## How To Navigate Custody Battles

## Try to Settle Out of Court

You should make every effort to settle a custody dispute outside of court. Believe it or not, a judge would rather see the custody dispute decided <u>outside</u> of court due to the long-term effects of a custody battle and court-ordered decision on the family. However, if both parents can put their feelings aside and work together, several options are available.

- Informal Negotiation it may be difficult for spouses to cooperate as their marriage ends, but an agreement made outside of court is the best way to settle. Successful co-parenting will create the best possible situation for both spouses and the child involved.
- Mediation appointing a third-party mediator to guide custody discussions is a good idea. Of course, they can't decide anything official, but the mediator can propose solutions.
- Arbitration another possible solution is similar to going to court but less expensive, and
  the result does not go on public record. A retired <u>judge</u>, or another neutral third party,
  reviews the case and makes an informed decision. The final decision is binding, which a
  judge can uphold in court.

## If the Custody Battle Goes to Court

One of the first realizations for each parent is that there usually isn't a clear <u>"winner"</u> in custody battles. You should only make decisions if they are in the child's best interest. If possible, joint custody that disrupts the child's life as little as possible is an ideal resolution.

Here are some tips to ensure that negotiations go smoothly:

- Prioritize The Child's Well-Being Again, any evidence or documentation presented helps make informed decisions about custody and visitation. It's not about beating the <u>ex</u> and is not the time to fight about the past or reveal damaging information about spouses. Custody battles are an emotional time for everyone involved, and the proceedings should remain as professional as possible.
- Hire A Professional Making sensible decisions from the start is the only way to guarantee the child's future. That is why hiring an experienced family attorney is the first order of business. The attorney can create custody agreements that favor both parents and work best for the child's safety.
- Dismiss Unrealistic Expectations An attorney can help dispel common
