

I have also seen strays in need of care that were euthanized simply because they did not have someone to pay for their care. I have treated puppies abused and abandoned by their owners and left to die. I could no longer bear to see animals not receive the care they need and that is why I founded Healing Haven in 2012.

Helping injured and sick animals not only saves the animals in need, it saves the people who love them. I have seen many situations where these pets provide emotional support to their owners who suffer from PTSD or other emotional challenges. There have also been many situations where these pets are the only companions people have in their lives, especially the elderly. Ending these valuable pet lives due to the owner's lack of finances is unacceptable. As a community we must ensure this this never happens.

In the last five years, Healing Haven has saved hundreds of animals all over the country that would have otherwise been euthanized due to cost of treatment. My wish is that together we can save thousands this year. Let us give every animal the chance it deserves, so no owner will ever lose their pet due to financial reasons.

Throughout my career I have been known for saving animals whose recoveries have been described as miraculous such as Joey the pitbull who was featured on all of the national news channels. The fact is, I just gave them the chance to fight for their lives. I didn't give up on them.

# The Incredible Hulk

IMAGINE... A FRAIL, HELPLESS PUPPY NOT ABLE TO BREATHE. THAT'S HOW IT WAS THE DAY HULK'S ORIGINAL OWNER BROUGHT HIM INTO AN EMERGENCY CLINIC. THE OWNER SAID TO THE RECEPTIONIST, "I DON'T WANT THIS PUPPY. HE IS TOO MUCH TROUBLE."

#### How could anyone abandon Hulk just because he couldn't breathe?

His frail chest heaved quickly in and out as he struggled to breathe. And with each attempt. he let out a small screech as his lungs struggled for air.

If the puppy didn't receive help right away he'd die. He was placed on oxygen to stabilize his breathing. When he became a bit more stable he was given an x-ray and the results were shocking: he had a diaphragmatic hernia. Simply put, his entire intestinal tract was sitting in his chest. No wonder he couldn't breathe!

Although he appeared to be close to death, Healing Haven believed that this adorable little puppy deserved a chance at life, and provided the surgery that could potentially save his life.

The good news? In spite of the odds, Hulk not only survived, he made a full recovery!

After several days of supportive care and pain management he was ready to go to a new home. One of the nurses at the hospital had fallen in love with him and knew he'd make the perfect companion for her young son. Her little boy named the puppy Hulk, after his favorite super-

At the age of 12, Saki the Shih Tzu, developed a life threatening medical condition called pyometra - an infection of the uterus that can occur in unspayed females. When Saki was brought to the veterinarian she was in critical condition. Her owners wanted to do everything to save her, however the high cost of treatment was more than they could afford. They were going to have to make the painful decision to put her to sleep. That's when Healing Haven stepped in. Saki's family paid as much as they could and Healing Haven paid the rest. Saki was immediately put on IV fluids, IV antibiotics and pain medications. Once she was as stable as possible, she went directly to surgery to have her infected uterus removed. Saki is now back at home playing with the children that love her. Saki's story is the perfect example of why Dr. Loudon founded Healing Haven. Saki had a serious illness that was treatable



and the decision to end her life too early did not have to he made. Saki is why Healing Haven is giving the gift of life to pets and the people who love them.

## Logan...the Determined

A woman walking in her neighborhood heard a faint cry. and knew an animal was in trouble. With the help of a friend she searched the area for an animal



in distress. Soon they found the source of the sound — a cat lying at the base of a tree. He was emaciated, nearly frozen and too weak to lift his head. They brought him to the emergency hospital where euthanasia was considered to relieve his suffering. However, it was decided that since he had fought so hard to live he deserved a fighting chance to heal. Healing Haven paid a large part of his medical bill and the woman who found him donated what she could. As a result, this little guy got a second chance at life. He was treated with aggressive fluid therapy, antibiotics and given proper nutrition. Within 24-hours he was alert, eating and hungry for affection. The woman who first heard his cry for help adopted the sweet kitty and Logan is proof that caring makes a difference.

A specialist was called in and she received the complicated care that she needed. Her vivacious spirit brings joy to their lives every day and she now knows the joy of being part of a loving family.

## Holiday Hazards!

#### **Holiday Food**

High-fat and rich and spicy foods can lead to pancreatitis.

Chocolate is toxic to both dogs and cats.

Xylitol, a sugar substitute, if ingested by pets could cause vomiting, hypoglycemia, seizures and liver failure.

#### **Holiday Plants**

Mistletoe and holly both can cause intestinal upset including vomiting and diarrhea, excessive salivation, and abdominal pain. Mistletoe can lead to seizures and death if a large amount is ingested.

Lilies can be severely toxic to cats, causing gastrointestinal issues and kidney failure.

Amaryllis is also severely toxic to both dogs and cats.

Liquid potpourri can be corrosive to the tongue and gums, cause difficulty breathing and liver damage.


#### **Holiday Ornaments**

Ornaments with sharp edges and glass can cause lacerations and perforations when pets try to chew them. If ingested, they can cause intestinal obstructions.

Electrical cords can pose a problem for curious puppies and kittens. They may lick or chew cords and outlets, that could result in electrical burns and lung damage.

Tinsel can be very hazardous for cats. They love to play with it but if ingested can cause intestinal obstruction.

It is shocking that anyone could turn their back on this loving 10-monthold poodle mix. He was brought to an emergency hospital, suffering from severe wounds along the entire length of his back. It was learned that he had spent the first 10 months of his life in someone's backyard, where he developed wounds on his back. They were so bad that he developed an intense maggot infestation. **His owners were unable to pay his medical bills and incapable of providing appropriate home care for Max.** Fortunately they decided to release Max to HHAF. In the caring hands of HHAF, Max received the care he needed for his severe wounds and dehydration. His coat was groomed, his wounds were treated daily for two weeks and his dehydration was corrected with IV fluids. And the best news — he has just been adopted!

The sweet four-year-old French bulldog was suffering from intervertebral disc disease and needed immediate surgery to relieve her intense pain and give her a chance to walk again. Her owners loved her so much and wanted to give her every possible chance at survival. Sadly, the family couldn't afford the estimated \$8,000 for her treatment. Their only option was humane euthanasia — until Healing Haven stepped in to help. Thanks to animal-loving people like you, Valerie was able to get the emergency surgery she needed. Today she is walking again and receives physical therapy to help her on her road to complete recovery.
