Jim Hoge, Noxious Weed Director Johnson County Public Works

Jim Hoge is the **noxious weed director** for the Johnson County Department of Public Works and Infrastructure. Hoge's main responsibilities: control, manage, and eradicate the County's noxious weeds.

What makes a weed "noxious" as opposed to just pesky?

A noxious weed is a plant that the Kansas Legislature has determined to have a negative impact on agriculture, public health, the environment or the economy. Weeds, including those declared noxious, impacted the U.S. economy by an estimated \$55 billion in 2012.

What do you like best about your job?

The people. Many customers or callers have become good friends. They call with questions about fruit and vegetable gardening, farm ponds, lawns, trees and shrubs etc. Everything but noxious weeds!

What is one thing you wish people knew about your job?

The Noxious Weed Department offers many free services and information. I distribute free weed guides, calendars and rain gauges. Some folks come in and ask "is this where I get the free rain gauge like my neighbor's?"

Teresa Smith **processes personal items** brought to the Adult Residential Center, a 398-bed community-based program for adult offenders. She also participates in random and requested searches of resident rooms and lockers.

People think we are the Driver's License Bureau and not the Department of Motor Vehicles responsible for vehicle tags and titling. These services are not available in the same office. The State handles driver's licenses and the County handles vehicle tags and titling as an agent of the State.

A resident fell unconscious and my customer and I performed CPR on her. I'm thankful she survived and that Johnson County had provided me with the appropriate training.
