Annie May rolling out red carpet for 'Mr Grey'

As preparations continue for the filming of the major movie, Wild Mountain Thyme, in the Ballina area in the coming weeks, local councillor Annie May Reape is keen to roll out the red carpet for its A-list lead man, Jamie Dornan. Ballina Municipal Dis-

trict councillors met on Wednesday last where Cllr Reape wondered whether the Fifty Shades of Grey star should be af-forded a civic reception. Cllr John O'Hara had raised the issue of the

movie, highlighting that it could see the Ballina area featured on cinema screens all over the world as the setting for the film adaptation of the Broadway stage play, *Outside* Mullingar by the Oscar and Tony Award-winner John Patrick Shanley.

Cllr O'Hara was reminiscent of the most tenacious Hollywood Re-porter hack, as he revealed in a hush-hush fashion that properties in the

Cloonkee and Cloonagh areas and on the Belmul-let side of Crossmolina were set to be used as lo-cations for the film, which also stars Emily Blunt, Jon Hamm and Christopher Walken. "It's called Wild Moun-

tain Thyme and it's about farmers arguing over land," Cllr O'Hara confided, remarking that the production will put the Ballina Municipal District on the map. He thanked Mayo Co Council for its role in realising

such a dream develop-ment for the area.

Men ended up in a legal stew after killing protected hares

Five men who hunted and killed three protected wild mountain hares in countryside in South Mayo have been directed to make a donation to an animal welfare charity.

Eric Ward, 46 Clareville, Claremorris; James Reilly, 94 Cois na hAb-hainn, Tuam; Martin Ward, 45 Gilmartin Road, Tuam; Patrick Sweeney, 35 Woodfield, Tuam and Eoin Ward, 143 Woodfield, Tuam, pleaded guilty at last week's sitting of Castlebar District Court to possessing a protected wild animal.

John Higgins, who is

employed as a ranger with the National Parks

and Wildlife Service, told the court that on January 18 last he stopped a Volkswagen Polo being driven by James Reilly at Kil-

quire Lower, Kilmaine.
The other four defendants were passengers in the vehicle.

Mr Higgins inspected the car and found three dead wild Irish mountain hares on the floor behind the passenger seat.

In reply to questions from Judge Deirdre Gear-ty, Mr Higgins said a licence is required to hunt these animals.

Open season for shooting the animals is between September and February but the accused were hunting the animals

with dogs.
Solicitor Cathy McDarby said the animals can be hunted with beagle or harrier dogs if hunters have the proper licence.

The five defendants had hunted for rabbits in the past and didn't know these hares were pro-

tected species.

The dead animals would have been used to make stews.

Judge Gearty directed the defendants pay €200 each to the Irish Society for the Prevention of Cruelty to Animals.

Cllr Annie May Reape formally proposed that the development proceed, noting that her colleague Cllr Michael Loftus would have done so were he not unavoidably ab-

It was agreed that the development would be a great boost for the community of Moygownagh and should be followed by the construction of further houses.

Man using cannabis was 'in a bad place'

A man found in possession of a small quantity of cannabis had been ordered to make a donation to charity.

Michal Stecki, 21 of 33 Lavey Manor, Charles-town pleaded guilty at Castlebar District Court to a charge of possession of illegal drugs.

Sgt Margaret O'Con-nor told the court that Gda Kieran Naughton received confidential information on November 7 last that a woman was in possession of drugs at a house at Hawthorn Vil-

lage, Saleen, Castlebar. Stecki was visiting the house and was found in possession of cannabis valued at €25.20.

The defendant has no

previous convictions.
Solicitor Tom Walsh said Stecki had been in a bad place at the time.

Having spent some time in his native Poland, he had returned to Ireland and is in his second year in college. Judge Deirdre Gearty

said she would strike out the charge if Stecki do-nates £250 to St Anne's Burns Unit at Our Lady's Children's Hospital,
