Overview: This memo is made to help clarify the changes that I've made. While editing your piece, I stuck tightly to the style guide as well as using the Chicago Manual of Style. If any work that I have done is up in the air, please refer to the Chicago Manual of Style for clarification. I made a few read throughs before diving into the editing, and I'm glad I had. After becoming comfortable with the piece, I noticed the humor and charm in it. In my edits I hoped to keep those aspects that you grasped. You may notice a few formatting changes to your work as well. I formatted it up to terms with the Chicago Manual of Style and to the Style Sheet. You also made my job very easy when it came to dialogue. You had the dialogue format down perfectly in "Crime Court."

Point of View: Something that showed up on the Style Sheet is the fact that there should be a consistent point of view. I noticed that in "Crime Court" there were often switches between a regular narrator and the host of a game show. Some of my edits reflect the fact that I tried to get this to only one point of view. I edited your story to keep the general narrator. The game show aspect is very unique, and I made sure it was kept and referred to in several sections such as when Charlie hears it on the TV.

Queries:

Q1: As you can find on the Style Sheet, titles should be italicized. "CRIME COURT" shows up in several places and I suggest changing it to "Crime Court" throughout the piece.

Q2: As stated in the "Point of View" section of this memo, the point of view was something I had in mind a lot while editing. Here, I deleted the intro to this sentence to keep a consistent point of view and take away the game show host narration.

Q3: This was also a problem of point of view. Everything that I have highlighted for Q3 I would suggest deleting, as it is not necessary. However, I do think that adding a few minor details in its place could not hurt.

Conclusion: I was impressed in the way that you made this idea work. I think that while writing and going over the edits you should just be mindful of the point of view mostly. Other corrections I made are simple grammar, formatting, or sentence mistakes. The descriptions and the characters work extremely well with each other, and the ending wraps it all up with a nice message. Again, just to make sure you don't miss this, there were a few formatting issues I corrected. I made sure to include your name, title, and page number in the top right of each page. Also, I formatted your first page up to standards with the Style Sheet.
