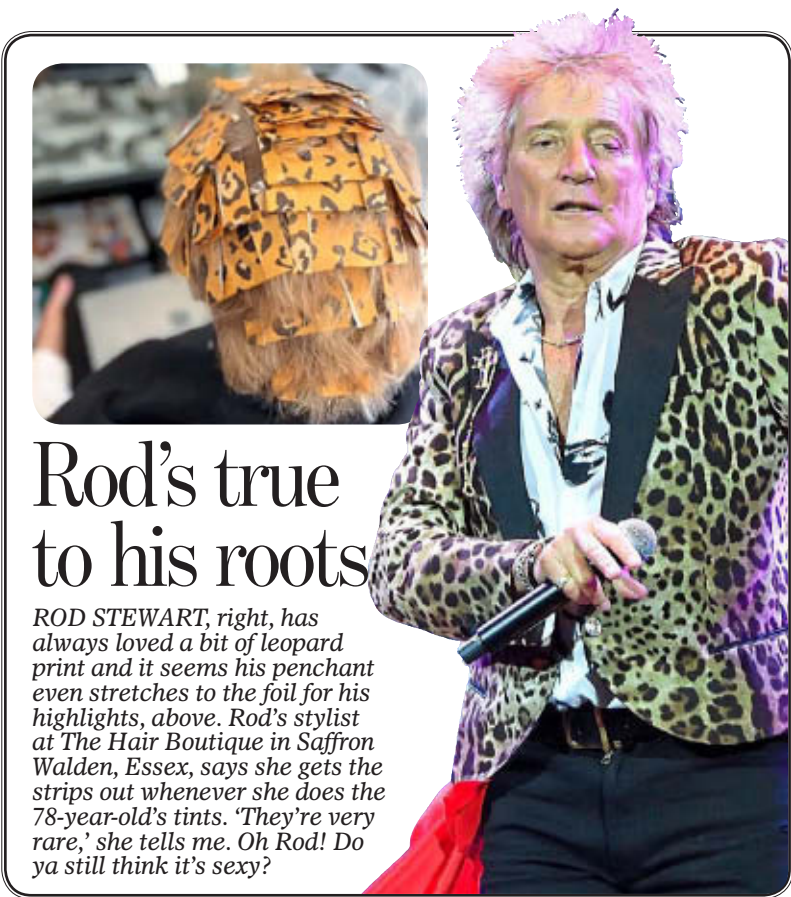
Take it as red: Monica is up for a cocktail
