





Lack of age verification draws in more teenagers who have not been smoking vape previously to test out vape products. Teenagers using e-cigarettes are twice as likely to say they intend to smoke regular cigarettes as compared to those who have never touched the product.

#### UNCERTIFIED MANUFACTURERS



**Eonsmoke** violated the Federal Food, Drug and Cosmetic Act (FD&C Act) by marketing new tobacco products without authorization, including e-liquids in flavors such as mango, cotton candy, sour gummy worm and others.

<u>SnowPlus</u> claimed it worked with a lab to produce high-grade vape products. Reverie Labs, the medical-tech company's website shows no single record that proves it has ever worked with SnowPlus or any vaping company.



#### DANGERS OF UNCERTIFIED VAPE PRODUCTS



Uncertified vape products are more likely to be sold online without age verification process.



Without an approval from FDA, the ingredients are unaccounted for and can be toxic for the body.



Uncertified vape products do not have FDA approval - which means it is **not up to FDA health standards**.

#### WHAT IS IRRESPONSIBLE MARKETING?



Irresponsible marketing includes advertisements, posters, and social media posts that show vaping as 'cool' and 'fun.' This kind of marketing attracts a curious group of consumers: underaged youth.

#### WHAT IS IRRESPONSIBLE MARKETING?

Under federal law, companies can produce any flavour they want, but they aren't allowed to promote varieties that could appeal to young people, defined as under 18, such as those that taste like candy, dessert or soft drinks.

However, a lot of companies still advertise this kind of flavors.






#### WHAT IS IRRESPONSIBLE MARKETING?

#### **COUNTERFEITS AND FAKES**




These counterfeit and fake vape products does not have **traceability** on them. Most are copycats of famous brands but made with **low-quality components and ingredients**.

With the rise of sales of vape products this past few years, counterfeit and fakes have also been showing up on stores.

The **nicotine level** of a vape pen helps with how an adult smokers respond to vaping.

Most companies contain 4-5% nicotine level which adult smokers think is too low.

>For any attempt to purchase any product within the **Bidi™ Stick** website, there is a **comprehensive and mandatory public search** done to **ensure and confirm the age qualification** of the customer before completing the transaction.

>In the instance that the verification system fails to verify the real age of the purchaser, the system asks the purchaser to present a government-issued identification card.

## **Additional Age Verification Toll Gates**



**Daily Order Limit. Bidi™ Vapor** has placed a limit on the purchase of **Bidi™ Stick** per day. This is to ensure that the sale of the Bidi™ Stick is for an adult smoker rather than for wholesale.

With this, a consumer can only purchase a maximum limit of 30 Bidi<sup>TM</sup> Sticks per month. This limit of 30 Bidi<sup>TM</sup> Sticks can be bought one-time or in a staggered manner within the month.



As an added preventive measure, **Bidi™ Vapor** also requires a **signature upon delivery** of **Bidi™ Stick**.

This tollgate confirms the buyer's identity, which ensures that the product does not fall to the hands of an underage person.

It also has a **child/tamper-proof packaging** with traceability attribute that ensures that adults who know how to open it are the only people who can use it, away from children.

### **Traceability & Innovative Design**



Bidi<sup>™</sup> Stick has an excellent traceability capability with its data systems to make sure that each Bidi<sup>™</sup> Stick requires top-quality components for a clean and consistent user experience.

#### Bidi™ Stick Process:

- Components go through a series of quality checks and controls.
- 2. After standards check, they are sent to the warehouse for assembly.
- Every product is quality-checked and logged into system database.

Through this system, we **eliminate the counterfeits** that claim to represent themselves as Bidi™ Stick.



The **Bidi™ Stick** offers a new generation of nicotine delivery systems offering a stronger nicotine concentration.

Bidi™ Stick only provides premium quality nicotine oil packed with 6% Class A Nicotine that is above its competitors with only 4-5% by weight per volume.

This higher nicotine content by volume enables adult smoke transitioners to have a more seamless transition with fewer toxins but a more familiar rich experience for them.



#### **Disinfection Process**

- 1. Before the production starts, the factory is thoroughly inspected by the Shenzhen Epidemic Prevention Department. They will check the company's disinfection of facilities and materials as well as all personnel's health. If the inspection qualifies the standards, operations can now commence. This is a precautionary and preventive measure to ensure site health and product safety.
- 2. All materials go through a UV (ultraviolet) light disinfection to sterilize all materials to be used.
- 3.All staff goes through daily body temperature checking and hand disinfection before they can enter the production premises to ensure that they are all sanitized whenever they need to touch the interior of the product.
- 4. Daily workshop on proper disinfection is in place.
- 5. The workshop is equipped with finger cots and masks to ensure product safety.


