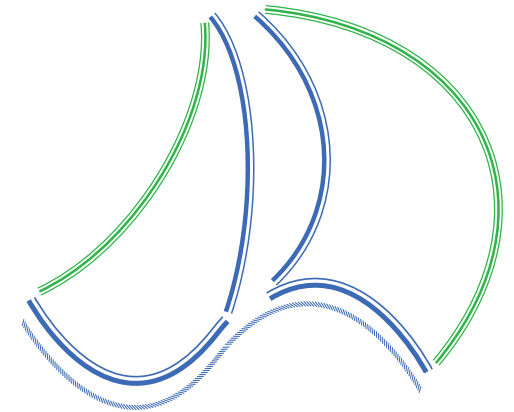
## ABOUT Us
