### Call to Order

President Tracy Hakobyan calls meeting to order. Notes that Recording Secretary Gonzalez is not present for her usual job of taking down minutes. President tells Corresponding Secretary Owen that, as bylaws(Article II:4) state, in the absence of the Recording Secretary, it is his duty to take down the minutes. # **Community Report**

His belly laugh after saying *Buenos tardas* belongs to an older man; when he tries to explain the latest video game he plays, he has the countenance of a doctor walking you through your MRI results. Hector's father manages the building, when he's not drinking himself to sleep in the parking lot. He looks half as tall as Hector but that can't be right. He sweats always. Through his hair and even his handlebar mustache, and his skin looks like its been dry-baked in the sun since he was a toddler. Once, through slurred speech, he told of how he traveled with other immigrants from Honduras through the Mojave Desert, and only after eight years of begging, farming, and construction work did he save up enough to send for his wife and two children.

Corresponding Secretary decides to keep these observations to himself. Over Mr. Fenton's continued talking, President welcomes City Council report.

# Office of City Council Assemblyman Josh Klingham

President recognizes and welcomes Assemblyman Klingham. Assemblyman Klingham thanks the Council for its continued support; also compliments President Hakobyan on her dancing skills at the recent LA City Gala. President smiles and laughs.
