

## Supreme Court Reformation

Another thought and this time about the Supreme Court of the United States of America. It became clear that something has evolved that is terribly wrong in the evolution of our Supreme Court and that is its overt duality of its politicization. This development while no one's fault because the prevention of this wasn't built into its formation, is nonetheless leading to an erosion of its purpose, which is the balancing of Federal Power.

Because our political system promotes and secures the Two Party System, one being Democrat and the other Republican; the Democrats representing the interests of The People and the Republican representing the interests of The Wealthy. Today we don't speak of the two political parties, rather we describe judges as being Liberal or Conservative. However, it's a thin veil as the Liberal judges are all appointed by the Democrat President and the Conservative judges are all appointed by Republican Presidents. The outcome of this narrow interpretation of democracy, the two party system, results in the following. Whichever party is in power, should an opening on the Supreme Court take place, controls the selection and this results in a person from that political viewpoint being appointed. Should one party remain in control for too many years then the politicization of the Supreme Court leans heavily in that direction, thus undermining the very concept of the Balance of Power and the Fair Interpretation of the Constitution and the Bill of Rights.

To correct this weakness the following is suggested: Of the nine justices and their nine seats, three seats be dedicated to the Republican Party, three seats to the Democratic Party and three seats be dedicated to people who have proven the ability to be equal minded and be from neither the conservative nor the liberal frame of mind, but that of balance and harmony; from the middle. Of the three from the middle, one is then chosen to be the mediator or the Chief Justice. The inclusion of this suggestion would preserve the intent of the Founding Fathers in their Wisdom to create a political system that safe guards the Balance of Power so that The Fair Minded Values of Democracy would always be at the forefront of decision-making.

I would like to share my personal view as follows. To more fully understand the Values of Democracy I came to investigate life in Europe and the intense abuse of Power at the time of the Founding Fathers. This helped me to form an opinion as to their intent.

Who were the Founding Fathers and what were their beliefs that led to their "insurrection" or "Revolution" to overthrow the unjust English Crown? Most of them were Masons. While the Catholic Church in Europe at the time called Masons agents of the Devil, the Masons were the freedom fighters who were committed to overthrow the injustice of Royal and Religious Rule that prevented the free expression of a democratic life. When democracy won out, the first priority of the Founding Fathers when creating the Constitution was to build in to it the separation of Church and State. They did this so that at no time in the future could anyone or group of wealthy people through the influence of religion take control of the government using the Church as its pawn, as did the Kings of England, France, and other European countries. Today, the erosion of the separation of Church and State being championed by the Supreme Court's Conservative Majority Justices is violating the intent of the Founding Fathers of our great nation. Basically the Conservative influence is that of Christian Fundamentalism using the

Republican Party as its pathway to power. The Conservative goal is to have the United States be ruled by the strict interpretation of the Christian Bible much like the Taliban and Isis intend by imposing the Koran and Sharia Law upon the rule of the people in Muslim dominated countries throughout the world. This will ultimately undermine the preservation of Democracy. In the United States the Christian Fundamentalists through The Republican Party and it's billionaire supporters are taking control of local, state and Federal offices with the intent on eliminating anyone even in their own party from political office unless they support this intent. Thus the moderate Republicans are being removed from office and the one's that are being elected have no intention on working cooperatively with any President that opposes their intent.

Given this interpretation of events the proposal for changing the structure of the Supreme Court to one of Balance is so critical.
