The active agent complex consists of the biopolymers, hydrolized sclerotium gum and sodium polyglutamate, as well as a natural moisturizing factor (NMF*) from urea and potassium lactate. Hydrolized sclerotium gum is a low molecular weight scleroglucan that helps to protect the skin from environmental damage and leaves skin feeling smooth and healthy. Sodium polyglutamate coats the skin with moisture binding properties that keep it smooth and supple. Potassium lactate is responsible for the preservation of the stratum corneum's physical properties. The amino acid betaine - trimethylglycine is osmotically active and has excellent moisture retention capacity.
