We source our hemp from dedicated farmers in Oregon, extract a full spectrum of beneficial hemp-derived compounds, create wellness-promoting formulations, and test at multiple stages of production to make sure our CBD products contain the things we want in our bodies, and none of the things we don't. The Origins of Cannabinoids Matter

We know the hemp plant's growing environment plays a crucial role in the expression of cannabinoids, so we only source our hemp from a trusted network of sophisticated farmers in Oregon where the climate yields a richer cannabinoid profile from the plant.

Because the state of Oregon has relatively dry microclimates with months of little to no rain, the hemp plants don't need to be as resistant to mold, which increases their cannabinoid and terpene content. Additionally, Oregon hemp is tested for a wider variety of pesticides and contaminants because Oregon farmers are subject to higher testing standards than most hemp producers in the US and across the globe.

What results from this unique growing environment is a plant rich in CBD, as well as a richer composition of other helpful cannabinoids and terpenoids.

Hemp Extract is More Than Just CBD

Most hemp extract is formulated with only CBD in mind, removing solvents quickly with intense heat, which risks the degradation and loss of other beneficial molecules in the process. But the beauty of hemp lies in its full spectrum of cannabinoids and terpenoids, each with unique properties that work together to promote wellness. That's why we developed our methodologies and cutting-edge extraction technology to preserve a wide range of natural botanical compounds.

Our extraction procedures are carefully designed to minimize decarboxylation. During the evaporation process where we remove residual solvents, we maintain a heating temperature of no more than 60°C, as opposed to the industry standard of 120 - 160°C. It's one of several deliberate measures we take with the intention of preserving every helpful cannabinoid.

With an array of beneficial plant compounds at our disposal, we have more opportunities than ever to promote wellness.





Scientifically Formulated for Optimal Absorption

Our mission is to promote wellness, so it's important to us that our products are easy for the body to absorb.

To preserve lipids and other molecules in the hemp plant, we refine our Full Spectrum Extracts with supercritical CO₂. It's one of the many ways we've utilized our combined years of experience in plant science, engineering, and supplement production to bring out the best possible values of all ingredients during our manufacturing process.





We put our CBD products through scrupulous testing at multiple stages of production.

Ensuring Quality and Protecting Against Impurities with a COA

In addition to the quality safeguards we put in place during production, we make sure every finished product receives a Certificate of Analysis from an accredited lab to let you know the product is free of commonly harmful impurities, and that its cannabinoid content matches product specifications.

Know Exactly What You’re Paying For

A study conducted in 2017 found that almost 70% of online CBD products are mislabeled, either having substantially more or less CBD than advertised. If a product’s chemical makeup doesn’t match what’s on the label, the consumer’s best interest may be compromised.

What is the endocannabinoid system (ECS)?

The endocannabinoid system (ECS) is a biochemical communication network that plays a crucial role in regulating our physiology, mood, everyday experiences, and overall health. The ECS is present almost everywhere in the body, facilitating regulatory responses across the central nervous system, digestive system, many vital organs, and other bodily functions.

Humans and animals make their own cannabinoid called Anandamide, which binds to cannabinoid receptors like a key fitting a lock, helping the body to achieve homeostasis, or internal regulatory balance. CBD and other cannabinoids can act as mimicking keys and bind to these same receptors.

Why choose Full or Broad Spectrum CBD products over CBD Isolate?

When you take a CBD Isolate, you're only getting the benefits of a single cannabinoid. Taking a Full or Broad Spectrum Hemp Extract, like the ones in MyRemedeMD Tablets and Tinctures, allows you to take advantage of the hemp plant's natural cannabinoid profile.

How should one use CBD?

Everyone's body absorbs, metabolizes, and responds to CBD differently. Finding the optimal amount is typically best achieved by starting with smaller amounts and working your way up over two or three weeks.

CBD is a biphasic compound, which means it may elicit different reactions at different concentration levels. To help one conveniently find the most effective amount, MyRemedeMD offers a variety of serving sizes across our product line, ranging from 10 mg Tablets to 1500 mg Tinctures.

Will CBD get one high?

CBD is non-intoxicating, promoting wellness without producing the high associated with THC, the other prominent cannabinoid of the cannabis plant.

Is CBD addictive?

CBD is generally considered non-habit forming. The World Health Organization has reported that "CBD exhibits no effects indicative of any abuse or dependent potential" in humans.

Will CBD make me sleepy?

CBD won't necessarily make you sleepy, but it may make you feel calm, helping you to fall asleep.

Are there other side effects?

More research is needed to draw clear conclusions about CBD's potential side effects. CBD may interact with or alter the effects of medications. If you have a condition or are prescribed medication, consult with a doctor before adding CBD to your regimen. If you are pregnant or nursing, you should not use our products.
