# A LETTER FROM CRAIG

## *Florida has Stolen the Rights of Victims of Negligence with Newly Passed Law*

Unfortunately, during the recent legislative session, the Florida Legislature destroyed decades of laws that shielded Florida citizens from profit-driven insurance companies.

In May, 2023, in a sweeping new law written by insurance company lobbyists, the folks in Tallahassee stripped the rights of victims of negligence. The new law ensured billions in profits for insurance companies, without mandating any reduction of insurance premiums for customers.

How did this happen? It is because our Florida legislature has been the subject of constant pressure from Big Insurance to bail them out and help ensure their continued profitability.

Here is how it affects you:

**1. You could be barred from filing a case if you wait too long.**

Under the new law, you must file a lawsuit within two years of the occurrence that injured you. For decades, the limitation has been four years. It was cut in half. Unfortunately, this will clog the court system, as cases take time to develop and more cases will enter the courts earlier than they should.

**2. You will be barred from recovering any money if you are found more than 50 percent at fault for your accident.**

Let's say you turn left in front of a person in your car while driving. You get hit by another driver and you become paralyzed and will need care for the rest of your life. However, the person who hit you was going 100 miles per hour. If they weren't speeding, perhaps they could have avoided you or stopped. You both may be partially at fault. However, if the insurance company convinces a jury you are more than 50 percent at fault, you get **NONE** of your medical bills paid off, and **NOTHING** for your lifetime of pain and suffering. This threshold used to be different; if you were 75% at fault, you could get 25% of your damages. No longer. Insurance companies win; you lose.

Doctorate of Jurisprudence - 1995**3. Your attorney's fees may no longer be paid by the insurance company when they wrongfully deny a claim.**

For 130 years, there has been a safeguard in Florida against insurance companies wrongfully denying a claim. The safeguard was that they had to pay your attorney's fees, once they lost (which they usually did). However, this law has now been repealed.

For example, if you have a claim from a Hurricane for \$100,000 in roof damage, and the insurance company wrongfully denies your claim and then gives up shortly before trial, \$40,000 of the \$100,000 goes to your lawyer, and you only get \$60,000 (even though it will cost \$100,000 to fix your roof). Before the new law, you would get the entire \$100,000 and the insurance company would pay your attorney. No longer. Insurance companies win again.

This new law has many other parts to it- all of it is bad for the citizens of Florida. The insurance companies, once again, fooled the public, and the legislature, that insurance companies are the victim of a culture of "frivolous lawsuits".

Next time you see an endless stream of commercials for Progressive, Geico, Liberty Mutual, and other insurance companies, ask yourself where their advertising budgets

come from, and why such budgets are so big. The answer? Your skyrocketing premiums, and no accountability.

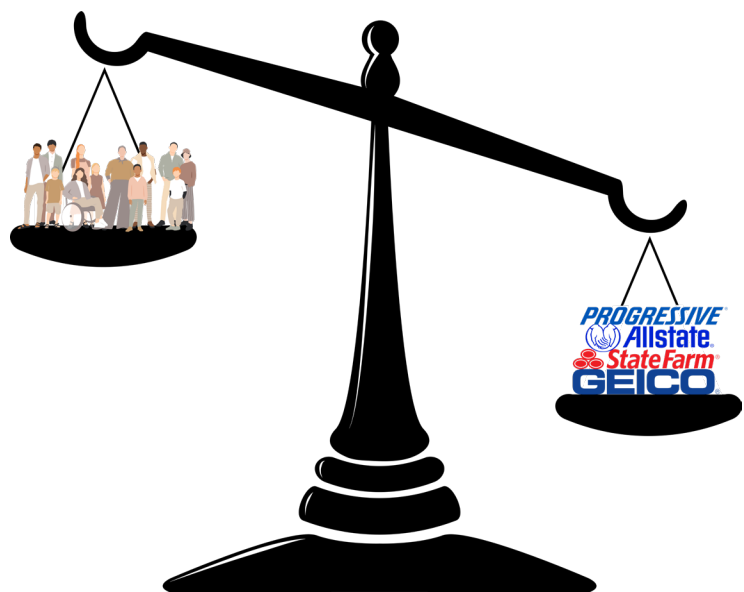
Sadly, Big Insurance wins again, and you lose.

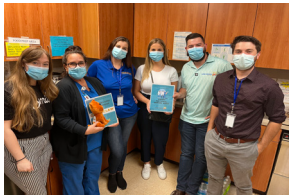

## PRACTICE AREA SPOTLIGHT: SLIP, TRIPS, & FALLS

Premises liability holds property owners or occupiers responsible for injuries or damages caused by hazardous conditions on their properties. In Florida, premises liability laws aim to safeguard individuals visiting or residing on others' properties.

Property owners and occupiers must maintain their property in a reasonably safe condition and take necessary precautions to prevent harm to visitors. The duty of care varies based on the visitor's status: invitee, licensee, or trespasser.

- **Invitees:** Property owners owe the highest duty of care to invitees, who visit for business purposes or as members of the public. Regular inspections, hazard repairs, warnings, and reasonable care to prevent accidents are required.
- **Licensees:** Licensees, such as social guests, enter the property with the owner's permission for their own purposes. Owners must warn them about non-obvious dangers known to them.
- **Trespassers:** While property owners owe a lower duty of care to trespassers, intentionally causing harm or setting up dangerous traps is still prohibited.

To establish a premises liability claim in Florida, the injured party must prove the following elements:

- **Duty:** The property owner or occupier owed a duty of care to the injured party.
- **Breach:** The owner or occupier failed to fulfill their duty by neglecting property maintenance or addressing hazardous conditions.
- **Causation:** The breach of duty directly caused claimant's injuries or damages.
- **Damages:** The claimant suffered actual harm, including physical injuries, medical expenses, pain and suffering, or property damage.

Property owners and occupiers have a responsibility to maintain safe premises, warn visitors of potential dangers, and prevent accidents when possible. ## INTERVIEW WITH PAUL SHALHOUB, ESQ.

### *Why GOLDLAW?*

Because of the structure Craig has built here. I wanted to be with a firm that was committed to giving back to the community and could match my level of commitment to community service. Craig and GOLDLAW embodied that, and he and the firm has supported every endeavor I have taken on. Coming to GOLDLAW also gave me the opportunity to reconnect with my first mentor, Spencer Kuvin. I interned with his firm in 2008, and my experience there verified my desire to practice personal injury law.

### *Talk about your role as a member of the GOLDLAW litigation team...*

As a litigator, it is our job to present cases in court in front of juries. One of the first things a litigator must do is develop a "theme" for the case. The theme is the framework or storyline that is created so that we can easily explain the facts surrounding the case to a jury. It is crucial that the theme makes it easy for the jury to understand the facts and evidence that is presented so that they reach the conclusion we want them to reach.

### *Why did you decide to practice personal injury law?*

From day one upon entering law school, there was one thing I wanted to do: practice personal injury law and do jury trials. I wanted to represent plaintiffs who were injured, and work to get them justice. Tort law is exciting to practice, because it allows us to advocate for clients in and out of the courtroom. We make society safer by holding wrongdoers accountable. That is what truly inspired me to practice law.

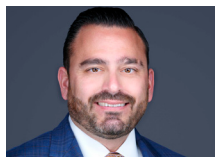
### *Talk about how litigators can get juries to side with them?*

If you can get jurors to engage with you on a substantive level, you can tell who will be leaders and followers. Lawyers do this by putting things in terms that all jurors, regardless of their interest or educational level can understand. One of the first things young attorneys learn is to eliminate complex terms and phraseology. I was taught to simply present the "meat and potatoes," because facts are what determine the case. This also helps cut down on time. We want to keep the jurors interested and engaged, so we focus on making what we present relatable. The last thing we want is for jurors to lose interest. When that happens, cases are lost."

# TRUCKING ACCIDENTS AND YOU: WHAT YOU NEED TO KNOW

In the United States, large trucks - including semi-trucks, 18-wheelers, and commercial vehicles - are involved in a staggering number of accidents each year. Data from the National Highway Traffic Safety Administration (NHTSA) shows that there were 5,601 large trucks involved in fatal crashes in 2021, a 12% increase from 2020.

Florida ranks third among states for most truck accidents, trailing only California and Texas. In 2020 alone, accidents in Florida involving large commercial trucks caused 29 fatalities and more than 500 severe injuries.

## Why Hire GOLDLAW for Your Trucking Accident Claim?

"GOLDLAW has been helping victims of trucking claims for two decades with significant success," said GOLDLAW Founder and CEO Craig Goldenfarb. In 2014, the firm negotiated a **\$6.5M settlement** for the family of a tow truck driver who was killed after being struck by a passing tractor-trailer while helping a motorist who had broken down on I-95. "It was a heart-wrenching, emotional case," said Goldenfarb. "It took a lot of time and resources, but ultimately our expert team was able show that the truck driver was at fault, resulting in a significant recovery for the family."

Truck accident claims are more complicated than those involving standard passenger vehicles due to these key differences:

### 1) Severity of the crash and Resulting Injuries

Because of the truck's size, injuries to victims are generally severe, and in many cases lead to incapacitating conditions or death. According to the National Safety Council, in 2021, 5,700

large trucks were involved in fatal crashes, an 18% increase from 2020 and 49% increase over ten years. These crashes resulted in 5,788 deaths in 2021.

### 2) Complexity of the Case

In large truck crashes, it's important to realize that multiple parties could be held liable for the accident. "It's been GOLDLAW's experience that many entities can be held legally responsible for an accident involving a commercial truck," said Goldenfarb. "This may include the driver's employer, the mechanics and techs who maintained the vehicle, manufacturers of the truck and its parts, and multiple insurance companies. That's why victims need a law firm experienced in cases like these to represent them."

### 3) Causation/Evidence

"So many factors come into play with truck accidents that are not normally part of the car accident settlement/litigation process," said Goldenfarb. "In addition to multiple insurance considerations, we have to investigate state and federal transport laws, information stored on the truck's data recorder, driver's log reports, and cargo manifests. It's a time consuming, and detail-oriented process, but we must be thorough to get the best result for clients."







### Common Causes of Truck Accidents

Florida experiences a high volume of trucks traveling through the state daily. Accidents happen for any number of reasons, but there are a few common factors including:

- **Distracted Driving** - Because they spend most of their lives on the road, truckers often eat, drink, and perform other tasks while driving to stay on schedule. Accidents caused by these factors are a big problem, even though most of them are illegal under federal regulations.
- **Driving Under the Influence** - According to the NHTSA, around 3% of truck drivers involved in fatal accidents in 2020 were intoxicated.
- **Speeding/Reckless Driving** - 21% of truck drivers involved in a fatal crash have had at least one previous conviction for speeding, according to the NHTSA. Other dangerous behavior, including tailgating and illegally changing lanes is common for drivers trying to meet deadlines.

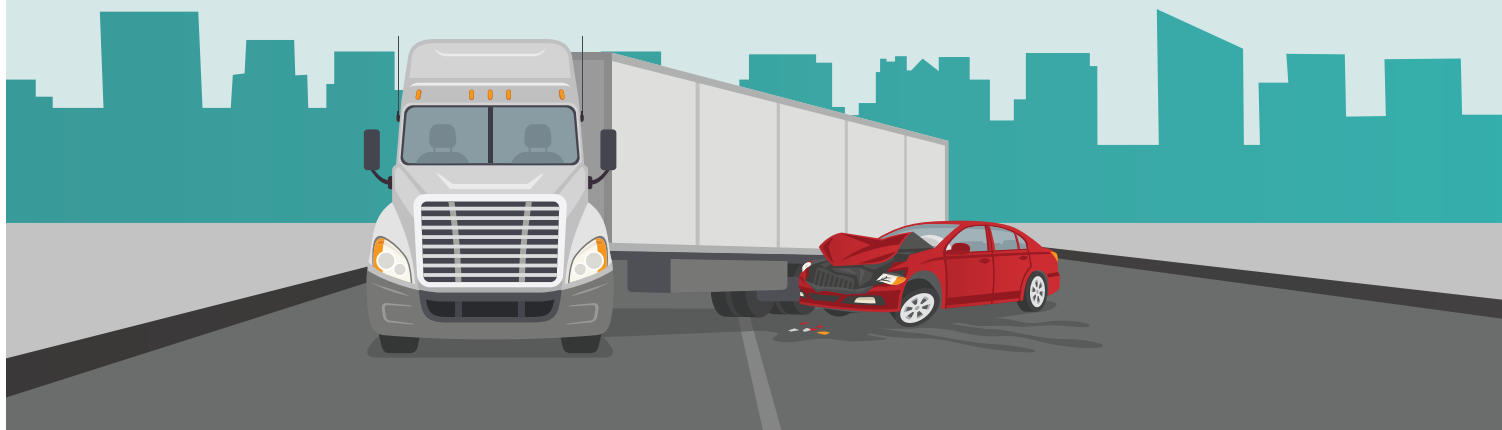
- **Driver Fatigue** - Long hours behind the wheel make drivers tired, slowing their reflexes and response time. Although federal laws were enacted to ensure truck drivers take regular rest breaks, many ignore them.

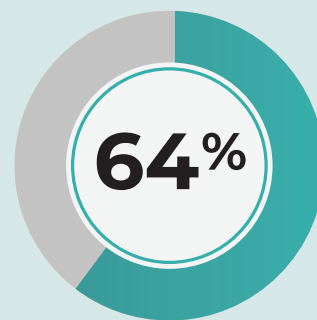

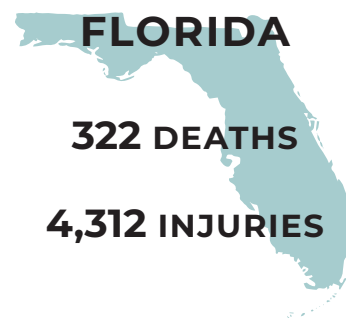
