

## Susan Monica (fed victims to pigs)

This is Susan Monica. She was convicted of murdering two men at her residence in rural Wimer, Oregon between 2012 and September 2013. In one of the most bizarre cases you'll ever encounter, it's not just the brutal way she committed the act, but the method she used to get rid of the victim's remains that is incredibly gruesome.

On January 10, 2014, the authorities came to Monica's house because they found out that she was using someone else's food stamps card illegally. They accused her of committing fraud. The authorities would soon realize that this was much more than an identity theft crisis.

While investigating Monica's barn in rural Wimer, Oregon, they found evidence of human remains, to be more specific, the skeletal remains of a human leg outside the barn's pig pen. This horrifying discovery was just the beginning as it urged the investigator to search the whole property.

The owner of the farm, Susan Monica, was born Steven Buchanan, and served in the United States Navy during the Vietnam War. After being honorably discharged, Monica began living as a woman, going under the name Susan Monica. She would go on to pursue a career in engineering and in 1991, bought a 20-acre farm located in rural Wimer, Oregon. The very same farm where these gruesome finds were discovered.

Investigators found the remains of two people. The first person to be identified was Robert Haney, a 56-year-old man who worked for Monica and disappeared in September 2013. It was reported that Robert Haney was

estranged from his family. Monica hired Haney after putting up an ad on Craigslist, to which he responded. Haney, a divorced individual, was attracted to the secluded location. Haney, who was on welfare, utilized food stamps or an electronic benefits transfer card, or EBT card, to make purchases.

According to Haney's son, Jesse, his father, and Monica had a professional agreement. Monica would give him cash for doing household chores, carpentry, and handyman work. He would also be allowed to live on the premises. This arrangement worked well for Haney, who liked to live without modern technology and pay cash. He didn't own a phone or any electronic devices either.

However, as it transpired, Haney's family was not as distant from him as initially believed. Jesse and his siblings, decided to visit the farm on January 1st, 2014 to check on his well-being when they hadn't heard from him for a long time. Monica informed them that their father had left four months earlier and asked them to clean out his trailer. The property was in utter shambles according to everyone who visited the place.

The discovery of Haney's jacket and tools during the cleaning triggered suspicions and led them to contact the authorities and file a missing person's report. Monica spoke with the police, but kept to her lie. She said Haney left the property to seek revenge against a family member who had been assaulted. His children confirmed that the assault did happen, but they had not seen their father. She said Haney began binge-drinking and acting erratically.

After the police initially left, they maintained their doubts about Monica's honesty. Another team of investigators took a different route to the case. Their suspicions intensified when they learned that Haney's welfare debit card was still being utilized at a nearby Walmart. Surveillance footage revealed that Monica was the one using the card.

This prompted the police to return to the farm to conduct a fraud investigation. However, what they stumbled upon was a horrific crime scene, which is where we return to the investigations that took place on January 10, 2014.

One investigator encountered a severely injured leg in a pond. The subsequent investigation revealed that the limb in question was not derived from an animal, but rather from a human. Monica was brought in for questioning. Monica revealed that Haney had disappeared from the farm during the summer of 2013.

Before revealing that they found human parts around the property, Monica was questioned by the authorities where she knew what had happened to Haney, to which she continuously replied that she didn't know.

She eventually asserted that Haney was disemboweled and in the process of being consumed by pigs.

Having mercy, she shot him, and then, once the pigs had their fill, she put his remaining body parts in trash bags which she stored in the barn. However, Monica expressed uncertainty whether Haney was already deceased when she fired the shot.

As expected, some of Haney's remains were discovered in plastic bags inside Monica's barn. She further explained that wild animals must have gotten into the sacks and dragged his leg into the pond.

Monica said that she was afraid of the authorities euthanizing her pigs, so she didn't tell the entire truth about what had happened. The police later confirmed that some of Haney's remains were still contained in garbage bags in the barn.

Upon making this discovery, a thorough investigation of the crime scene ensued, leading to the complete closure of the entire farm. Within the course of their search, the investigators uncovered another body, eventually identified as Stephen Delecino, a former employee of Monica's who had gone missing in 2012.

Monica's property was found to be in an appalling state, with an abundance of garbage, animal bones, and a lack of functioning water and sewage systems.

Monica verified that it was Delecino's body, but said his death resulted from self-defense. She claims she caught him stealing two of her rifles and the confrontation turned deadly.

The investigators dedicated three weeks to meticulously scouring Monica's 20-acre farm, meticulously digging over 50 holes in their pursuit of additional evidence or potential victims. However, no further remains were uncovered throughout their extensive search.

Monica provided varying explanations for the deaths of both men when questioned by detectives. She claimed that Delecino had committed suicide by shooting himself in the head in 2012, while she also claimed that she had done so for protection and that her pigs had eaten parts of his body.

Monica openly confessed to having little regard for human life and expressed her belief that the world would be better off without people during the course of her video-recorded interrogation, later used in the trial.

*Monica stated: "I do not value human life very much. The only thing wrong with this planet is there's people on it. If it weren't for us, all the other animals, dodo birds and whatever else, would still be here".*

Former Jackson County Sheriff's Detective Eric Henderson reported that Monica fed Delecino's remains to her pigs in 2012 and then buried what was left. When pressed if there were more victims, Henderson says he got a chilling response from Monica, *"She told me that if she told me about the 17 others that she would spend the rest of her life in jail."*

Monica initially pleaded not guilty to two counts of murder, abuse of a corpse, and identity theft. Even though Monica had a lawyer, she chose to question Eric Henderson, the lead investigator in the case. During the trial, an Oregon State Police anthropologist testified that Haney's legs had been broken up with an axe and that his thigh-bones looked like they had been chewed by an animal.

The anthropologist said it was unclear whether Haney had been dead before the dismemberment of his legs. Furthermore, the anthropologist stated that Delecino had suffered three to four gunshot wounds to the head. Another witness who had been in jail with Monica said that she had gotten a birthday card from her that said, "From the sweetest murderer in Jackson County."

After six days of testimony and just one hour of discussion, Monica was found guilty of all charges on April 21, 2015. She is currently serving a 50-year prison sentence within the Oregon Department of Corrections at the Coffee Creek Correctional Facility.

Monica reportedly told cellmate Jordan Ferris about what really happened to Haney. Ferris revealed, *“Susan told me that Robert and her got into an argument because he was drunk, and he was trying to come on to her. She shot him and then pushed him into the pigpen.”*

If you're wondering what happened to Monica's pigs, they were euthanized because there were reports that she had been feeding them dead pets and livestock.
