Security guard killed while tryingto thwart robbery bid

BENGALURU: A 22-year-old security guard was stabbed to death and two others were injured in their attempt to thwart a possible robbery by three armed men in Suryanagar on the city outskirts on Wednesday night.

Tarun, a native of Assam was working as a security guard at a residential apartment in Suryanagara near Anekal.

Police said locals, who noticed the three lying injured, rushed them to a nearby hospital. But doctors declared Tarun brought dead. The condition of one of the two men injured in the attack, is said to be critical.

According to preliminary investigation, the armed men, who had come on bikes were confronted by Tarun, who was later joined by the other two men, the employees of a private company. Police suspect that the guard and the two others were trying to thwart a possible robbery attempt. **DH News Service**

History-sheeter Nagaraj, sons held after month-long hunt

Fugitives were constantly on the move, stayed in temples, schools

BENGALURU/CHENNAL History-sheeter V Nagaraj and his two sons who had been eluding the police for nearly a month, were arrested by a special team of the city police from a village near Arcot in Vellore district in Tamil Nadu on

Nagaraj and his two sons — Gandhi and Shastri — were on the run since April 14, when Rs 14.82 crore in demonetised notes was seized from their house after raids on his house and office in Srirampuram.

How they were arrested

Nagaraj (56) and his sons were arrested near the Angala Parameshwari temple at Harini village near Arcot in Vellore after a brief chase on Thursday afternoon. Assistant Commissioner of Police

(ACP) Ravi Kumar, who led the team that was on the hunt for Nagaraj, called up Nagaraj's advocate and sought his client's surrender. The advocate contacted Nagaraj, who said he was not willing to surrender. The police tracked the mobile tower location to a village near Arcot and rushed to the spot. They saw a man fitting Nagaraj's description standing near a van and talking over his phone. As soon as he saw the police, he got into the van

which started moving. The police then had to chase the van for around one-and-a-half kilometres before they intercepted it. One of Nagaraj's sons was driving the van, the police said.

When the police rounded them up, Nagaraj created a ruckus and screamed saying he was being kidnapped since the police were in plainclothes. There was confusion and a few passersby intimated the Tamil Nadu police who rushed to the spot. A senior police official from Bengaluru had to call up him by one of his relatives. the Vellore district superintendent of police to intimate their counterparts that it was a police operation. Later, the three were taken for medical examination, the police added.

However, Tamil Nadu police sources from the headquarters in Chennai said that they were arrested with help from the Tamil Nadu police.

Nagaraj and his sons, in order to evade the police, did not stay in hotels or friends' houses. They were always on the move most of the time in a Maruti van which the two sons took turns to drive, the police said. They stayed at schools, temple premises and farmhouses where their identities were not sought, police sources said.

Nagaraj made it tough for the police by not using his mobile phone constantly. He kept changing the SIM cards and handsets that were supplied to Sometimes, he used to call from remote locations to mislead the police. Nagaraj also managed to send two CDs to the media through his advocate where he accused Chief Minister Siddaramaiah and a few senior police officers of 'fixing' him by foisting false cases against him. He also said the money belonged to a man named Maniunath who claimed to be Siddaramaiah's PA and at his behest, the

The police had earlier arrested five of his associates to collect clues about his whereabouts and movements. Nagaraj and his sons were brought to Bengaluru on Thursday night and are being interrogated an the abduction and extortion case. Meanwhile, Nagaraj's two wives are said to have gone absconding after his arrest.

Bashing CM in 2nd video proved to be rowdy Nagaraj's undoing

BENGALURU: Former corporator and historysheeter V Nagaraj dug his own grave by naming politicians in his second video, according to officers who picked him up in Tamil Nadu on Thursday.

The government set a three-day deadline for police to catch him after he released the second video on May 9. He had adversely remarked about Chief Minister Siddaramaiah while heavily praising Home Minister G Parameshwara. A Congress MLA from Bengaluru, against whom Nagaraj held a grudge, intervened in the matter. The legconvinced the

Congress state leadership that Nagaraj's remarks could spell trouble for the government and the party. It was then that the government ordered the police to get cracking.

The same day, two police teams were formed to catch Nagaraj. In the night, investigators interrogated eight of the 11 associates of Nagaraj who were picked up following the April 14 raid on his house. The men told police that it was Nagaraj's wont to run away whenever a criminal case was registered against him. He would spend the time praying at temples of female deities as he believes that would solve his problems. He would appear in public only after his lawyers helped him get bail.

Trio who paid Rs 32 lakh in fake notes to buy 1 kg gold arrested

BENGALURU: Three men, who allegedly duped a citybased jeweller by paying him Rs 32 lakh in photocopied banknotes, were arrested by police on Wednes-

The suspects had given photocopies of 2,000-rupee notes to buy one kg of gold on the busy KG Road in the heart of Bengaluru on April 24.

Police gave their names as Vinod Tilakchand (45), Hemanth Gowda (33) and Harish Kumar (31)—all from Mysuru.

Fake identity

One of the suspects had assumed a fake identity of 'Jugraj', a businessman from Chikkamagaluru. He called the jeweller, Dinesh Kumar, on his mobile phone on the pretext of placing an order for one kilo-

gram of jewellery "for his daughter's wedding".

Feigning preoccupation with the wedding preparations, he told Dinesh that his manager would hand over the cash to get the jewellery, police said.

Photocopies of notes Accordingly, another suspect

met Dinesh near Shikshakara Sadana on KG Road and handed over a bag containing photocopies of Rs 2,000 notes and took the delivery of gold jew ellerv. He managed to divert Di-

nesh's attention by engaging him in conversation and rode off before the jeweller could count the cash, police said.

When Dinesh returned to his shop and began counting the notes, he had the biggest shock of his life: they were all

proached the jurisdictional Halasuru Gate police station and filed a complaint.

Police tracked down the suspects based on the call detail record (CDR) and arrested them in Mysuru. They have seized the gold along with a large amount of photocopied notes, a photocopier, two cars and other accessories.

The masterminds

Tilakchand and Gowda are believed to have masterminded the plot to con the jeweller while Harish supplied them fake notes.

Harish also used to print cheques, bonds and fake notes and had cases against him in Mvsuru, Chamarajanagar and Bengaluru, police added.

Rao was shocked to see the police as he did not know the victim had informed them. He pleaded innocence, but the police took him away for interrogation.

al powers to impose penalty on institutions for not taking measures to ensure child safety, for not paying teachers on time, employing faculty with-

out necessary qualifications and not maintaining a schedule of employees. Ajay Seth, additional chief secretary, Department of Pri-

mary and Secondary Education, acknowledged that DERA has limitations and in certain districts, meetings may not be happening regularly. "There are some missing elements. The basic rules say that DERA shall devise its own procedure to conduct enquiries. We need to lay down rules on what these procedures are," he said. In the coming months, Seth said that they would lay out DERA's functioning in detail and make it more effective. "We will have a relook at the constitution of the authority as well and it will be open for review. We want to provide a credible forum for matters to be heard," he said They will consider creating a public domain where details of cases can be accessed.
