## **Amora Bain Carson**

Generally, children are a symbol of innocence, a symbol of purity. It then is ironic when you think a child is possessed based on what you feel or think. This child was barely even 13 months into the toxicity, the struggles, the judgement of this world before the world judged her before her own parents judged her based on a "game". She could barely form her own words before her parents formed their opinion about her.

They say we do not choose who our parents are; I am sure if Amora Blain Carson had that choice she might have chosen better parents, heck maybe she even chooses not to be a part of this gruesome world into where she was born.

Amora Blain Carson was the daughter of teenage mother Jessica Carson, who met her partner and soon-to-be Fiancé in high school. They soon got engaged and along with Jessica's baby, Amora moved into Milam's apartment, located in Longview, Texas. It was reported that Milam loved Amora, or did he not????

In the spring of 2008, Milam and Carson bought an Ouija board, with Carson intending to communicate with her dead father, who committed suicide when she was ten. She discovered his body after he died, and she had questions for her late father. This went on for about two hours wherein she allegedly got answers. Eventually, Carson felt Milam was possessed along with the entire house. This led them to move out of the apartment into Milam's mother's apartment in Tatum, Texas, a small town located in Rusk County. A fairly small town with a population of 1385 people as of the 2010 census.

It seemed like they left their earlier apartment in a rush because the landlord stated that the apartment was trashed; there was food in the fridge and amphetamines along with a knife in the tank of the toilet.

Carson who was once a lively, people-person was noticed to start withdrawing from friends and family, and even stopped caring about how she looked and appeared; all of which caused a worry or two. It was around this time that Milam's father died, he and his father were purportedly close. Milam had been homeschooled from the fourth grade on, primarily by his father.

Milam was described as passive, having control issues, and a very short anger span. To prove this accusation, a friend described an event that happened where Milam got into a quarrel with Carson. It eventually got to the point where he pointed the gun at himself while threatening suicide, the situation got to the point where he shot a hole in the floor of the car while Carson was in it trying to talk him out of shooting himself.

Milam had a history as a sexual predator, he would even be convicted and spend about 48 days in jail of a 180-day sentence, due to error by officials. He became a registered sex offender in Longview, but due to how short his stay in Longview had been officers did not expect him to leave so soon and they did not conduct regular checks on him.

The young couple continued to believe that the young child in their care, Amora was possessed and needed an exorcism to get rid of the demon(s). you would think an exorcism should be done by a preacher or a priest if at all one was needed.

The day was December 2nd, 2008, Carson and Milam were pumped on amphetamines and this led them to use a hammer to "try and beat the demon(s) out" of 13-months old Amora. Cruel you might think, it only gets worse when they leave her seemingly lifeless body in the apartment to what appeared to be a pawn shop, where it was reported that they tried to exchange some tools for some money. Money that some people assumed to be used for getting the services of a Priest to perform the exorcism or to get cash to run away.

They later went up to a gas station, where they bought some cigarettes, all the while Amora was left to die back in the apartment. According to a recording, later that morning at about 10:37 am, Milam called 911 to report the death of "his child".

The response arrived quickly and Officers were with them. Milam and Carson told them that they went for a walk to seek out another property. Milam gave his report of the incident, welcomed the officers to search their home, and even gave them a list of possible suspects.

Undoubtedly, they searched the home, after getting a warrant, and found in it, baby clothes, blood splatter, beddings stained with blood, baby clothes, Astroglide lubricants, a pair of jeans stained around the lap, and a few other things. All of these items tested positive for the DNA of Amora Bain Carson. While processing the couple's vehicle the investigators noticed the absence of a baby seat, which they later found face down in their driveway.

The couple, Milam Blaine and Jessica Carson were indicted on capital murder charges and they pleaded not guilty. During the trial, the medical examiner who conducted the post-mortem examination of Amora's body reported the cause of death as homicidal violence due to blunt force trauma and possible strangulation. It was also reported that her injuries included facial abrasions and bruises that looked like one big injury, 24 human bite marks, scrapes, and abrasion from head to toe, bleeding underneath the scalp was also discovered, there was extensive fracturing to the back of the skull and so many more injuries that the medical examiner described it as the worst he had ever seen inflicted on a child.

The Jury convicted Jessica Carson, the mother of Amora Bain Carson of <u>capital murder</u>, and was sentenced to life without parole. Milam Blaine on the other hand who was seen as most responsible for the death and injuries and violation of parole of his previous sexual offense and a few other reasons was sentenced to death by <u>lethal injection</u>. Since the conviction, Milam has had his execution stayed twice.
