Title: SNAP BENEFITS ACCESSIBILITY IN 2024

Background Info:

Four major changes to SNAP benefits are coming in 2024 for all Americans. The maximum benefit threshold is increasing, eligibility and age requirements are expanding, exemptions are being implemented for work requirements, and the income eligibility thresholds are rising. Several non-profits groups are protesting the USDA's interview requirements, to make it more accessible for college students to be eligible for snap. DC Mayor Muriel has recently agreed to increase the funding for SNAP in 2024 despite initially being hesitant and amidst legal pressures to do so, for a temporary period of 9 months. DC Residents are supposed to receive the increased funds starting on February 23.

Why is this story relevant:

This story is relevant because more than 42 million Americans receive SNAP Benefits. Also, about people in the District use SNAP Benefits, or food stamps. __ College students are on food stamps or in need of them.

Topic: DC Women's Healthcare Accessibility

Title: DC Bridging the Health Inequity Gap OR New DC Law Improves Women's Access to Preventative Healthcare

Background Info:

Abortion accessibility and legality is the center of an ongoing debate nationwide. While abortion is legally protected in DC, DC women receiving medicaid cannot receive medicaid-covered abortions due to a ban. However, a newly-passed law in DC is making it easier for women to obtain hormonal birth control prescriptions without needing to receive a doctor's approval. Pharmacists who are properly licensed may now prescribe and offer hormonal birth control to women seeking it.

Why is this story relevant: Close to what would've been the 51st anniversary of the now-overturned Roe v. Wade verdict, this new law increases preventative healthcare accessibility for women, specifically low-income and disabled DC citizens. Many college students are a part of low-income homes and
