Riverside County, CA – Over a year after COVID-19 broke out in the United States, the popular California music festival event, known worldwide as Coachella, has been canceled for the second year in a row.

Coachella Lives On, Dubbed As "Couchella" As Fans Anticipate Virtual Music Festival Viewable From Home

The world-renowned popular music festival, Coachella, has been canceled for the second year in a row following the one-year anniversary of COVID-19 being in the United States. In light of the situation, fans anticipate the announcement of the music festival's virtual replacement, "Couchella."

Following the outbreak of COVID-19 in the United States in the earlier months of 2020, many of the activities previously participated in person were moved onto virtual platforms such as Zoom and Microsoft Teams. A year later, virtual activities and meetings have become the norm and many organizations have turned to holding previously in person events in live-virtual formats on various livestream platforms.

Coachella fans anticipate that, following the cancellation of Coachella 2021 for the second year in a row, several of the scheduled performances will be streamed online where fans can enjoy the concerts from the comfort of their homes. In past years, Coachella has been streamed live on online platforms such as YouTube.
