

TOPIC: Battery Energy Storage Systems



Mamoon Alyah is the managing director of CEERISK Consulting, offering clients in the insurance and legal markets around the world services to investigate complex engineering incidents and provide expert opinions in engineering disputes. He is a chartered electrical engineer and holds an International Certificate in Enterprise Risk Management. With over 35 years of experience, he investigated numerous complex claims involving electrical power systems (generation, transmission, and distribution), including turbine failures (gas and steam), wind energy (onshore and offshore), solar (PV and CSP) in addition to geothermal, hydro, and other power systems. He also investigated failures of energy storage systems (ESS), including batteries, transformers, substations, switchgear assemblies, and cables (overhead, underground and subsea) in addition to other power equipment.

Mamoon has been qualified as an expert witness in different jurisdictions (USA, UK, EU, Middle East, and Asia), preparing expert reports and giving evidence in legal proceedings in many jurisdictions in matters involving electrical energy networks, power equipment and apparatus, construction disputes, and defect claims (design, manufacturing, and workmanship). He has authored several articles published in leading industry magazines, in addition to being a frequent lecturer on a variety of topics to different organisations and groups such as the CILA, OEC London and Dubai, and the International Association of Engineering Insurers (IMIA), among many others. He hosts a monthly webinar for insurance industry professionals on topics covering energy and engineering claims.

TOPIC: CPHA – when are the terms applicable and have they changed at all?



David VIcek specialises in insurance litigation and construction, and infrastructure law. His experience in insurance litigation includes public liability claims, professional indemnity claims and construction industry-related claims (third party property damage/ loss of support/collapses/deaths on site and Department of Labour Inquiries/PAR/CAR/fire/contractual claims). 
