A HISTORICAL COMMITMENT TO DIVERSITY AND INCLUSION



Maude Riseden Hughett in 1909 was the first woman to earn a law degree at UT and the first woman to earn a law degree in the South. Women nationwide would not be granted the right to vote until a decade later.



Marilyn Virginia Yarbrough was UT Law's first female dean and the first person of color to lead the college. She was one of the first female law deans and was the first black woman to serve as dean of a Southern law school.



Lincoln Anderson Blakeney was UT Law's first black law student, following a successful 1951 suit to open graduate admission at UT to persons of color—just a few years before the *Brown v. Board of Education* ruling ended racial segregation in public schools nationwide.
