OUR STORY

Founded in 2007, ABC works with young authors ages 6 to 18 in Central Texas, primarily TravisCounty. We provide programs in creative writing, journalism, college essay writing, resume writing, expressive journaling, and more. We strive to make our programs safe and accessible for all students, and prioritize partnerships with Title 1 schools and communities that have limited access to creative arts programming. With Austin's rising housing costs and shifting demographics, we continue to adapt. In the past two years, ABC expanded its geographic reach to increase program equity and accessibility, activated youth civic engagement through op-ed programs, integrated therapeutic journaling into our programs, and provided monthly workshops for system-involved youth.

OUR MISSION

ABC engages local writers and artists who serve as mentors and role models to our students. Our students are encouraged to use their voices confidently, explore expression and identity through writing, and gain skills that will promote academic and personal success. To support students whose voices often go unheard, ABC partners with local organizations that work with vulnerable youth, such as LGBTQIA+ teens (Out Youth), first-generation college-bound students (Breakthrough), young people in foster care (CASA of Central Texas), systeminvolved youth (Gardner Betts Juvenile Center), and more. Further, through our Mobile Program, we create opportunities beyond Austin city limits to serve the growing number of low-income families displaced by rising housing costs.



EQUITY & INCLUSION

ABC has provided anti-racism training for all staff and board members. We've also provided these for instructors and are actively looking for further, cost-effective ways to provide these trainings to all instructors and volunteers.

Equity and inclusion is at the heart of our work. By working with Title 1 schools and other nonprofits that work with young people, we hope to erode some of the oppressive structures that have limited equity for so long in this country. We believe the work we do is anti-racist and liberatory because it values the voice of those often unheard.

EQUAL OPPORTUNITY

ABC is an equal opportunity employer. We always look for ways to increase the diversity of our staff, board, and instructor pool.

MEDIA, PRESS, AND PUBLICATION RELEASEFORMS

ABC asks students and families to sign release forms in order to appear in any public facing posts, whether that's social media, grant applications, etc. We also ask for permission to share student writing in our anthology. We believe it's important for students to give their informed consent with regards to how we're using their likeness and their work.

Related to this, we've never asked students to appear in front of donors or at fundraisers. We share student work with donors of course, but we've never asked students to attend galas, fundraisers, etc.

STUDENT CONTACT & ON-CAMPUS PRACTICES

ABC has a handbook that guides instructor behavior with students.

We also abide by the policies and procedures with all of our campus partners.

DISABILITY AND ADOLESCENT (5-10 YRS) INSTRUCTION

Our programs are open to students regardless of ability. Most of our activities have non-written options for students with limited English proficiency or writing skills.



HOW WE COLLECT FEEDBACK

Our adult students are always sent survey forms that ask them the bright and low spots of their program.

Our students are surveyed at the beginning and end of the semesters. This information is used to help us gauge where the students are with their writing skills and confidence. We also use these to gauge the effectiveness of our programs and to learn what interests our students.

HOW WE USE FEEDBACK

The surveys and other feedback are reviewed by the staff. We frequently reflect on our program processes in order to find ways to be more efficient and effective for the students.

We share our collected feedback internally.

OUR CHALLENGES IN COLLECTING FEEDBACK


Young students often have trouble articulating areas of concern. This means that often are instructors and program staff have to look at other signs: not paying as much attention, not completing work, general student restlessness. These are opportunities to look at what's the root cause of these effects.


