# Assembly will champion White Ribbon campaign

Congleton's efforts to encourage men to speak out about misogyny and challenge the attitudes and behaviours that lead to violence against women is to be highlighted at a top meeting of local councils.

Town Coun Mark Edwardson announced he will "fly the flag" announced for Congleton when he addresses the National Association of Local Councils' national assembly in London on Wednesday, 29th November.

White Ribbon is the national campaign asking men to speak out against male violence against women and Congleton Town Council was one of the first to be accredited with White Ribbon status. Its ambassadors ask people to make the promise never to commit, excuse or remain silent about genderbased violence.

Playing a leading role in Congleton's efforts is deputy mayor town Coun Wesley, who worked with the association to become White Ribbon accredited.

Her town hall colleague Coun Edwardson will head to the capital later this month where he will speak at the association's national assembly after which he has been invited to be a guest at its awards ceremony at the House of

He will address the assembly to inspire other councils and regional leaders to become White Ribbon accredited.

Coun Edwardson told the "Chronicle" the event was not going to be a "mere talking shop nor an opportunity to rest on collective laurels," as he planned to "urge" more members to join the campaign to stop male violence against women and girls.

He said: "This is a real thrill for me. I've only been a town councillor for just six months so it's a privilege to have been invited to speak at such an important event.

"I just hope I can live up to expectations by being a great ambassador for Congleton Town Council and its support for the White Ribbon campaign."

He emphasised that one of the "most important" reasons for his trip to Parliament was the experiences of his female relatives, some of whom had reported being victims of sexual harassment.

Coun Edwardson added: "Domestic violence is endemic; even here in Congleton. Sexual and domestic violence takes a massive toll on women and girls, and it is not acceptable; I

want it to stop.
"That's why I'm of a dozen White Ribbon ambassadors in Congleton. It's our job to persuade other men to stop and think before raising a hand. The consequences for both parties can be catastrophic.

"The campaign's slogan is 'Change the Story,' that's all we want to do."

Coun Edwardson's London trip was announced during recent meeting of the wn council's Community town council's Committee, which received an update from Coun Richard Walton about plans for this year's White Ribbon campaign which begins on Saturday, 25th November, for two weeks.

He said: "We will be flying

the flag on the town hall, lampposts will have ribbons and there is a massive Press and social media campaign.

Ambassadors will have street stalls at Congleton's Christmas lights switch-on celebration on Saturday, 24th November and at this month's makers' market. Congleton High School

has booked a talk with White Ribbon ambassadors, which Coun Walton said "always proves really rewarding."

The town council is also working with Cheshire Police which has pledged to focus on domestic violence in the county.

Coun Walton said the White Ribbon group had stalls in the town centre in June, at Congleton Pride in July and at Astbury Mere in September. Some 65 new White Ribbon "promises" were made which he said was "excellent".

When Coun Edwardson told town councillors that he was looking forward to his trip to London, Coun Wesley told him to "have fun" and "bring us a

# School shutdown on first day back

Students at Sandbach School were "evacuated" on their first

morning back after half term. Work on the school's electrical supply had been carried out during the holiday but there was a power outage first thing.

Students had arrived for lessons — and were on their

way home soon after.

"You couldn't write it could you?" headteacher Sarah Burns told the "Chronicle".

Earlier this year the high school secured funding from the Government's Condition Improvement Fund and a programme of works to

However, David Osborne, finances resources at the school, said: "Unfortunately, during Monday morning, a malfunctioning new mains incoming breaker caused a whole site power outage, which could not be resolved

until later in the day."

Mrs Burns said she was 'grateful" to drivers of school buses who arrived back at school at 10am to escort children home safely.

"The pupils were so well behaved; we just had a very calm evacuation process whereby they got hold of their calm evacuation parents and got permission to leave.

"And we kept anybody that couldn't leave with us until we were able to make that connection. Obviously, it was something that nobody wanted to happen, but the students were good about it." The main block of Sandbach school is a grade 11 listed building, and Mrs Burns described the school as an "old site with a lot of ancient equipment" which is

gradually being replaced

She added the school has had to close several times during her time as headteacher because the site is "quite unusual" due to its age.

We had all the new pipes laid, then they were being connected up over half term, but we are a very complicated site with a lot of different blocks of different ages, which makes it much more complex than other schools."

New electrical parts were ordered on the Monday afternoon and the school was open as normal the next day.

# Convicted in her absence

Mary-Faye Roberts, (33), of 4, Astbury Lane Ends, Congleton, has been fined £72 for speeding on Park Lane.
