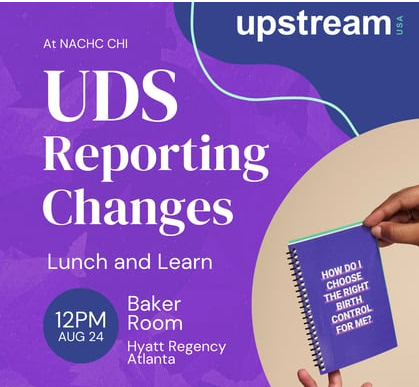

In April, the Health Resources & Services Administration (HRSA), [released new guidance about changes to the 2024 Uniform Data System \(UDS\) report](#). As a result, *all Federally Qualified Health Centers (FQHCs)* will now be required to report how many of their patients were screened for pregnancy intentions. FQHCs are critical access points for contraceptive care and screening is one element of best-in-class care.
