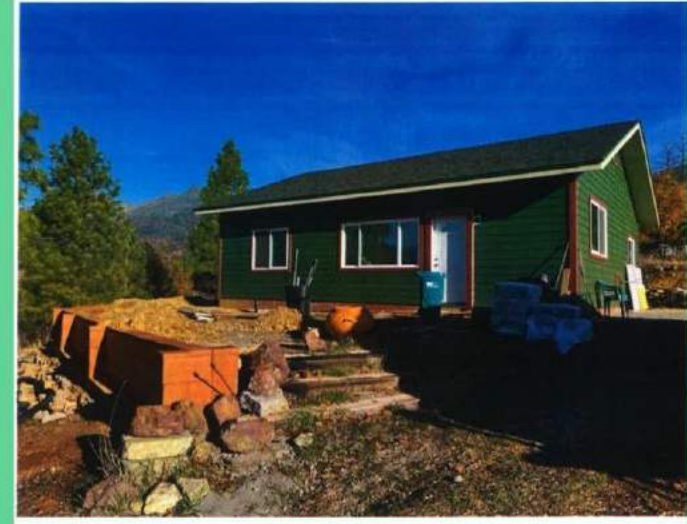
# Major wins
