Public Relations Situation: Creation of a video news release for RiverGuard to advocate for strong laws and enforcement to reduce pollution in lakes, rivers, and streams.

Analysis of Key Publics: 1. Northeastern US citizens (get the most acid rain); wants/interests/needs

*Informing the public about the devastation of acid rain/snow


Action Statement: Informing the public about acid rain and acid snow, their damage and affects, while encouraging citizens to become active in calling for change from their government and officials.
