## **Irma battered butterflies**

#### Not many seen in summer count; hurricane likely washed away eggs

Five women walked along the wooden boardwalk, spotting everything from baby alligators to owls to purple pickerel weeds.

"I don't know why they call it a weed, because I think it's pretty, but I didn't get to name it," said Joan Dunn, a boardwalk naturalist.

A pig frog could be heard grunting in the background. But the five women weren't just out for a nature walk — they were there to count butterflies.

The women were one of five groups of about 20 volunteers who gathered at Audubon's Corkscrew Swamp Sanctuary on Thursday as part of the 20th annual North American Butterfly

### Scott backer helped firm get SunPass contract

Vendor faces complaints in Florida, other states

The company behind Florida's troubled SunPass toll system won the lucrative, seven-year contract with the help of one of Gov. Rick Scott's top supporters despite allegations of favoritism and the company's histo-

ry of problems, records show.

The state's Department of Transportation announced last week that it is withholding payments to that company, Conduent State & Loon Schuttere in resources



ny, Conduct State & Local Solutions, in response to a backlog of about 90 million elec-

to a backlog of about 90 million electronic toll charges.

On Wednesday, the department said the backlog of transactions had increased to 170 million. Late fees and penalties are on hold until the system is fully operational.

The New Jersey-based company has experienced problems in a number of states, including Texas, where some customers were sent bills and exorbitant late fees in error, an ongoing USA Today Network investigation found. They include some mistaken — but

They include some mistaken — but nightmarishly high — late fees to drivers, and other problems Florida knew about before signing a seven-year contract in 2015.

The company won its contested bid for that contract with the help of Brian Ballard, a close Scott supporter and one of the nation's top lobbyists. Ballard is now helping the governor raise money for his GOP campaign to unseat
