Media officer of the team, Babatunde Ayoola said in a statement that the team is bouncing back and is being encouraged by its teeming supporters.


He said, "It has been a revival since we moved back to Lagos and we have enjoyed every bit of it. The way the fans are cheering the team is encouraging.



# Egbin, Ijede residents lament irregular power supply

esidents of Egbin, Ipakan and Ijede areas of Ikorodu, Lagos State, have lamented the irregular power supply by the authorities of Egbin Thermal Power Plant in spite of being the host communities.

Leaders of the communities made the appeal at a town hall meeting organised by the host communities of the power plant in Ijede, Ikorodu..

They made the appeal against the backdrop of an alleged plan by the authorities of Egbin Power Station to move an abandoned 1X100 MVA transformer project meant for the area to another transmission station.

The Community Development Chairman (CDC). Alhaji Shakiru Ajala, stated that the communities have faced a lot of challenges since Egbin Thermal station was sited i n the community.Ajala urged the government as a matter of urgency to resolve the situation before it gets out of hand.

"The host communities have been in darkness while the Egbin Power Plc Estate enjoys 24 hours uninterrupted power supply," he said.

Ajala said that top among the

demands was that the abandoned 100MVA transformer should not be moved to another transmission station for use but rather to be energised and put to use for the host community.

The regent of Ijede, Chief environmental hazards

Kayode Musediku, said that non-availability of power supply had crippled the economy and commercial activities of the communities.Musediku also said that people were moving out from the community en masse as a result of the

caused by industrial waste from Egbin thermal station.

"As you can see, people of liede are known to be fish farmers but because of the chemicals and hot water flowing into the lagoon, we no longer engage in our usual trade.

"Since this power plant was sited in Ijede, we have not benefited anything from the company. Most times, we pay a huge sum for the epileptic power supply in spite of being the host communities."

We are appealing to the government to, as a matter of urgency, intervene because we are peace loving and lawabiding citizens," the regent said.

# Tanker crushes Okada rider to death in Itamaga

tanker driver escaped being lynched by a mob in Ikorodu area of Lagos State after a commercial motorcyclist was crushed to death by the tanker. The incident occurred at the Itamaga area inward Ijede at about 9.30am when the tanker laden with fuel and the Okada journeyed inward Ijede.

Eyewitnesses' account said the incident was caused by the potholes on Itamaga/Ijede road as both vehicles were trying to avoid the potholes shortly before the tragedy occurred.

The deceased - Jemilu Sulaiman and a male

passenger were said to be riding side by side the tanker when it meandered and the rider was crushed to death by the rear tire, Fortunately, the male passenger escaped unhurt and was full of appreciation to God Almighty. The incident led to outrage in the area as coriders and sympathizers rushed to the scene to apprehend the tanker driver just as street urchins hijacked the situation by attempting to lynch the tanker driver and set the tanker ablaze.

When Vanguard visited the scene, people were running for their dear lives shouting on top of their voices and protesting that the tanker should not be set ablaze because of the context in which the incident took place.

However, information got to Policemen from Area N and Igbogbo Division who rushed to the scene to control the area.

#### In addition, some chieftains

of the Okada rider's association rushed to the scene to remedy the situation and calmed down the mob. The matter was reported at the Igbogbo Division just as

the deceased family said they were not interested in a court case and arrangement concluded to prepare the deceased for burial. Vehicular and commercial activities were paused for a

Abayomi said of the 53

victims brought to the hospital, one was brought in dead, while two others died in the hospital due to the severity of injuries they sustained.

# Businessman arraigned over N3.38m fraud

businessman Mr. Isaac Ayidessa has **L** been arrainged before an Ijede Magistrate Court for allegedly defrauding a business partner of the sum of three million and three hundred and seventy five thousand naira (N3,375,000) on the premise that he would help him buy motorcycles.

Ayidessa was said to have obtained the money in instalments between April 2018 and February 2019, from his partner, Mr. Bilewu Gbolahan after which he allegedly ran away without delivering the motorcycles. After he was caught, Avidessa was arraigned before the Ijede Magistrates' Court on three counts of

obtaining money under false pretenses, stealing and displaying conduct likely to cause a breach of peace. He, however, pleaded not guilty to the charges.

The prosecutor, Inspector Aminu Isaac, said Ayidessa obtained

N3.375,000 from Gbolahan to buy motorcycles, adding that the offences contravened Section 278 and was punishable under Section 285 of the Criminal Law of Lagos State, 2011.

Isaac Ayidessa, between the month of April 2018 and February 2019 at Oke-Eletu, Ijede in the Ikorodu Magisterial District, did obtain the sum of N3,375,000 from one Bilewu Gbolahan on the pretext of buying motorcycles for him, thereby

committing an offence contrary to and punishable under Section 312 (1a) of the Criminal Law of Lagos State, 2011.

"That you, Isaac Ayidessa, on the same date, time and place at the aforesaid magisterial

district, did steal the sum of N3.375.000 belonging to one Bilewu Gbolahan, thereby committing an offence contrary to Section 278 and punishable under Section 285 of the Criminal Law of Lagos State, 2011."

The presiding magistrate, Mrs. Oshodi-Makanju, granted the accused bail in the sum of N500,000 with two sureties each for the said sum.

She added that the sureties must reside within the jurisdiction of the court and show evidence of tax payment to the Lagos State Government. The magistrate - Mrs. Oshodi-Makanju later adjourned the case.



After the five charges were read to them, the accused pleaded not guilty to the offence. Magistrate A. O Ogbe adjourned the matter to a later date and the accused were granted bail.

The elated beneficiaries were particularly impressed by



h r e e persons w e r e as truck crashes **BRT** bus confirmed dead and 69 others injured in an accident involving a

Dangote Cement Plc's truck and a Bus Rapid Transit (BRT) vehicle on the 27<sup>th</sup> of August at the Ogolonto area of Ikorodu, Lagos State.

It was learnt that the truck. which was laden with 45 tonnes of cement, suffered brake failure around 10.30am and skidded into the BRT lane, and crushed the bus with number plate LSR 228 XS.

It was gathered that the truck was heading for Ikorodu, while the fully loaded BRT was heading for the Lagos Island, when the accident occurred. The BRT driver, Samuel Akpochi, and a bus trainee died in the hospital, a female passenger died on the spot.

*The* injured passengers were taken to the Ikorodu General Hospital and the Lagos State University Teaching Hospital, Ikeja.

An eyewitness, who identified himself simply as Wale, said one of the passengers died at the Ikorodu General Hospital, adding that other injured passengers were taken to different hospitals.

He stated, "These truck owners want to maximize their returns. They don't care what happens to an overloaded truck. From what the officials said, the truck conveyed 45 tonnes of money cement, way above its rather than rescuing them. capacity.



The state Police Public Relations Officer, DSP Bala Elkana, who confirmed the death of three persons, noted that 32 injured passengers had been taken to hospital.

"Three people died in the accident. We have moved 32 people, who were injured, to hospital for treatment," Elkana stated.

The Public Relations Officer, Primero, Cletus Okordolor, who confirmed the accident, noted that it was a sad day for the company.

He said, "Two of our busmen died in the accident, the driver and a trainee, who was on the shadow run. The bus conveyed about 70 passengers. It has been a sad day for us.

"We have successfully moved all the victims to the General Hospital in Ikorodu and those whose cases are critical have been moved to LASUTH. The bus driver and the trainee died in the hospital while receiving treatment, while a female passenger died on the spot of the accident.

"The bus was coming from Ikorodu and heading for the Island, while the Dangote truck was coming from Mile 12 and heading for Ikorodu. The driver of the truck slept off and veered off the service lane and came into the BRT corridor and crashed into our bus.

# 'Kaoli Olusanya didn't work against Ikorodu interest'- Osinowo

he media team of Hon. 

# **FEATURE** Struggle for BRT in Ikorodu

he Lagos state BUS RAPID TRANSIT SYSTEM which is also known as (BRT), came into existence on March 17, 2008, even though it was supposed to be opened in November 2007. The BRT is a bus-based public transport system designed to improve the capacity and reliability relative to a conventional bus system.

In examining the history of BRT we understand that the population in Lagos is on the increase but still not everyone in Lagos makes use of the BRT, yet there are always endless queues early morning to early afternoon, during weekdays. While this cannot be attributed solely to the control of the system, there is need to put proper operational measures in place to reduce the stress of the people.

Residents of Ikorodu are forced to queue every day either due to delay of buses caused by the traffic or buses undergoing downtimes. Ikorodu has a large population, and as a result of the traffic, there are usually more people than normal waiting to board the BRT which is seen as faster. At times, the queues are

uncontrollable as people struggle and rush to board available buses; people often get injured in the process. The afternoons are usually calmer as the traffic then switches to the return leg into Ikorodu.

From observations early in the morning, there were indications that people often stand for hours on end due to lack of buses to convey people. From conversations with the citizens of Ikorodu, the issue calls for more creative strategies to address which does not appear to be going away anytime soon.

An anonymous BRT user stated that "The population in Ikorodu is too large that even the BRT have problem in accommodating the citizen of Ikorodu, even with the commercial buses around, you will still find a lot of people struggling to get a bus.

The reporter interviewed some regular BRT users and Richard, who works in Lekki explained that at first it wasn't easy for him at all because of the late arrival of buses and having to wait on



rush and push just to get into the bus. He also mentioned that the buses are not conducive enough due to the number of people they carry which is more than what it is supposed to be. However, everyone is forced to manage just to get to their destination on time. He also said this has made some of them to be early risers as he gets up by 4am just to prepare and be at the BRT bus terminal on time. Other commuters also pleaded with the government, that more buses should be provided since the ones that are available are insufficient to convey the citizens of Ikorodu. They suggested that government should employ a bus coordinator who can help control the long queue. And provide a proper time of buses to arrive and depart from their stations so that they won't be too much crowd. Richard hoped that with some adjustments, the



# **Ebiripo and Egusi Ijebu**

biripo is the Ijebu version of moi-moi which can be eaten with Egusi Ijebu soup. It is a cocoyam meal eaten as a solid or as some would say 'swallow' that goes well with the Egusisoup peculiar to the Ijebus. It is necessary to note, that this intriguing meal is well enjoyed by almost all Ijebus, including the indigenes of Imota and Agbowa. Below is a detailed recipe of this interesting meal that can bring you closer to the Ijebus;

### **Ingredient** List Egusi Ijebu:

- Melon Seed (Egusi) -2 cups
- Pepper (Rodo and Tatashe)
- · Fish: Smoked(Shawa, Titus, Panla)- as desired
- · Palm Oil
- · Onions 1 bulb
- · Crayfish to taste
- · Iru (Locust Beans)
- · Seasoning (Maggi and Salt) - to taste

### **Ebiripo:**

- · Cocoyam-4 pieces
- · Pepper (Rodo and Tatashe)
- · Leaves a bunch
- · Salt- to taste

### **Preparation (Ebiripo): To** 4. Add salt to the bowl of make this:

1. Peel, rinse and grate cocoyam then leave in a bowl.

1. Pick, wash and rinse melon seeds (Egusi seeds) to remove dirt. 2. Wash the pepper, rinse then blend. Remember to add the melon seeds and little water while blending the

pepper. The result must be a smooth paste that should not be thick or very watery.

3. Pour the blended paste in a bowl.

4. Get another bowl; debone all the smoked fish and wash thoroughly.

5. Pick a good bulb of onions, wash, slice, and leave in a plate

6. With a clean pot on fire, add palm oil, and heat for 1 minute. Add onions immediately and stir to avoid them getting burnt.

7. Add the pepper and Egusi mixture to the already fried onions in the pot and stir. After stirring, leave to cook for 4 minutes.

8. Wash the locust beans (Iru) thoroughly and pour in the pot on fire. Stir again and reduce the heat of the fire to avoid the soup from frying and becoming too thick.

9. Pour all the fish in the pot and stir.

10. Add Maggi and salt to taste and cookfor 5 minutes. 11. Turn off the burner, as the soup is now cooked.

### How to Serve:

'Serve a rich plate of EgusiIjebu with a wrap of Ebiripo'.

Ebiripo can be eaten with other soups and stews. Egusi Ijebu can also be eaten with other solids and can be cooked with proteins such as beef, chicken, goat meat etc.

couple and their child were found dead in their home in Aga. Ikorodu. The sad incident happened at Borokini Road in Aga, Ikorodu.
