He credits his successful business and legal career to a work ethic he learned from his father, who worked on the farm 7 days a week never taking a weekend or holiday off. As a young boy, Ellis' dad gave him his first job driving a tractor on the family farm earning \$.50 an hour. Ellis also credits his experience at Maur Hill to his academic success after leaving Atchison.

At 16, Ellis came to Maur Hill Prep as a boarder graduating in 1969. He graduated with high honors 1974 from The University of Texas at Austin with a BA in history. Among a host of academic honors, Ellis was elected to the most prestigious and oldest scholarship organization, Phi Beta Kappa He earned his MBA from Southern Methodist University in 1977 graduating with honors, being elected to Beta Gamma Sigma. He earned his law degree from University of Houston Law Center in 1978.

The Texas Lawbook, has recognized Ellis as a legendary attorney that the profession considers one of the "Lions of the Texas Bar". With four decades of practicing law under his belt, Ellis is widely recognized as one of the best commercial real estate transactional lawyers in Texas history. He's represented some of the most powerful and wealthy individuals in the state, including the Bass brothers, Richard Rainwater and David Bonderman."
