



Officers Resign Amid Administrative Investigation

A Sanford Police Department administrative investigation started in March after questionable bodycam footage surfaced online and attracted over two million views and criticism from residents. It was revealed that two officers have resigned during a media briefing displaying the conclusion of the investigation.

The footage from June 2024 showed two of Sanford's officers delaying their response after being called to a RaceTrac gas station in Sanford. A woman working at the gas station was trapped in the bathroom and held at knifepoint by a homeless man armed with a box cutter. The woman sustained severe lacerations to her neck, multiple lacerations on her hand and had a tooth pulled out. Randal Lawton, 62, was charged with kidnapping and aggravated battery with a deadly weapon.

The footage was viewed at the briefing as Smith talked through the findings. Officer Dominick Delorbe, the most senior officer, arrived at the gas station first and failed to act promptly. Smith said that while Delorbe did not hear the screams on the 911 call, he did hear the victim calling for help once on the scene.

The footage shows the second officer, Giovanni Castro, arrive next and also wait for a prolonged period despite knowing the severity of the situation. Lawton was not arrested until more officers came. "They had a responsibility and duty to act. If there was one officer or two officers. He knew that somebody had already

informed him that a situation had taken place and it was clearly his responsibility," said Smith.

Once Smith was informed of the circumstances in March, Dalorbe and Castro were placed on administrative leave immediately and were taken out of service on March 10. Additionally, the supervisors in that chain of command were also involved in the investigation. He said that he was extremely disappointed after seeing the footage and noted both of the officers did not follow department procedures.

Delorbe resigned as he was facing termination. Smith stated that Castro followed directions of the senior officer and was suspended for five days without pay, had an extension of his probationary period and retraining on the department's active assailant process.

The supervisors included a sergeant, a lieutenant and patrol captain who failed to follow through rules and regulations that involve properly notifying the chain of command regarding the full circumstances. See **Officers Resign**, Page 2



behind St. Stephen's Arts & Crafts ministry is to provide a space for members of the Central Florida community to "share their time, talent, ideas and friendship."

While it does succeed in doing that, there is also a larger purpose to the Arts & Crafts ministry: namely, preparing for the church's annual Craft Fair, held in the fall.



St. Stephen's Craft Fair initially began as part of the church's annual Winterfest but eventually split into its own event, with everyone involved bringing a unique handmade creation to sell.

Past Craft Fairs have seen woodworks, a quilt boutique, a collection

of baby's and children's items, custom cards, floral and home decor items, kitchen items, and many other kinds of crafts. No commercial vendors are allowed at the event, and admission is free.

All proceeds from the fair go towards the Society of St. Vincent de Paul, a church-run organization aimed at providing support and outreach to community members in difficult financial situations, and often those who struggle with housing, according to Morales. Last year, St. Stephen's Craft Fair raised over \$12,000 for those in need, and they don't seem to be slowing down any time soon.

es of the event. Each of them received a letter of counseling.

Officer De La Rosa, who made what the chief called a derogatory comment captured by body camera footage regarding the mental health of the suspect, resigned from the agency at the start of the investigation.

"I believe one of the things that has come out of this is that it has allowed us to take a look at ourselves and take a look internally," said Chief Smith. "One of the things that we have done internally as well is made sure that our supervisors are reviewing the bodycams more often, more accurately, and more in detail. And when situations rise to such a level, that information is going to be brought to my attention or the attention of internal affairs or our office."

Oviedo City Council votes to change Land-use Designation for a 55+ Apartment Complex

In a narrow 5-2 vote, the Oviedo City Council on May 5 made a controversial decision to change the land use designation for an almost 10-acre piece of land from low density residential to mixed use for an apartment complex.

The 9.62-acre parcel of land is located on the east side of Lockwood Boulevard and the north side of County Road 419.

The apartment complex, proposed by Kimaya Real Estate, is “Arya at Oviedo” a 55 and older exclusive community with 172 apartment units and more than 6,000 square feet of commercial space.

Public comment on the apartments was extensive, with a dozen citizens voicing their opposition to the apartments over potential impacts on the environment, traffic, the height of the building and conflicts with the city’s comprehensive plan.

Multiple council members, including Mayor Megan Sladek, had their own concerns about the project, but it ultimately passed. Council members Alan Ott and

Keith Britton voted against it.

One concession was made, with council members getting the applicants to agree to lowering the height of the complex to 60 feet from 70 feet, which is in accordance with the Live Local Act.

The Live Local Act, passed in 2023, is designed to increase the availability of affordable housing in the state through tax breaks and other developer benefits if at least 40% of the units are offered at an affordable price.

During the meeting, Oviedo’s Development Services Director Teresa Correa told the council that the apartment complex could be larger, and the applicants could negate having to go through the city council under the Live Local Act.

In a lengthy Facebook post, Sladek cited these provisions in the Live Local Act as the reason she voted in favor despite her reservations.

The apartments passed. If there’s one thing worse than 172 apartments being built on Lockwood Road it is 173 or MORE apartments being built there. I’m throwing the state legislature under the

bus on this one. I resent the state backing me into this corner. Oviedo has a Comprehensive Plan. We spent a lot of time as a community talking about where we’d like our development to happen. We had public hearings and made hard choices about where adding denser housing made the most sense. Then the state thought it would be cute idea to pass the Live Local Act and basically trash that plan.

Just after Oviedo adopted its Comprehensive Plan (2022), the state adopted a law that says that apartments that are “affordable” can go anywhere commercial uses are permitted. Here’s the kicker: in Oviedo, because our adjusted median income is so high, market rate (aka luxury) apartments meet the statute’s legal definition of “affordable.” This means regular old normal apartments are allowed “by right” (and without a public hearing) anywhere a commercial use is allowed.

When faced with the reality that there was no legal way we could guarantee residents that turning down these apartments would not result in EVEN MORE apartments being built, I picked my poison and agreed to 172 apartments with a splash of commercial, because that, in my opinion, is less awful than even more apartments with no commercial component.

So do I like that we approved apartments on this parcel? No. I’d have preferred it be commercial, just like our Comp Plan says it should be. But because of this state-level law, insisting this land be developed according to our Comprehensive Plan is not a choice. Since some-

one already determined that building 172 age-restricted apartments was profitable, it’s not a big stretch to think that 173 apartments that are not age restricted would be even more profitable, and the latter is allowed without a public hearing under state law. Technically, the state-level law says this land is entitled to have 410 apartments. It’s pure nonsense. And it’s also the law.

So that’s why I voted to move forward with the project. It was a 3-2 vote (Sladek, Teuchert, Boddiford voted for it, Ott and Britton voted against). On the up side, the process Council followed to get to this end result could not have been better, and the efforts the Land Planning Agency Members made to nudge this project to be better made a difference. I appreciate their efforts. Collectively, we got the developer to lower the project height by 14% (10 feet), increase open space 23% over what they originally proposed (37% total), and contractually commit to commercial uses that will keep traffic as low as possible (11% as much traffic as could have been allowed “by right” and without public hearings).

Moving forward, I know we’ll all be watching this project like hawks to make sure the eagle that roams this area is protected and that no more land is cleared than the bare minimum required. Nothing is as good as not developing this at all, but I truly believe this project creates the least traffic and most open space any project that would ever have knocked on Oviedo’s door.

Deaf musician plays for the Winter Springs Marching Band

Born profoundly deaf due to sensorial hearing loss, Lainey Mahnken became the first patient at Arnold Palmer Hospital for Children to receive a cochlear implant at just one year old.

Today, Mahnken is able to pick up her flute and let the melody ring out, clear and bright.

A freshman at Winter Springs High School, Mahnken is a proud member of the marching band.

In sixth grade, after following in her sister's footsteps by joining the band, Mahnken decided to pick up the flute.

"I just thought it really sounded good," Mahnken said. "I enjoy play-

ing music. It's fun to connect with my friends who play the same instrument as me and are in the band with me. I use band as a time to just enjoy."

For Mahnken, music is more than just notes on a page. It gives her a meaningful outlet and a space for connection.

"Music can have multiple moods for me," she said. "It can be something relaxing, something relatable. I like all kinds of music — classical, alternative, pop rock. Whatever matches my mood."

A fan of artists ranging from The Cure and The Smiths to modern pop and soothing jazz, Mahnken is drawn to music with strong instrumental elements. One artist she admires is Leve, whose jazzy vocals she describes as "very soothing - it reminds me of the flute."

Alongside her love of music, Mahnken is deeply connected to Deaf culture. She grew up learning American Sign Language, which allows her to build friendships in both the hearing and Deaf communities.

As she looks toward the future, Mahnken has dreams to attend Gallaudet University, a federally chartered university for the Deaf and hard of hearing in Washington, D.C. After visiting the city last year, she was captivated by its energy.

"When I grow up, I just want to live my life, have a good job, make money, and live life to the fullest. I want to travel and discover new places," Mahnken said.

Lainey's mother, Paige Mahnken, has witnessed her daughter navigate unique challenges and develop a deep love for music.

"Just hearing her pick it up and play. It'll be just in the weirdest times, and I just love that. And I'll just stop and listen," Paige Mahnken said.

Lainey's journey is a testament to the possibilities that can unfold when you set your mind to something. Her story highlights life with a cochlear implant and celebrates the beauty of discovering new talents and pursuing what they love.

Miss Piggy

An Orlando-Sanford International Airport police officer was dispatched to Gate 2 at the airport after the pilot of a flight heading to Hagerstown, Maryland, requested assistance after a child was seen being hit on a plane. The officer then spoke with a woman with the child and two unnamed individuals. The group confirmed that there was a disturbance on the plane, and they voluntarily exited. One of the unknown individuals said the child had been in a lot of trouble recently and was very disrespectful on the flight. The officer then spoke with two witnesses on the flight. The first witness described the woman hitting the child and slamming his head on airplane's window. They said, "the woman was not correcting the child, she was abusing him, whipping the 'shxt out of the kid.'" The second witness described the same incident but noted that the child repeatedly called the women fat. The officer reconvened with one of the unnamed individuals, who described the incident in more detail. They said the argument began over the Uber app not being downloaded, which resulted in the child getting his phone taken away. The officer then spoke with the woman again, who said the child was very rude and disrespectful during

their Disney trip. She said he began calling her fat and "Miss Piggy," which lead to her taking his phone away. Kristy Lee Crampton, 51, of Hagerstown Maryland, was charged with domestic cruelty toward child, abusing child without great bodily harm.

Say uncle!

Deputies with the Seminole County Sheriff's Office were dispatched to 795 Snow Hill Road, Geneva, on the afternoon of May 23, after a man reported his uncle had fired a gun at him. A deputy reviewed a video on the man's phone, time-stamped at 1:16 p.m., that showed the confrontation. The man said the argument originated between a road rage encounter between him and his uncle on County Road 426, that culminated with his uncle following him to his residence. The man said the bullet passed close to his right ear and shoulder and that he wished to press charges. The man's uncle admitted to firing one round, but claimed he only wanted to teach his nephew a lesson, not kill him. Eddie Lee Banks Jr., 78, of Geneva, was charged with attempted homicide.

Saved by friends

A Sanford police officer responded

to a domestic disturbance call at 815 Historic Goldsboro Blvd, Sanford, on the early morning of May 21. The officer spoke with a woman who said she drove to her ex-boyfriend's house located at 106 Magnolia Park Trail, Sanford on the afternoon of May 16 after he asked her to visit him through a mutual friend. The woman noted that the man was previously arrested for domestic violence against her and was on pre-trial release. One of the conditions of his pre-trial release was to have no contact with her. The woman said she planned to tell him she was "100 percent done with him." Once she told the man, she attempted to leave but was thrown down on a bed by him. He began striking her and eventually choking her until she was unable to breathe and began experiencing starry vision. She then hit the man, allowing her a chance to get away, but was then thrown on the ground. The man then wrapped his legs around the woman's head, squeezing her throat with them until she was once again unable to breathe, had blurry vision and involuntarily urinated herself. The man told her, "I'll kill you right now I don't give a fxxk." Two of the man's friends then opened the door and removed him off the woman, allowing her to escape. Since the incident, the woman has experienced painful swallowing and sustained welts on her head and bruises on her body. Yah'Seir Amarian Brown, 19, of Sanford, was charged

with kidnapping, domestic battery by strangulation and contempt of court violating injunction of protection against domestic violence.

Bears growl in Class 5A State Softball Final

LONGWOOD — Capped by Winter Springs High School winning the Class 5A State Championship, a trio of Seminole County teams made an amazingly impressive run before the home fans at the 2025 FHSAA State Softball Championships at Boombah-Soldiers Creek Park.

The No. 2 seeded Bears (24-8), with only one senior on the roster, dominated the first half of the Championship Game at the complex located around

Winter Springs had advanced to the final with a 5-4 victory over No. 3 seeded North Fort Myers (20-8) on a walkoff, one-out, double in the bottom

Farrah Gordon was the Head Coach for the Bears and the roster was made up of Seniors: Alondra Maldonado; Juniors: Lilly Clark, Reese Fernandez, Adison Pierce, Bella Reed, Miranda Rinne and Katelyn Wassey; Sophomores: Christina Brisson, Lauren Daugherty, Kamylah Fermin, Abigail Hooper, Bubbie Mandigo, Summer Mason, Tiffany Seemann and Adisyn Traugher; and Freshmen: Madison Barahona and Kennedy Jackson.

The Geneva School (22-4), whose campus is also within five miles of the state site on the old horse racing park

on Seminole Boulevard in Casselberry, took an early 4-0 lead and then looked to have grabbed the momentum with a 6-run fourth inning highlighted by a grand slam from 8th-grader Ella Ingram in the Class 1A State Championship Game, but the third-seeded Knights saw the offense go cold as top-seeded Ft. Myers-Evangelical Christian (28-3) rallied with a pair of 4-run innings to pull out a 17-14 victory.



Integrating faith into our journey towards mental well-being doesn't negate the practical steps of seeking professional help. Just as we might seek medical attention for a physical ailment, recognizing the need for support from healthcare professionals like counselors and psychiatrists is a sign of wisdom and self-care. Our faith encourages us to be good stewards of the bodies and minds God has given us, and this often involves utilizing the resources and expertise available in the medical and therapeutic fields. Seeking professional guidance aligns with the biblical principle of seeking wise counsel (Proverbs 12:15), allowing trained individuals to offer evidence-based strategies and support.

Furthermore, for some, the management of mental health conditions may involve the use of medication, prescribed and monitored by qualified medical professionals. Embracing this form of treatment should not be seen as a lack of faith, but rather as a responsible step in caring for one's overall health. When the mind is broken it is harder to fix than a broken bone. Although, with the proper medication and wise counsel - one can get their lives on track. Mental health doesn't have to be taboo.

In the bible David had his mental break downs, yet God still loved him in his brokenness. We can be broken and later rise to resilience. Psalm 22: This is a profound psalm of lament and anguish. David describes feeling forsaken by God, mocked by his enemies, and physically weakened. His cries are desperate, yet even in his despair, he expresses trust and hope in God’s ultimate deliverance.

You can see this in verses like:

- “My God, my God, why have you forsaken me? Why are you so far from saving me, from the words of my groaning?” (Psalm 22:1)
- “I am poured out like water, and all my bones are out of joint; my heart is like wax; it is melted within my breast.” (Psalm 22:14)

However, the psalm ends with a powerful declaration of God’s future triumph and praise. Therefore, a comprehensive faith-filled approach to mental health

embraces both spiritual practices and the responsible utilization of professional healthcare. Prayer, Meditation, scripture, and community support provide a vital framework of hope and strength, while seeking counsel from therapists and adhering to prescribed medication, when necessary, are practical steps in addressing the complexities of mental health conditions. Recognizing the value of both spiritual and professional support allows individuals to pursue healing and wholeness in a way that honors both


their faith and their physical and emotional needs, ultimately leading to greater well-being and a deeper connection with God and others.






