FEP Operations Center Secure E-mail Process

Overview

Introduction

To ensure compliance with HIPAA Security guidelines, e-mails containing Personal Health Information (PHI) must be secured so that the PHI contained in the e-mail cannot be accessed by other than the recipient. Sigaba is the web-based application used at the FEP Operations Center (FEPOC) to encrypt (secure) electronic mail (e-mail) that contains Personal Health Information.

FEPOC associates send secure e-mails to recipients (FEP Plans, FEPDO associates, vendors, etc.) via the Sigaba application by entering a message with "securefepoc" in the Subject line. To retrieve the secure e-mails, recipients must register via Sigaba. Once registered, the secure e-mails can be accessed by the recipient (securefepoc will appear in the subject field of the e-mail). The secure e-mail may vary slightly in appearance due to the various platforms (i.e. Yahoo, Outlook, Hotmail, etc.) that recipients use.

This document has been developed to communicate the procedures for sending and retrieving secured emails via Sigaba.

Introduction


The Secure E-mail Welcome (Main) Page introduces a user to the secure e-mail process and related activities. From this page, users have the option to select the appropriate link to:

- Register, if they are a first time user
- Update their profiles
- Address Password or User Identification (ID) Problems

Note: Only the recipients (not the sender) of secure e-mails need to register with Sigaba.


