<p>Ground level tracking shots follow the character's feet throughout the film.</p> <p>The camera moves from left to right. Out of the dark is shown a hallway. A boy, Aarav, runs to the main door, takes out his shoes from the shoe rack, and sits down to tie his laces.</p> <p>Once done, he gets up, grabs his bat, and informs his mother before leaving. Aarav leaves through the door.</p> <p>The door opens. Aarav enters all dirty. He puts his cricket bat to the side and removes his shoes with his own feet, without caring about them.</p> <p>The camera follows Aarav to the left before Aarav disappears into the dark.</p> <p>The camera starts moving to the right again. Out from the dark comes a teenage Aarav, who is more calm and mature.</p> <p>The camera follows Aarav to the shoe rack and the main door. Teenage Aarav pretty much follows the same actions, but his shoes are new and his bat is bigger.</p> <p>Teenage Aarav opens the door and leaves. Out from the door, Aarav returns home, all dirty and sad.</p> <p>Aarav puts his bat in its place and sits near the shoe rack, crying. His mother enters the frame and shows concern for him.</p> <p>Aarav sobs as his mother comforts him. The camera moves to the left, into the dark. The voices of Aarav and the mother fade away.</p>	<p>Aarav: Mom, main khelne jaa raha hu. Mom: Aarav, 8 O'clock ke pehle aanay. Aarav: Haa.</p> <p>Aarav: Mom, I am home.</p> <p>Aarav: Mom, I am leaving Mom: Good luck for the selections beta.</p> <p>Mom: What happened beta? Aarav: Nahi hua selection. <p>The camera starts moving to the right again. Out from the dark comes a grown up and more mature Aarav.</p> <p>Aarav's father enters the frame, while he is on his way to the main door.</p> <p>Aarav is surprised to see his new kicks.</p> <p>Aarav sits down near the shoe rack. Mother enters the frame.</p> <p>Aarav ties his laces and pauses for a second. Slow zoom-in on the shoes.</p> <p>Slow zoom-in on the shoes continues.</p>	<p>Aarav: What is this, papa? Father: Congratulations on the selection beta.</p> <p>Aarav: New BRAND NAME shoes ! Father: Chalo, wear them and show me.</p> <p>Mother: Ohoo, new shoes. Aarav: Yes</p> <p>Father: What happened beta? Aarav: Nothing; its' just BRAND NAME has been with me for so long now. My forever sideKick.
