He sits down, wears them, gets up, grabs his cricket bat, and leaves through the main door.	A / A
The door opens. The same kid comes out with dirty shoes. He takes them out right away using his feet, puts his bat in its place, and rushes to his room. The camera follows him, and his feet disappear into the dark.	
Out from the dark comes a teenage boy. He very much follows the same actions as the kid, but in a more calm way. The shoes are new, and the bat is bigger.	IWRITERS
He leaves through the door after wearing his shoes and grabbing his bat.	CIATION
Door opens. The teenage boy returns home all in dust, especially his shoes. He sits near the shoerack and cries.	
The camera moves to the left, where it is dark, pauses, and starts moving to the right again.	
Out from the dark comes a grown up and more mature boy. He is greeted by his mother and father. While the mother waves aarti for him, his father pats him on the back.	
Mother and father leave the frame as the camera follows the boy, who sits down to	



wear his new shoes before leaving through the door.

The door opens. The boy enters again, but this time, with a cup in his hand.

His parents enter the frame and congratulate him. He hands his trophy to his mother.

While his parents leave the frame, he sits down near the shoe rack to until his laces.

He pauses for a second and takes a hard look at his shoes. The camera zooms in to focus on the shoes.

The frame blurs to show graphics of the BRAND NAME and its tagline: An athlete's forever side-KICK.
