Jeffrey Bruce Atkins Sr., widely recognized by his stage name Ja Rule, was born on February 29, 1976, and hails from New York City. <https://youtu.be/DxNrXdcQHNs> {4:08-4:27}

As a significant figure in the hip-hop scene during the 2000s, Ja Rule is celebrated for his unique approach that merges the intensity of gangsta rap with the mass appeal of pop music, establishing himself as a pivotal artist who bridged these genres.

The rivalry between 50 Cent and Ja Rule stands as one of hip-hop's most enduring disputes, initiating in 1999 and extending to the present, with no apparent end in sight.

Before aligning with Interscope Records, 50 Cent was embroiled in a notable conflict with Ja Rule and his record label, Murder Inc., over allegations involving a robbery of Ja Rule's jewelry by a friend of 50 Cent's an incident Ja Rule insinuated 50 Cent had masterminded. Ja Rule attributed the feud's origin to a music video shoot in Queens, where he felt 50 Cent was envious of the attention he was receiving from the local community.

Ja Rule and 50 Cent kept on going back and forth and dissing each other about the robbery incident.

In October 1999, 50 Cent released his initial track disparaging Ja Rule and Murder Inc. This track was part of his initially planned but ultimately unreleased debut album, "Power of the Dollar." Despite never being officially released, this diss track emerged around the same time Ja Rule celebrated the success of his debut album, "Venni Vetti Vecci," which achieved sales of over a million units.

A physical altercation took place in March 2000 at The Hit Factory in New York. The two artists were scheduled to perform at the same venue, leading to an exchange of words that quickly escalated into a physical confrontation between them. <https://youtu.be/DxNrXdcQHns> {9:11-9:16}

This altercation resulted in 50 Cent sustaining a stab wound and needing three stitches. The rapper Black Child admitted to the stabbing, claiming it was in self-defense under the belief that there was a gun threat. <https://youtu.be/DxNrXdcQHns> {9:21-10:34}

The dispute was further complicated by an IRS investigation that hinted at connections between Murder Inc. and drug lord Kenneth "Supreme" McGriff. The investigation revealed potential conspiracies to harm Jackson, including his shooting in 2000 and subsequent lack of cooperation with law enforcement regarding the incident. Communications intercepted from Murder Inc. indicated ongoing threats against Jackson linked to McGriff.

In 2002, 50 Cent made his mark with the release of "Wanksta," a track rumored to be a dig at Ja Rule. This song emerged as 50 Cent's breakthrough single, climbing to the 13th spot on the Billboard charts.

In 2002, allegations arose against 50 Cent suggesting he had obtained an order of protection against Irv Gotti and Ja Rule, putting his reputation at risk. Irv Gotti was the one who brought this claim to light. Despite these claims, 50 Cent refuted them, and his image remained largely

untarnished. It was later clarified that although an order of protection was indeed issued, it was not directly requested by 50 Cent himself but was instead initiated by law enforcement as a protective measure for him. Between 2002 and 2003, the rivalry between 50 Cent and Ja Rule escalated as they exchanged a series of diss tracks. 50 Cent released tracks such as 'I Smell P***y', 'Back Down', and 'Hail Mary', with the latter focusing on Ja Rule's apparent fixation with Tupac. In response, Ja Rule countered with tracks like 'Loose Change' and 'Guess Who Shot Ya', keeping the feud alive with their musical exchanges.

By May 2011, both parties signaled the official cessation of their feud. This period of peace was briefly disturbed in 2015, reigniting over social media comments related to another feud between Meek Mill and Drake, with 50 Cent and Ja Rule exchanging jabs.

In 2017, Ja Rule faced significant criticism for his involvement in the Fyre Festival debacle, a highly publicized event that failed to deliver on its promises, leaving attendees stranded and out of pocket. The beef between 50 Cent and Fat Joe ignited in 2004, intertwined with 50 Cent's existing feud with Ja Rule. The spark was Fat Joe's collaboration with Ja Rule on the track "New York," which led to 50 Cent targeting both Fat Joe and Jadakiss with his diss track "Piggy Bank." The conflict escalated with various exchanges of insults and diss tracks over the years. However, the passing of Chris Lighty, a mutual friend, <https://youtu.be/4sYODflywu8> {0:00-0:17} led to their eventual reconciliation during a tribute at the BET Hip-Hop Awards.

In 2007, the rivalry between Kanye West and 50 Cent peaked when they released their albums, 'Graduation' and 'Curtis,' on the same day.

50 Cent was confident he'd outsell Kanye, even stating he'd quit releasing solo albums if Kanye's sales were higher. Despite Kanye selling 957,000 copies in the first week to 50 Cent's 691,000, 50 Cent continued his music career, not sticking to his retirement statement.

William Leonard Roberts II, widely recognized as Rick Ross, is a prominent figure in the hip-hop industry, both as a rapper and a record executive. He's celebrated for his deep, commanding voice, an imposing presence that transcends his music, and his ability to paint vivid pictures through his lyrics.

50 Cent and Rick Ross' beef dates back to 2008 when 50 complimented Ross during an interview but also warned him not to stand too close to Fat Joe, with whom 50 was beefing with at the time.

In early 2009, Ross released "Mafia Music," which takes shots at 50. 50 Cent responded by dropping "Officer Ricky (Go Ahead and Try Me)." The two would continue to trade shots in songs and in interviews. The same year, 50 Cent put out a sex tape featuring Rick Ross child's mother, which would eventually land him in a lawsuit that he lost and in turn had to file for bankruptcy.

But mostly the situation has died down from its height. Last month, Rick Ross was asked during an interview if his feud with 50 would ever end. He responded, "I doubt it."

One of the ultimate beefs 50 Cent was involved in that shocked a lot of fans was his beef with Diddy.

Sean Love Combs, who has gone by Puff Daddy, P. Diddy, and Diddy, is a multifaceted American artist renowned as a rapper, record producer, and executive. Originating from Harlem and

raised in Mount Vernon, New York, Combs initially made his mark as a talent director at Uptown Records. He later established his own label, Bad Boy Records, in 1993, significantly impacting the music industry.

The longstanding feud between 50 Cent and Diddy escalated with 50 Cent's 2006 track "The Bomb," where he insinuated Diddy had knowledge about the Notorious B.I.G.'s murderer.

Biggie, a pivotal figure in East Coast hip-hop and gangsta rap, was tragically killed in a 1997 drive-by shooting. Known for his distinctive, laid-back lyrical style and storytelling that often explored dark themes, Biggie remains a towering influence in rap music, celebrated for changing the genre's landscape with his profound lyrical prowess and flow. <https://youtu.be/CapF98d7QeI> {0:00-0:11}

On the night of March 8, 1997, following a Soul Train Awards after-party at the Petersen Automotive Museum in Los Angeles, Christopher Wallace, known as Notorious B.I.G., was shot in a drive-by incident. Leaving the overcrowded venue in two GMC Suburbans with his crew, Wallace's vehicle was stopped at a red light when an unidentified assailant in a black Chevrolet Impala opened fire, striking Wallace with four bullets. Despite being rushed to Cedars-Sinai Medical Center and undergoing emergency surgery, Wallace succumbed to his injuries, passing away at the age of 24. <https://youtu.be/CapF98d7QeI> {0:13-0:51}

His autopsy, which was released 15 years after his death, showed that only the final shot was fatal; it entered through his right hip and struck his colon, liver, heart, and left lung before stopping in his left shoulder. Wallace's funeral was held at the Frank E. Campbell Funeral Chapel in Manhattan on March 18. There were around 350 mourners at the funeral, including Lil' Cease, Queen Latifah, Mase, Faith Evans, SWV, Jay-Z, Damon Dash, DJ Premier, Charli Baltimore, Da Brat, Flavor Flav, Mary J. Blige, Lil' Kim, Run-D.M.C., DJ Kool Herc, Treach, Busta Rhymes, Salt-N-Pepa, DJ Spinderella, Foxy Brown, and Sister Souljah. David Dinkins and Clive Davis add the pictures of the people mentioned also attended the funeral. Diddy was reportedly with the late rapper the night of the shooting but was in another vehicle. 50 Cent has since accused Diddy of continuing to profit off the name of the Notorious B.I.G., who was signed to Diddy's Bad Boy Records label, through posthumous releases and sampling

the late rapper's material in his own songs. 50 Cent has also insinuated on multiple occasions, including as recently as December 2023, that Diddy was involved with the 1997 murder of Tupac Shakur. Authorities have not accused Diddy of wrongdoing regarding Tupac and the rapper called the insinuations "nonsense" in a 2016 interview. <https://youtu.be/JybiuU49hCk> He has also made comments about Diddy's sexuality on numerous occasions, calling him "fruity" in a 2018 interview, pointing to an instance in which Diddy asked 50 Cent to go shopping (which Combs said in an interview was because he thought 50 Cent "needed some clothes"). 50 Cent also claimed he doesn't go to Combs' parties because he'd "hug you from the front and the back at the same time." 50 Cent also trolled Combs over their competing vodka brands in 2015, repeatedly tweeting the hashtag #nopuffyjuice to deride Combs' Ciroc company. <https://youtu.be/-FDdplZnNQs> {0:00-0:50}

In contrast, in December, 50 Cent announced his production company, G-Unit Film & Television, would produce a documentary about the sexual assault allegations levied against Combs, and proceeds would be donated to victims of sexual assault. 50 Cent posted an image that appears to be a promotional poster for a documentary titled "Diddy Do It?" on Instagram on Wednesday, causing a spike in search for the title, though the poster's artist Kode Abdo confirmed to Forbes it is not a poster for a real show.

The beef between 50 Cent and Diddy hasn't been resolved as 50 Cent kept on dissing him regarding Diddy's house being raided.

Apart from beefing and dissing rappers, 50 Cent has also been in notable beefs with Actors and Boxers.

His Beef with Will Smith wasn't something his fans were expecting.

The tension between 50 Cent and Will Smith emerged when 50 Cent made comments about Jada Pinkett Smith's relationship with August Alsina, following her revelation on "Red Table Talk." show a picture of Jada pinkett's red table talk Their exchange, which began with 50 Cent checking in on Will, escalated quickly, leading to a sharp retort from Will after 50 Cent's probing questions about their personal matters.

Floyd Joy Mayweather Jr., an American former professional boxer and current boxing promoter, had a career spanning from 1996 to 2017, during which he maintained an unbeatable record. He secured 15 major world titles across various weight classes, ranging from super featherweight to light middleweight, marking him as one of the sport's all-time greats.

The fallout between 50 Cent and Floyd Mayweather began after Mayweather's 2012 prison release, with 50 Cent claiming Mayweather owed him money.

As reported by ESPN, in 2012, Mayweather was in jail for two months after being sentenced to three months "in a misdemeanor domestic battery case." As the publication also noted, he was released from the Las Vegas prison on August 3, 2012.

According to The Mirror, 50 Cent said he was in charge of kickstarting Mayweather's promotions company, The Money Team, while the retired boxer was behind bars. As the outlet also noted, Jackson said he did a good job with the company and started to sign boxers to the business. However, once Mayweather was out of prison, 50 Cent said he never got the \$2million he was owed.

50 Cent famously claimed that Mayweather's funds were dwindling.

This led to a public exchange, including 50 Cent challenging Mayweather to read a page from Harry Potter for charity, later changing it to "Cat in The Hat" on Jimmy Kimmel's show.

When asked if Mayweather should go back to boxing, Jackson responded: "I think he got to right now because the money's gone." On July 27, 2020, Mayweather spoke about the drama on the Champsides podcast. When asked about the feud, the former boxer responded: "You can't hang out with me every day for years and all of a sudden, if I don't give you half of my company, now it's 'oh, you're dumb and you're stupid and you can't do this, and you can't do that.'" He continued: "But, if I can't do all these things, why are you hanging around me?"

As of 2022, the decades-long beef between the two men has been resolved. On August 15, 2022, 50 Cent went on The Breakfast Club and shared that the feud was over. 50 Cent said: "I went to see him when I was in Vegas, around my birthday." He later revealed that the two had apologized to each other and that Mayweather had asked the rapper: "Why'd it take you so long?"
