Hi! and welcome to 50 states of crime

INTRO GRAPHIC (50 STATES OF CRIME)

My name is Hannah Ferrara, the host of my new true crime podcast!

Today is the very first, and long awaited episode, and I just wanted to thank all that are watching; it means so much to me.

With that being said, let's go ahead and jump right in to our first case.

I thought it was only right to start our series of states off, with one that is close to heart and home for me: New Hampshire.

Our first case takes place in the southern part of the state. The city we are going to be located in is nicknamed the "Queen City" for being the largest population in NH, but is actually known as Manchester.

We have a lot of details to get into regarding this case today, so I want to get started as soon as possible. But, before we do that, I do just want to give a trigger warning and let you guys know that what we will be discussing and showing today can be extremely hard to hear. Just please approach

with caution, especially because unfortunately we will be talking about a young girls murder.

Harmony Montgomery was born on June 7th, 2014; making her only 5 years old at the time of her death.

She is described as a sweet, kind, funny, little girl that especially loved to talk. She had bright, beautiful blonde hair, ocean blue eyes, and the cutest pair of glasses you've ever seen.

Unfortunately due to the sort of roller coaster of a childhood that Harmony did have, not much information about it is out there. Along with that, I wasn't able to find a lot of information regarding Harmony's extended family; so we are mostly going to discuss her parents.

Harmony's mother, Crystal Renee Sorey was born in Haverhill, Mass on September 14th, 1990, making her about 34 at the time. Not much information regarding Crystal's childhood is available, but we will come back to her when we talk about the years leading up to Harmony's death.

The person we need to focus on the most here, other than the victim, is her father; Adam Montgomery.

Adam Montgomery was born on January 22nd, 1990, making him about 34 at the time as well.

The information I found on Adam's parents and childhood came from Reddit, so I can not say that it is 100% valid; but The Boston Globe has made several hints to the same story in their articles and research.

It is believed that Adam's childhood was scarred by drug use and violence. He was allegedly born to a pair of troubled teenagers. His father "Michael" was 16 at the time, and his unnamed mother was 15. Court records also show that Adam was placed into custody of his father's family after being born.

In 1995, when Adam was 5, his father was prosecuted for robbing a McDonald's, while holding a toy gun and wearing a mask. He was ultimately sentenced to 6 - 9 years in prison. Adam's paternal grandparents were left to raise him and his 3 year old brother.

After growing up with a troubled life, even with his grandparents, at age 14 Adam was sent to live with another member of his family, Michael Montgomery. Together they moved to Clearwater, Florida; where police records show that after Adam enrolled in high school, he stole his uncles BMW, crashed it and ran away from home. We don't have information on the following years of his life, until

he eventually moved back to New Hampshire, and his life began to spiral.

In July 2007, making Adam only 17, he and his uncle were caught sharing a bathroom stall in a McDonald's in Chelsea. Adam's uncle had "track marks" on his arm indicating recent drug use, and Adam himself was found with heroin and a knife in his pocket. Not only that, but he was found with a teardrop tattooed under his left eye; which is a symbol associated with gang and prison culture.

State Police did charge Adam with possession of heroin and violating a city ordinance for carrying a knife; but he successfully fought the charges.

As time went on, trouble increased and continue in Adam's life. In 2008, Adam was actually identified as a suspect in the murder of Darlin Guzman, who was shot and killed in the parking lot of a Lynn convenience store in February of that same year. No arrests have been made in that murder case since.

Four days after Guzman was killed, Adam was accused of, and later plead guilty to, breaking into a Malden apartment with another man and demanding money from three women; whilst threatening them with a pellet gun. A few months after that, he was arrested and also eventually plead guilty to

stabbing another man in the leg in Manchester.

On top of the the awful reputation that follows Adam, not many people have ever had anything good to say about him. People have described him as someone who can come off as a nice guy to strangers, but then turns out to be a pure evil man who has a "black soul". In a more recent interview, Crystal Sorey even said that Adam is "manipulative and misogynistic; that she was afraid to have a girl because of how he viewed women."

Hearing how Harmony's mother had a feeling of fear ever since she first found out her gender; sends chills down my spine knowing how this story heartbreakingly plays out.

Before we start to get into the timeline of Harmony's life, I wanted to mention that you guys will be hearing me mention a women named Kayla Montgomery. Kayla is Adam's former wife, who was disgustingly involved in Harmony's murder and there throughout the entire time. There is not much information to find on Kayla, and frankly I am fine with not discussing her life prior to the hell that her and Adam put Harmony through. With that being said, let's get into the details of this timeline.

Our story today starts around August 2014, 3 months after Harmony Montgomery was born. From

August 2014 till January 2018, Harmony was removed from her biological mother, Crystal Sorey's, care on three separate occasions related to drug use and neglect. Since Adam was actually in prison when Harmony was born, she only visited him two separate times in January and July of 2015.

In September of 2015, Adam is released from prison and moves back to New Hampshire; but it isn't until a full year later in September of 2016 that he decides to contact DCF and try to resume visits with Harmony. I do believe that DCF dropped the ball on this case and Harmony's safety in general, but as we continue to discuss, I would love to hear what you guys think. This is just my opinion.

Anyways, after DCF grants permission to Adam to visit Harmony once a month, he does so for about 5 months. When February 2017 rolls around, Adam randomly stops responding to DCF and stops visiting Harmony.

In the time that Adam was essentially MIA, Crystal unfortunately had lost the custody of Harmony to the state of Massachusetts in part, due to a substance abuse issue. Harmony was then placed in a foster home in Haverhill in July of 2018. A month later, Adam contacts DCF and visits Harmony for the first time in 11 months, and only the 9th time in her life.

On February 21st 2019, is when the state of Mass unfortunately failed Harmony, and let Adam have full custody. Within the first five months of Adam having custody of Harmony, DCYF received an anonymous call alleging abuse at the Montgomery household, which was located on Gilford Street in Manchester at the time.

The caller stated that Harmony had a black eye when they visited the Montgomery household the week prior. A CPS worker visited the home and ended up telling the Manchester police that they did not observe any eye injury at the time. The month after this call, on August 7th, A CPS worker revisits the home and interviews Harmony, Adam, and Adams new girlfriend Kayla. The worker did note a red mark on Harmony's eye and faded bruising on her eyelid. Adam and Kayla stated that the mark was caused from being struck with a toy while playing with a sibling. On October 1st, 2019, CPS paid their last visit to the household on Gilford Street, and found that all children appeared to be happy and healthy. This would be the last time CPS workers will ever see Harmony again.

The next few months in this case get a little bit harder to follow, and I might have to jump back and forth between years. I know it's difficult to keep up with, hopefully the dates at the bottom of the screen can help. What makes explaining this in one straight line so difficult, is that we have a couple different timelines

pertaining to everyones stories to go through. I also want to preface that the the information in the next parts of this story, including the murder, are all sourced directly from the arrest affidavit of Adam Montgomery and the Lead Detective on the case, John Dunleavy.

Before we get into the murder timeline and thereafter, I want to explain what Crystal Sorey, Harmonys biological mother, was going through for the years that Harmony has been missing and how the Manchester Police uncovered what they did.

On November 18th, 2021, the Manchester Police department received a call from Crystal Sorey who was reporting that Harmony, while in the custody of Adam, has gone missing. She explained that since losing custody, she has regained sobriety and unsuccessfully made attempts all throughout 2021 to locate Adam and Harmony. Adam and Kayla had blocked all communication with Crystal through phone number and social media. Over the years she has made attempts to locate Harmony by contacting various schools and driving by addresses associated with Adam, but didn't wield any success. At this point, she hadn't seen Harmony in over six months. The last time she had physically seen her was only through a Facetime video around easter 2019, and Crystal recalls Harmony looking frightened.

Learning this information, MPD decided to contact DCYF and learned of previous addresses associated with Adam, but were unable to locate him or Harmony. DCYF was also unable to locate her; so the MPD initiated an investigation into the whereabouts of Harmony Montgomery on 12/27/2021.

They began to actively make attempts to track down Adam and talk to involved family members to establish the last time that Harmony was physically observed and known to be safe. Officers and investigators were unable to make contact with Adam through the phone, but were able to make contact with various family members who associated with Adam and resided in Florida. Through these family members, investigators received information that Adam had previously admitted to giving Harmony a black eye back in July of 2019.

The next day, December 28th, detective John Dunleavy was able to connect and speak with Kayla Montgomery. He found that Kayla shares three younger children with Adam, but they are all accounted for. During this interview, Kayla was asked about the last time she had physically seen Harmony. She responded and said that she saw Harmony last sometime in November or December of 2019, one morning before going to work. She explained that, that same morning Adam said that he was driving Harmony back to Crystal who was living in Mass at the time; and

she never saw or heard about her after that day. She also claimed that she had not physically seen Adam since late October 2021 and had not spoken with him since around mid-November 2021. The last she knew, she claimed he was living in a sober house before leaving the area to live in Maine with another female.

On December 31st, 2021, officers were able to make contact with Adam and his new girlfriend, Kelsey Smalls. They were found sleeping together in a vehicle in the area of Harvell Street in Manchester. Detectives showed up at the scene as soon as possible to speak with the couple.

Kelsey Small claimed that she had been romantically involved with Adam for over a year now, and that she was aware Adam had three children from one mother and another child from before that. However, Kelsey said that Adam was not in touch with any child from his prior relationship and that he never talked about Harmony; so she has no information on where she may be.

Now, during the detectives interaction with Adam; they continuously stressed their concern that Harmony had not been physically seen in over two years; and they weren't certain she was even alive. The police report emphasizes on the fact that Adam did not exhibit much emotion and or react to this at all.

That same day, Kayla Montgomery participated in a voluntary interview with detectives about the last time she saw Harmony. She told detectives that two days after Thanksgiving 2019, November 30th, 2019, Adam had taken her to work which was a 6:00 am to 2:00 pm shift at Dunkin Donuts on Eddy Road in Manchester. She said that while Adam was dropping her off, he stated he was going to bring Harmony to her mother so she could stay in Mass with her. When Adam picked Kayla up from work later that day, he no longer had Harmony and said that he had just dropped her off. Kayla had just assumed Adam had safely dropped Harmony off in Mass with Crystal.

Detectives were definitely concerned about Kayla's claims that Adam said he was bringing Harmony to Crystal, because Crystal had blatantly denied ever taking custody of Harmony from Adam at that time or ever even seeing her following the Facetime in April of 2019. When this was investigated, they found that Crystal was living in Lowell, Mass with her boyfriend. He was interviewed and he confirmed that Harmony was not with Crystal at all from October 2019 to present day.

They also had found that DCYF contacted the Manchester School District in September of 2021 and found that Harmony was not registered at all.

On December 31st, 2021, the 9th Circuit-Family Division-Manchester granted protective supervision of Harmony to DCYF from Adam via a Juvenile Abuse/Neglect Ex Parte Order. At the time of this order, Adam had been Harmonys sole parent in custody. Now, this order states specifically that he was ordered to cooperate with the MPD and assist with locating her. When Detective Riley served this order to Adam the same day, he still refused to provide any information on where Harmony was. Specifically, when he was served the order, he said "either arrest me or I am leaving" and refused to answer any additional questions.

About 5 days later on January 4th 2022, Adam was officially arrested, formally charged and arraigned on charges relating to Harmony. These charges consisted of second degree assault for an incident in July of 2019, inference with custody, and two charges of endangering the welfare of a child. He has been detained at the Hillsborough County House of Corrections since that date.

It wouldn't be 5 months later, until June 3rd, 2022, that investigators would learn and get information on what actually happened to Harmony, and where she might be.

Jumping backwards just barely two weeks, Kayla Montgomery takes the stand and testifies before the Grand Jury for Hillsborough County

Northern District as a part of the Grand Jurys investigation into the disappearance of Harmony. Despite Kayla being under oath for her testimony, she continued to tell the story of seeing Harmony one day before work and Adam taking her to live with her mother in Mass. Investigators actually ended up researching Kaylas claims that she was at the Dunkin location at the specific times she had previously allotted. Every single Dunkin location in Goffstown confirmed that Kayla was not working there on the day she claimed she was. As a result, a arrest warrant was obtained for Kayla on two charges of perjury.

Kayla was officially arrested on the perjury charges on June 3rd, 2022. That same day, she sat down for an interview with the MPD and her attorney. She outwordly addmitted that she had lied during her grand jury testimony; and she had information regarding Harmony Montgomery. The information that I am going to explain from here on out is all from Kaylas side of the story and her interview with detectives.

Kayla stated that the family including herself, Adam, Harmony and the other unnamed two young children, were evicted from the house they were living in on Gilford Street in Manchester the day before Thanksgiving 2019, which would have been on November 27th. After they were evicted, they were living in there vehicle which was a Chrysler Sebring. During their time living out of

the vehicle, they stayed in the parking lot of Colonial Village on River Road in Manchester where their friend, Anthony Boderro, lived.

Kayla went on to explain that the day their Chrysler Sebring broke down, December 7th, 2019, is when Adam struck Harmony, causing her death. In further detail, Kayla stated that while they were all living in the vehicle together, Adam would get extremely upset that 5 year old Harmony was not saying when she needed to go to the bathroom and was having accidents in the car. After each accident, Adam would get upset and strike Harmony in the face or head with a closed fist.

Prior to the vehicle breaking down, Kayla witnessed Adam strike Harmony in the face/head on three separate occasions because she had an accident. This would happen while Adam was driving the vehicle, and Harmony was in the rear seat on the passenger side. Adam would turn his body and deliver sets of three to four blows with a closed fist to Harmonys face/head on those three occasions over the course of a few minutes.

After the final blow, Adam said words to the effect of that he felt something or heard something when he hit Harmony and "I think I really hurt her this time. I think I did something." After this, Harmony began to make a moaning type noise which went on for

roughly five minutes and then stopped. At NO TIME did anyone stop, attempt to pull the car over, or get Harmony any medical attention as the result of this assault. This happened in the morning before the family arrived at the Burger King on Route 3 in Manchester. Afterwards, the family returned to the parking lot of the Colonial Village Apartments. They stayed there for approximately 20 minutes, in which Kayla couldn't recall doing what, but it certainly wasn't checking on the silent Harmony in the back seat. Later in a second interview, Kayla admitted that in this 20 minute period, Adam had her get a bag of Heroin/Fentanyl from Anthony Boderio and used some of it before leaving the parking lot.

After about 20 minutes, the family left the Colonial Village apartments and shortly after is when the car broke down. Kayla claims the car died at around 8 or 9 am but according to the police records, the car was broken down on the intersection of Elm Street and Webster Street at approximately 12:11pm. Kayla said that it was at that time that she and Adam discovered Harmony was not breathing, and unfortunately no longer alive.

I know the thoughts of this brutal assault and murder on such a helpless little girl is already hard enough to sit with, but I do want to warn that it sadly gets worse and more inhumane from here. I will also be showing some hard

to see pictures, so just be aware before continuing.

After discovering Harmony was no longer alive in the backseat of their car, next to their other two children, Adam decided it was best to go to the trunk and remove clothing from a black and red Under Armour duffle bag, and place the lifeless body of Harmony into it. Kayla admitted that at no point did either of them have a single conversation about getting any type of lifesaving measures for Harmony, and that Adam simply put her dead body into the bag and walked it back to the parking lot of the Colonial Village Apartments.

Once back at the apartments, Boderio drove them to their vehicle to collect their belongings before it was towed. He then allowed them to stay in his Audi in the parking lot for two or three days over the weekend.

During the investigation, search warrants were obtained for Facebook and Google records relevant to the time period of late November and early December of 2019. Location data from Google was consistent with the Montgomery family staying in the Colonial Village parking lot from about November 27th to December 8th of 2019; which corroborates Kayla's story of the time period that they stayed there.

Investigators also had a chance to interview some individuals who supported certain details Kayla had told them. Anthony Boderó, the friend who lent the Montgomerys his car and his parking lot to stay in, as well as his girlfriend Donna Demers testified that the last time they saw Harmony was in September of 2019.

Donna testified that when her and Boderó brought the family Thanksgiving leftovers, she had a chance to look in the car; and she was confident that Harmony was not there. Boderó also admitted that he did provide drugs such as "crack and fentanyl" to the Montgomery's, before continuing with his statements. Boderó stated that after Thanksgiving of 2019, the Montgomery's came to him with just two boys, no Harmony, and asked if they could stay with him due to being evicted and their car breaking down. He recalls them arriving with just a few belongings and a trash bag; but offers them his Audi to sleep in. He repeatedly denied seeing Harmony and stated he only knew that they stayed in his car for two nights. When confronted about Kayla stating Boderó saw Harmony and the two children in the car everyday from Thanksgiving to December, he stated that she was lying. When questioned about helping Adam and Kayla retrieve their belongings from their car after it broke down, he didn't remember that happening.

Another witness named Kimberly Frain was interviewed and she

recalled personally interacting with the Montgomerys while they were staying in the Audi in the parking lot on the night of December 7th 2019. She believes that she only saw Adam, Kayla, and the other two children that night.

Investigators also spoke to Courtney O'Brien and her husband Matt Garcia, who claims to have known Adam his whole life. Courtney recalled a conversation she had with Adam sometime between December 2019 and January 2020 in which he said that Harmony was with her mother, Crystal, because Harmony wouldn't stop peeing her pants and he thought she was better off there. Matt Garcia told investigators that he had a conversation with Adam after the news regarding Harmony going missing got out; and Adam said he didn't know why the police were bothering him because he gave Harmony back to her mother. Garcia stated that Adam said "the kid won't stop peeing and shitting everywhere. She was driving me nuts. We were living in the car, so I let her-, I had her mom come and get her."

These little interviews are extremely important to this case, because this information from these individuals is consistent with Kayla's story and when Harmony eventually ended up going missing.

Kayla stated that Harmony's body was moved to various locations over the course of the next several months. Before they left

the apartments and were still staying in this Audi, Adam would keep the bag with Harmony's body inside of it, inside the trunk of the vehicle; but would also leave it out on the snow to stop the decomposition of the body from happening. After a few days of living in Bodero's Audi, the Montgomery family moved in with Kaylas mother and her boyfriend, bringing Harmony's lifeless body along. Their house was located on Dubuque Street in Manchester, NH. When they arrived at the residence, Harmony's body, which was still in a duffle bag, was placed inside of a red cooler with a white top in the common hallway of the apartment building. Harmony's poor body was left there until the end of December 2019.

Kaylas mother testified that during the time frame of the two to three weeks that Adam and Kayla stayed with them, Harmony was not present; and she was told she had gone to live with her mom. When Detective Dunleavy obtained consent to search Kaylas mothers apartment, he asked about the red and white cooler that Harmony's body was previously stored in. Her mother states that this cooler had been in her bedroom closet for close to two years. When she was asked if the cooler had ever previously been in the common hallway of the apartment, she confirmed it had.

Kayla continued to explain that after leaving her mothers house, the Montgomery family moved into a Families in Transition shelter on

Lake Ave in Manchester around December 30th, 2019. She stated that the duffle bag containing Harmony's body was brought to this shelter as well, and placed into the ceiling vent in the bedroom. During this time, she explained that there was liquid coming from the bag as well as an odor; so Adam placed a trash bag around it to keep it from leaking. When Detectives conducted a search of the Families in Transition shelter, specifically the room the Montgomery's stayed in, they found some terrifying but validating information. When they removed the vent to check the part of the ceiling that Harmony's body was kept in, they located a large area of staining and a smell that was consistent with decomposition.

After living at Families in Transition, the Montgomery family moved to an apartment on Union Street in Manchester. They were able to do this because police actually were in possession of a lease agreement that was signed by Adam and Kayla in 2020 for themselves and only TWO children to lease the apartment on Union Street. TWO children. She continued to tell police how they brought Harmony's body along to this new apartment and that Adam had put the Under Armour duffle bag with her body in it, which was inside of one or two trash bags, into a plastic bin storage container, which was then PUSHED on a stroller from the shelter to Union Street. I was able to easily look this distance up on google maps, and that would have been an hour and 10 minute walk through

downtown Manchester. This absolutely blows my mind. Growing up near Manchester, I know how busy and full downtown always is. To think that Adam and Kayla just casually strolled through hundreds of people, pushing their poor dead daughters body and not thinking twice about it, makes me sick.

Once the Montgomery's got to Union Street, they placed the plastic bin container into a closet in one of the bedrooms in the apartment. At one point, Kayla saw Adam take the duffle bag out of the plastic storage container, and saw it leaking. To fix this problem, Adam put another trash bag around it and placed the bag with Harmony's body into the refrigerator.

At some point after Harmony's body was moved into the refrigerator, Adam transferred her body out of the Under Armour bag and into a new bag. Kayla stated that this happened in the bathroom, and that Adam spent four to six hours in there that day with the shower running the whole time. She distinctively recalled an odor and steam coming from the bathroom whenever Adam would open the door, and a scent of cleaning supplies when he had finished up. After Adam was done, he placed Harmony's body inside of what was described as a Catholic Medical Center, or CMC maternity bag. Unfortunately, the bag was much smaller than what her body was placed in previously, so detectives presume that Harmony's body would not have fit unless dismembered or distorted. After all of this was done, Adam

placed the CMC maternity bag inside of the freezer of the apartment.

In a second interview with Kayla Montgomery, she actually changes her story pertaining to Adam putting Harmony's body in the CMC bag in the bathroom. This time around, she stated that she was actually there in the bathroom when Adam dumped Harmony's body into the shower. He added lime to the CMC maternity bag to help with decomposition, and while he did so, Kayla recalled the sight of Harmony. She told detectives, and this is so hard for me to even say, but that she could see Harmony's skin, teeth, and hair; and could ultimately tell it was still her. She continued to explain that Adam was having a difficult time fitting Harmony's body into the CMC bag, because she was frozen. Kayla physically saw Adam run hot water in the shower and "squish" her flesh to try and thaw her out. Whilst doing this, Kayla also helped Adam cut all the clothes off of her body to help fit into the bag. When Adam was pushing and pushing on Harmony's body, Kayla heard a loud bang; but couldn't be sure what it was from. She also recalled Adam banging the CMC bag on the floor while zipping it up; and her assisting to close it. Once it was closed, Harmony's body went back into the apartment freezer and the bathroom was cleaned with ammonia.

Where Harmony's body is transported next is one of the most just disgustingly inhumane

and crazy things I have probably ever heard. Kayla stated that she herself ended up bringing the CMC maternity bag, still containing Harmony's body in it, to Adam's place of work, Portland Pie Company restaurant on Elm Street in Manchester. This was done at Adams request, to which Kayla then pushed her two children to this restaurant in a front to back stroller, with the CMC maternity bag between them. Adam proceeded to KEEP Harmony's body in the walk in freezer OF THIS RESTAURANT for a WEEK OR SO before being brought back to Union Street. When detectives spoke to former employees at Portland Pie Company, which has since closed in 2020, they all recalled seeing the CMC bag in the freezer on a couple occasions on both the floor and the shelves, but never questioned it. They also confirmed that they only saw Adam handling the bag after Kayla had brought it in.

After Adam and Kayla kept Harmony's body there for about a week or two, they decided to bring her back to the apartment on Union Street. They kept her body in the freezer of their apartment until sometime during the spring of 2020. It is unclear how, but shortly after, they transitioned from Union Street to either the Econo Lodge or Comfort Inn in Manchester. Kayla stated that Adam brought the CMC bag with Harmony's body in it, to the hotel and placed it in a mini-fridge that was in the room. This is the location they were at when Adam did something that nobody is sure about still do this day.

It was unclear what date Kayla states this took place, but this is what we know based on Adams Arrest Warrant Affidavit. Sometime around midnight or 1:00am, Kayla claims that Adam took a previously rented U-Haul and left. During the overnight hours, Adam had made a trip to an unknown destination to dispose of Harmony's body, and returned in the morning. She also stated that she has no idea about the location that Adam brought her too, or exactly when he returned. All Kayla witnessed and heard was Adam telling her he was leaving, he would be back, and saw him do so with the CMC bag containing Harmony's dead body. He told Kayla that he didn't want her knowing where she was going in case, quote, "something like this would happen" indicating Kayla being interviewed by police in regards to Harmony. When Adam returned, he seemed exhausted and said words to the effect of "it's done." After this, Kayla never saw the CMC maternity bag again.

Around the time that the Manchester Police Department began looking into the whereabouts of Harmony, they established a tipline so members of the public could call with any information. On February 26th, 2022, police had a call that came through the tipline, and wanted to remain anonymous. The tipster stated that a Jennily Paris and her boyfriend, Travis Beach had come to this tipster's residence a month prior and told them that two years ago, Adam had frantically asked Travis if he could rent Adam a U-Haul

truck. The tipster stated that Adam did not talk about what the U-Haul truck was going to be used for, but stated that Adam had asked Travis in a specifically freaked out and hurried way.

Detectives actually were able to locate travis and his girlfriend living in a parking lot in Manchester, and attempted to interciue them. Travis was extremely uncooperative and would not answer any questions unless it was with an attorney or his parole officer present. In March of 2022, when detectives were able to make contact with travis once again at the Parole Office, they asked him about Adam and his request for a U-Haul. Travis stated that he recalled Adam asking for one around wintertime of 2019 or early 2020. He said he had run into Adam on the street at a convenience store where he continued to tell travis "I fucked up, Im so fucked." When travis was asked if Harmony was present, or if he had ever seen her, he said no. When Adam asked Travis and his girlfriend to rent him a U-Haul truck, Travis's girlfriend Britney obliged and rented him one from South Willow Street in Manchester. Travis stated they had simply left from there and the next day they called U-Haul to make sure that Adam had returned the truck and he had.

After detectives recieved all of this information and were able to follow up on most of the details; it was decided that they were ready for an arrest warrant

against Adam Montgomery. It reads like this: "Based on the forgoing facts and circumstances, there is probable cause to believe that Adam Montgomery committed the crimes of second degree murder, tampering with witnesses and informants, falsifying physical evidence, and abuse of a corpse. One count of second degree murder in that he recklessly caused the death of Harmony Montgomery, a person under the age of 13 years old, under circumstances manifesting an extreme indifference to the value of human life, by repeatedly striking Harmony on the head with a closed fist. One count of tampering with witnesses and informants in that he, knowing that an official proceeding or investigation was pending, attempted to induce or otherwise cause Kayla Montgomery to testify or inform falsely. One count of falsifying evidence in that he purposely altered, destroyed, concealed or removed the body of Harmony with a purpose to impair its verity or availability in such proceeding an investigation. And last but not least, one count of abuse of a corpse in that he purposely and unlawfully removed, concealed, or destroyed the corpse of Harmony Montgomery or any part thereof.

Now I know you guys must be wondering: Where is Harmony's body? And that is the question that investigators, consumers like us, and her family are still wondering. There have been multiple searches for Harmony's body, including one in Chelsea, Mass this past September; but

unfortunatley, nothing has come from it.

Due to the length and overall heaviness that this case holds; I am not going to go into detail about the court cases with Adam and Kayla; because we would be here for another hour. What I can tell you is that, thank goodness, Adam Montgomery was found guilty of second degree murder charges and sentenced to at least 56 years in prison; which is added onto the 60 years that he already has for seperate weapon charges! Kayla Montgomery on the other hand was only sentenced to 18 months for perjury in front of a court; when she lied about her whereabouts and not knowing where Harmony was. But, she was granted parole in March, days before Adam was scheduled to be sentenced. She was ordered to complete mandatory prison programs, have an approved home plan, and will be under intense supervision for several months. She was not charged in connection with the part she had in the years after HArmony's death because she was the number one witness and story against Adam in court.

Judge Amy Messer of the Hillsbourough County Superior Court told Adam when he was being read his verdict, "You treated Harmony in the worst possible ways, in both her life and her death." I think that this is perfectly put, and I would say the same to Kayla. Even though Kayla might not have physically killed Harmony; she still killed her when she did nothing to help her

survive when she was still living. This case was a hard one to not only research, but share with you guys. The reason I chose this case besides the fact that it is particularly close to home, is because Harmony Montgomery, her mother Crystal and all of her loved ones deserve to get the closure of bringing her home. In my opinion, Adam should never be released from jail; but he sure as hell should not be even looked at untill he can bring that closure to the family, its the least he can do. I am going to do my best to find some resources where we as a team can do our part and try and bring Harmony home; and I will link them in the description of this video.
