

Entering (and Exiting) Crisis Mode with the Help of NMCRS

Jack Higgins joined the Navy when he was only 16, during WWII. Jack was from a rural area in Western North Carolina and joining the Navy provided him with opportunity and security he likely would not have otherwise had. Jack married his sweetheart, Robbie, and in 1956, their son, Craig was born.

In 1958, the Higgins family was stationed in Long Beach, California. While Robbie and Craig were home, Jack was on a "no-contact" mission in the South Pacific. Robbie unfortunately received a call that put her in crisis mode.

She spoke with a funeral director in Burnsville, North Carolina who told her that her father-in-law, Zebulon Higgins, had passed away. How would she tell her husband? What if the Navy couldn't reach him? What would she do?

Unsuccessful at reaching Jack, Robbie had no idea what to do – she only knew that someone had to be in North Carolina to represent

the family. But going with her two-year-old seemed impossible.

Robbie was working at the commissary on base when one of the ladies who worked there recommended that she reach out to the Navy Relief Society Office and share her predicament.

"Mom went down there, and the Relief Society basically took over her plight," Craig said. "They would continue to lobby the Navy to get ahold of my Dad – and they did, but he could not get back. Navy Relief then lined up a flight for Mom – can you imagine what flights were like in the 50s?"

Craig continued to share that the Society paid for his Mom's flight to North Carolina and back, but his Mom was still distraught because she had no idea who would watch her son.

Well, an acquaintance of Robbie's took care of Craig and the Society arranged for the Red Cross to contact Robbie's friend every morning to get an update on Craig and figured out how to call Robbie in North Carolina to let her know how he was doing while she was away.

"Her father-in-law died, she had a young son, and her husband was somewhere in the South Pacific," Craig said. "Mom always said she didn't know how she would have gotten through that crisis in her young life without the Navy Relief Society."

Jack retired from the Navy after 20 years of service, and the family settled in Tennessee. Although they never had a lot of extra money, when they had even \$5, Robbie would send a donation to Navy-Marine Corps Relief Society because of the impact they made on her.

As Craig grew up, his mother would tell him and his younger brother, that if they had any extra money, "send these people some money. They helped me and your Dad a long time ago," Craig said.

And he always did.

"Here's the kicker," Craig said. "As you get older and come Christmastime, you get to the point where you can't get your parents anything because they have everything they need. So, whatever we would have spent on a present, we sent it to Navy-Marine Corps Relief Society. My brother and I have been doing that for decades and always sent a notification to our parents that a donation was made in their honor."
