### Bausch and Lombs issues voluntary recall of ReNu with MoistureLoc products

Customers using ReNu with MoistureLoc immediately.

Bausch and Lomb has voluntarily issued a recall and ceased production and shipping of all ReNu with MoistureLoc products after the Food and Drug Administration (FDA) and Centers for Disease Control (CDC) and Prevention alerted company officials that products containing ReNu with MoistureLoc were linked to Fusarium keratitis infections.

Customers should stop using the product immediately and monitor for symptoms of Fusarium keratitis, which include eye pain, eye redness, blurred vision, sensitivity to light, excessive tearing and eye discharge. If you experience any of these symptoms, contact your optometrist immediately.

Bausch + Lomb is complying and working closely with the FDA and CDC for further guidance and assistance. The FDA and CDC are providing invaluable resources and knowledge as we navigate this situation. We are confident this collaborative effort will facilitate an efficient and transparent investigation.

Bausch + Lomb is committed to consumer safety and production of ReNu with MoistureLoc will be halted until a through investigation has been completed.

### **Background**

- November 2005, the first reports of Fusarium keratitis being linked to Renu with MoistureLoc occurred in Singapore and Hong Kong.
- In the early months of 2006, similar cases were reported in the United States.
- April 10th, 2006 the FDA and CDC issued a warning regarding the possible link between Fusarium keratitis and ReNu with MoistureLoc.
- April 10th, 2006 Bausch and Lomb issues a voluntary recall and ceases production and shipping of all ReNu with MoistureLoc products.

## **FAQs**

## 1. What is Fusarium keratitis, and why is it a concern?

a. Fusarium keratitis is a rare but severe fungal infection of the cornea- the transparent front part of the eye. It can cause intense pain, redness, blurred vision, and potentially lead to blindness. If not treated promptly, it can rapidly progress and cause permanent vision damage or loss.

#### Has Bausch and Lomb issued a recall for ReNu with MoistureLoc?

a. Out of an abundance of caution, Bausch and Lomb have issued a voluntary recall of all ReNu with MoistureLoc products and have discontinued worldwide distribution of the ReNu with MoistureLoc until a through investigation has been completed..

## 3. What actions are being taken by the Food and Drug Administration and Centers for Disease Control and Prevention?

a. Bausch and Lomb is fully cooperating with the FDA and CDC to actively investigating Fusarium keratitis outbreaks linked to ReNu with MoistureLoc. They have issued public health notifications, provided guidance to healthcare providers, and are working closely with Bausch & Lomb to determine the cause and scope of the infections.

### 4. Are other Bausch and Lomb products affected?

a. No, Fusarium keratitis appears to be specifically associated with the ReNu with MoistureLoc product formulation. All other products have passed safety testing and can continue to be used as directed.

## 5. What are the symptoms of Fusarium keratitis, and how is it diagnosed?

a. Key symptoms include eye pain, redness, blurred vision, sensitivity to light, excessive tearing, and discharge from the eye. It is diagnosed through a clinical eye examination by an ophthalmologist, who may also take samples for laboratory testing to confirm the Fusarium fungal infection.

## 6. How widespread is the Fusarium keratitis outbreak, and who is most at risk?

a. The CDC reported approximately 180 confirmed cases of Fusarium keratitis across 35 states. These cases primarily affected soft contact lens wearers who used the ReNu with MoistureLoc solution.

## 7. What precautions can consumers take to protect themselves from Fusarium keratitis?

a. Consumers should stop using ReNu with MoistureLoc immediately and consult an eye care professional if they experience any symptoms. Proper contact lens hygiene, including using fresh disinfecting solution each time and replacing lenses as recommended, can help prevent infections. Users should see an ophthalmologist immediately with any concerns.

## 8. What steps would you recommend for individuals to take if they believe they have been affected by Fusarium keratitis?

a. If you experience eye pain, redness, blurred vision, or other symptoms, remove your contact lenses immediately and seek medical attention from an ophthalmologist or emergency room. Early diagnosis and treatment with antifungal medications are crucial to prevent permanent vision damage from Fusarium keratitis. Delaying treatment can lead to serious complications.
