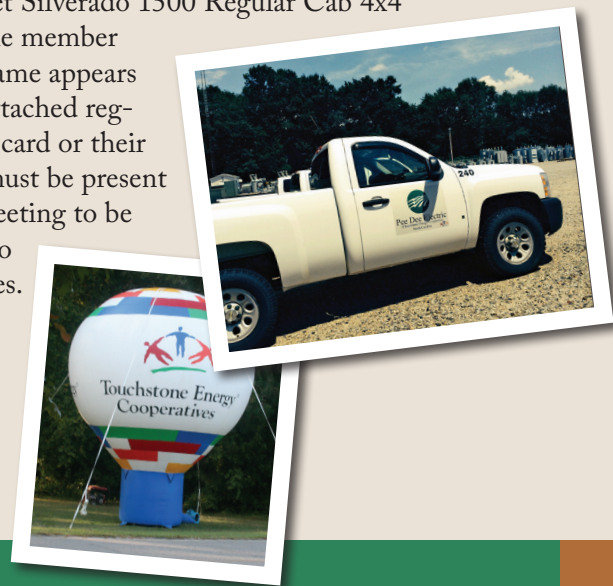

Prizes and Attractions

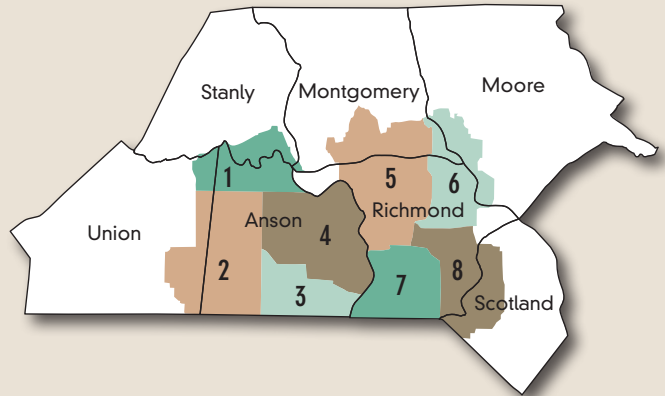
