Three generations stay the fastening course

n 1948, shortly after the end of World War II, Robert Hartman began selling stapling equipment to construction, industrial and manufacturing markets from his garage in Bethel Park.

The timing was right for such a company: The onset of a postwar construction boom quickly encouraged the family-owned business to expand its services.

The business evolved into Hartman Independent Co., a provider of fastening and packaging solutions that's now headquartered in Canonsburg and employs 33.

Robert Hartman ran the business from his garage, then from an office on the North Side, until 1981, when he passed leadership on to his son, Allen Hartman.

In 2016, the reigns of the company were passed on to the third generation, Allen's son Andrew

intended to join the family business. Admiring James Herriot, who published the book "All Creatures Great and Small," he hoped to become a veterinarian. He pursued a premedical degree at Washington & Jefferson College until he believed God clarified that wasn't the path he should take, and he then sought a business degree

Hartman began his new pursuit with an open mind, so when his father Allen suggested he apply to an opening at

the warehouse, he did so, starting out working for the company part-time in 1994 fixing nail guns. He joined the company full-time after graduating from college in 2002.

According to Andrew Hartman, the primary reason the business has been successful has been its dedication to its customers.

Hartman makes sure the company receives feedback from customers and continues to improve.

"I walk away with not only what I can do, but also [gain] perspective of the economy, the challenges we all face and the opportunities," he said.

Excellence has become intrinsic to the company. Through a dedication to faith and service. Hartman formed its first written vision statement in 2018: "we are striving for nothing less than excellence in all

Under the Hartmans' leadership, the company recently acquired the assets of Chambers Packaging Connection, a packaging supply company.

That purchase allowed the company to expand its product line, according to Hartman.
