NATIONAL HIGH SCHOOL

Indiana has secured the bid to host the National High School Mock Trial Championship in May 2020. This is Indiana's opportunity to showcase the state and its outstanding high school mock trial program. Hosting this national championship will secure Indiana's leadership in civic education nationwide. Mock trial educates youth on the legal system, particularly trial procedures, and highlights for them a fundamental tenet of the American justice system.

#### **High School Mock Trial: the Best and the Brightest**

Through the interactive High School Mock Trial competition (Mock Trial), students learn the important role of the American judicial system and the rule of law in democratic society. They engage in simulated civil or criminal trials and compete against teams from across the U.S., South Korea, Guam, U.S. Virgin Islands and the Northern Mariana Islands. Guided by teachers, student teams practice for the academic competition by studying a fictitious case and take specific roles such as attorney, witness or defendant. Each team represents both defense and prosecution in alternating trials. Volunteer attorneys and judges evaluate their skills.

Mock Trial builds critical thinking, team work, public speaking and poise under pressure — exactly the soft skills needed in today's workplace. Mock trial students are mastering them in high school.



#### **Building Confidence, Professionalism**

"As a lawyer, the job is to know what one is talking about. Lawyers must also be able to maintain their composure throughout frustrating objections and crosses from the opposing counsel. As a witness the job is to make the testimony more believable than the other team's. It would be impossible to do so if, as a witness, someone sounded like they had no idea what they were talking about or if they seemed juvenile. No matter what, no matter how frustrating it can be, no matter how well or how poorly it is going, professionalism must be maintained."

#### **Indiana's National Prominence in Civics**

Hosting the national competition in Southern Indiana's largest city brings a national audience to Evansville with more than 900 students, coaches, teachers, parents and attorneys attending the event. It introduces southern Indiana schools to Indiana's high school mock trial program.

As many has 100 trials will occur during the competition, primarily on just two days of the event. The final trial between the top two teams will occur in the Randall T. Shepard Courtroom at the Old Courthouse in downtown Evansville.
