No timetable for end to fire at Texas chemical facility

Officials said Tuesday that they're not sure when a two-day-old fire at a Houston-area petrochemicals storage facility will burn itself out, but they are confident that the air quality is safe, despite the huge plume of smoke coming from the blaze.

Harris County Judge Lina Hidalgo said at a news conference that monitors show the levels of contaminants in the air are safe and that the plume coming from the site in Deer Park, southeast of Houston, is reaching at least 4,000 feet (1219 meters) up and staying high enough so that the air quality at ground level is safe.

"It's understandable why people would be scared," said Hidalgo, the county's top administrator. "We're sharing information with the public so that everybody knows what we know, what we're doing and where we're headed."

The plume could carry particulates as high as 6,200 feet, officials said, but fog is forecast for the area Wednesday morning that could drag the

plume downward, making the air quality more hazardous.

"We're prepared for any contingency," Hidalgo said.

The fire that began Sunday at the Intercontinental Terminals Company and remained intense enough Tuesday to create its own micro weather system, causing shifting winds in the area, officials said.

The head of the county's health department, Dr. Umair Shah, said "there continues to be low risk to our commu-

nity," but vulnerable groups such as the elderly and pregnant women should be cau-

The company said Tuesday that five petrochemical tanks at the site were still burning, three others that had been on fire had burned out and two tanks that didn't have anything in them had collapsed.

Firefighters are using water and foam to try to prevent the blaze from spreading to five other tanks. A drop in water pressure allowed the fire to intensify overnight and spread to two additional tanks, but the pressure later normalized, authorities said.

The tanks contain compo-

nents of gasoline and materials used in nail polish remover, glues and paint thinner.

Officials previously said the fire could have burned itself out by Wednesday, but they scrapped that timetable on Tuesday.

ITC spokeswoman Alice Richardson said the company was "working our hardest to get this current incident under control."

"Of course ITC is very sorry. ... This isn't an event we wanted," a teary-eyed Richardson said during a news conference Tuesday.

The school districts in Deer Park and in nearby La Porte canceled classes on Monday but reopened Tuesday, albeit with restrictions on outdoor activities.



Lance Bass dives deep in 90's boy-band scam

AUSTIN, Texas — If you have heard about Lou Pearlman, you may become aware of his history. Otherwise, you are in for a heck of a ride.

If you were a 90's girl like myself, I'm sure you remember those days when two of the biggest boy bands took over the world, and your bedroom walls. Backstreet Boys and *NSYNC were rival groups back in the day, however, no fan knew about what was happening behind the number one hits or the sold-out concerts.

After his time at *NSYNC, Lance Bass became a filmmaker and producer.

His first-ever film, "The Boy Band Con: The Lou Pearlman Story" made its debut at SXSW 2019 in Austin. Filmmakers Matthew Duncy and Aaron Kunkel, *NSYNC's Joey Fatone, as well as Lance's mother, Debra Bass, were present at the premiere.

"The Boy Band Con" goes into the life and death of former manager Lou Pearlman, from his obsession to airplanes and managing his paper route as a kid growing up in Queens, to discovering bands such as *NSYNC and Backstreet Boys, to his death in 2016 while in prison. Filmmakers Bass and Kunkel also uncovered answers on why he created a Ponzi scheme that affected not only the bands he formed, but also the dedicated investors to his companies.

O-Town's Ashley Parker Angel, Backstreet Boys' A.J. McLean, Justin Timberlake's mother, Lynn Harless, and two of *NSYNC's bandmates, JC Chasez and Chris Kirkpatrick, among many others spoke out during the film.

Told by the artists themselves, they recount the time they met with Pearlman, and the time they were recruited and signed by the record label Pearlman was running, and the scam they fell into while recording for the now-defunct TransContinental Records.

If you lived throughout the TRL days, the number one hits, when *NSYNC took the world by storm after Backstreet Boys backed out on a big show on the Disney Channel that sparked their rivalry, it will surely give you some nostalgia. But at

the same time, learning more about Pearlman might give you some chills down your spine.

Living through the boy-band craze as a young girl, I was clueless on what was happening when I first heard of both the Backstreet Boys and *NSYNC.

If you loved Aaron Carter's music when you were a kid, you will be stunned by his remarks;

as he comes out as a counter-reaction to the film's events. He looked very different as a grown man.

During the prologue of the world premiere, not many of the audience knew who Lou Pearlman was, until his arrest in 2007. Afterwards, the film crew were given a standing ovation.

You may find yourself in the mood to listen to the bands' music after the movie, while some of you might not listen to them the same way you used to when you were a kid growing up. The Boy Band Con will change your mentality, and will leave you with a sense of "wow-ness".

The film is set to premiere on YouTube Premium on April 3.

Kathy Griffin tells her side of the story in exclusive comedy special

The phoenix rises once more. So what has Kathy Griffin been up to since her career crumbled in May 2017?

The 58-year-old comedian funded her own comedy special, from the film crew to the posters, filming at a fairly small venue in Santa Monica, CA. She wanted to tell her audience what really happened in her version of the story since the photo of Donald Trump's [fake] severed head. That image alone made U.S. history as a way to take down an American citizen from the highest levels of government.

Even the big names in streaming, such as Netflix and Hulu, gave her the big fat N-O to streaming her new special. Then the death threats came after. Griffin was more than happy to read some of them that made her laugh (and probably cry).

Griffin takes us behind the scenes in the beginning, where she prepares for her photo shoot, not knowing the fact that it would take the world by storm. Her photographer, Tyler Shields called President Trump the "social media president".

The humor in her new special might not be for everyone. If you aren't into dirty political humor where Griffin pokes fun at The White House, then it's best to steer clear. However, loyal fans would enjoy it from start to finish.

But one thing the audience noticed, was the blue 50s dress she wore; it was the same one she wore when the photo went viral. Griffin felt proud of wearing it again, as it "symbolized a light of hope".

During both of her showings at SXSW, she gave away merchandise to her audience as part of her "apology" to the public. Most of which were exclusive from her previous World Tour, such as t-shirts, buttons and "Impeach Brett" mugs (in reference to U.S. Supreme Court Justice Brett Kavanaugh).

Basically, Griffin's special was more trash-talk towards President Trump. Although she wanted to make things perfectly clear (and she did during her premiere) that she was "exercising her First Amendment right." If only the big stream companies would give her just one chance to share her side of the story, the public, and Hollywood, would finally forgive her.

Startups shine bright at SXSW Trade Show

One of the highlights that SXSW had to offer was the Startup Pavillion, featured at the Trade Show.

Each Startup had a story to tell, from how they came up with their invention or product, to promoting their company altogether. Some are currently in beta mode, or work in progress, while others are already available to the public. From tech gadgets that may change the face of VR gaming, to buying beer from a vending machine, to brand new health innovations that may make physical therapy much easier than before.

Highlights:

BeBop Sensors started off four years ago in California. Having started as simply a VR/ AR simulator, the developers then realized that these "sensor gloves", activated using sensor subsystems and blockchain, can be beneficial to the medical and technology fields. The company spokeperson says that the sensors will be compatible to current and future VR games on Steam. They look forward to have the product on sale within later this year.

Orig3n is a genetic testing kit that works differently compared to other DNA testing kits such as 23andme and Ancestry. Orig3n tests your DNA on a variety of different levels. Need to know what your perfect workout is all about? What about your ideal wellness plan? Maybe your behavior? There is a DNA kit just for that. You use a cotton swab to gather a sample of your DNA, and you should get your results within two to four weeks, two weeks less than the leading DNA test.

Lovot, the cute and cuddly puppy-like robot that made its debut at CES this year also shined bright at the SXSW Trade Show. The robot works differently like other standard robots that obey your commands whenever you say it. Lovot actually begs for your attention. Basically, like Amazon's Alexa, with an actual robot body. You need a hug after a long day of work? Lovot will give it to you. Want Lovot to do a trick, it'll do so. You don't

need to give it treats. This robot works great with kids, but for adults? Of course.

Want to try sushi but cannot due to food allergies? Sushi Singularity is there to rescue you! They are a startup sushi company that makes customized sushi based on your likes, dislikes, and food allergies. Customers take an online survey as part of their reservation. For example, if you have a shellfish allergy, the chefs will make aware of it,

and will use a food printer to create a non-shellfish-made sushi just for you. Their first restaurant is set to make a trial run in Tokyo in the year 2020, with plans to expand outside Japan later on in the decade.

Goodbye console? Google launches game-streaming platform

NEW YORK — Google on Tuesday unveiled a video-game streaming platform called Stadia, positioning itself to take on the traditional video-game business.

The platform will store a game-playing session in the cloud and lets players jump across devices operating on Google's Chrome browser and Chrome OS, such as Pixel phones and Chromebooks.

Google didn't say how much its new service will cost, whether it will offer subscriptions or other options, or what games will be available at launch -all key elements to the success of a new video-game platform. It said only that Stadia will be available in late 2019.

Google made the announcement at the Game Developers Conference in San Francisco. Some industry watchers were expecting a streaming console, but Google's platform centers squarely on the company's cloud infrastructure.

"The new generation of gaming is not a box," said Google Vice President Phil Harrison. "The data center is your platform."

Much like movies and music, the traditional video-game industry has been shifting from physical hardware and games to digital downloads and streaming. Video-game streaming typically requires a strong connection and more computing power than simply streaming video, since there is real-time interaction between player and game. Google says it is leveraging its data centers to power the system.

Alphabet Inc.'s Google said playing video games will be as simple as pressing a "Play Now" button, with nothing to download or install. An optional dedicated Stadia controller will be available. The WiFi-enabled controller has a button that lets players launch a microphone and use Google Assistant to ask questions about

the games being played. Another button lets users share gameplay directly to Google's video streaming service, YouTube.

Harrison said he expects all gaming will eventually take place outside consoles, in cloud-powered streaming platforms similar to what Google announced. But not

"It won't replace traditional games devices overnight," he said in an interview after the announcement. "And we wouldn't be here if not for the existing traditional platforms."

CFRA Research analyst Scott Kessler said Google's approach that ties YouTube sharing and video-game playing is unique.

"It is not necessarily at this point the easiest thing for people to livestream their games and now you can do it with the push of a button," he said. "What they've done with Stadia is to connect and unify both the gaming platform and the streaming platform which obviously is new."

The company said Stadia will be available in late 2019 in the U.S., Canada, the U.K. and parts of Europe. Google showed demos of "Assassin's Creed Odyssey" and "Doom Eternal." More information about games and pricing is due this summer.

The U.S. video game industry raked in revenue of \$43.4 billion in 2018, up 18 percent from 2017, according to research firm NPD Group.

BTIG Managing Director Brandon Ross said Stadia will be a positive for game publishers "assuming that it works and works at scale, which is a big assumption."

That's because the platform could bring in players not willing to spend the money upfront for a gaming PC or a console.

"What they're presenting is a feasible way to play videogames in the cloud, and utilizing the cloud so you can play anytime, anyplace and anywhere," he said. "There's no friction, including the friction of upfront hardware costs."

Ross added that Google's platform could set up a distribution battle between Microsoft, which owns the Xbox, Sony, which owns the PlayStation, Google and perhaps Amazon, which reportedly is working on its own video-game service, as they race to lock down distribution of the most in-demand games.

To that end, Google launched Stadia Games and Entertainment which will develop Stadia-exclusive games.

"The differentiator for any of the distributors on a console or in the cloud is going to be available content," he said.

Harrison said Google will rely on outside publishers and game developers to provide many of the games available on the platform. But having its own inside studio will also allow the company to fully test and make use of new features.

"We can be the advance party, so to speak, and we can be testing out the latest technology," he said. "Once we've proven it we can help bring that up to speed on the platform even more quickly with our third-party partners."

Harrison acknowledged Google faces stiff competition from longtime rivals Microsoft, Sony and others. Google has been working on Stadia for more than four years, he said, and has been working with game developers through Android and Play Store for longer.

The others have more than a decade of experience. But Google believes it brings something new.

Browns trade for OBJ

NFL wide receiver Odell Beckham Jr. will be joining the Cleveland Browns after the New York Giants traded him for the Browns' first- and third-round draft picks in the 2019 Draft, along with Browns safety Jabrill Peppers. This is a big-time win for the Browns as they are getting one of NFL's elite. Beckham brings with him 5,476 receiving yards and 44 receiving touchdowns. Beckham as of late has been running into contract problems with the Giants, so this trade would be a breath of fresh air for the player.

The Browns will not be pushovers the upcoming 2019 season which also marks the NFL's 100th season. The Browns were not only labeled the worst team in the NFL, but they were a laughing stock. But with 2018 first-round draft pick quarterback Baker Mayfield and newly acquired wide receiver Odell Beckham they magically turn into Super Bowl contenders. The Browns had a losing streak that dated back to the 2016 season, but Baker Mayfield helped change that

as he led the Browns to a home win against the New York Jets in the 2018 season, their losing streak up to that point was 635 days. During that time Head Coach Hue Jackson was sacked and Browns appointed their Defensive Coordinator Gregg Williams as interim head coach. On the ninth of January 2019, Browns interim offensive coordinator Freddie Kitchens was promoted to head coach. Kitchens brings with him 11 years of tight end, and quarterback coaching experience from the Arizona Cardinals.

The Browns came out of this deal the clear winners, not only did they sign a high caliber wide receiver in Odell Beckham, but they also have Jarvis Landry who is an instant link with him as they both played at LSU and a quarterback who can throw in the shape of Baker Mayfield. They are arguably the best team in the AFC North now, with the Steelers recently losing star wide receiver Antonio Brown, the Bengals (still) only have Andy Dalton and A.J. Green, and the Ravens lost C.J. Mosley. The Browns will surely land the top spot in the AFC North. Fantasy players beware, Beckham, Landry, and Mayfield might rack up serious points.

The New York Giants were once Giants, but it seems quarterback Eli Manning is past his prime. Having already placed fourth in the NFC East and a record of five wins 11 losses

in the 2018 season, their stock dropped significantly after this trade and seem the losers in this deal. The Giants who won the Super Bowl in 2008 and 2012 is no more. They now have two first round draft picks, which based on multiple mock drafts the Giants will use at least use one of those picks to draft a defender, something that has been severely lacking for the Giants in 2018. With 38-year-old Eli Manning not getting any younger, it would only make sense to draft a new quarterback this or next year's NFL draft. Manning would still leave behind a legacy that won the Giants two Super Bowls in 2008 and 2012, both of which were against Tom Brady and the Patriots.

James passes Jordan on NBA scoring list

The accolades continue to pile up for Lebron James. The King has moved passed Michael Jordan into the fourth place on the NBA's All-Time Scoring list. James scored his 32,293rd point on a lay-up, in the second quarter against the Denver Nuggets. Relishing the moment, Lebron put his jersey up to his face, walked off to the sideline, and became understandably emotional.

The kid from Ohio, who grew up with a single mother, outscored his childhood hero Michael Jordan. So, who is the greatest of all-time? Honestly, only time will tell. What we do know is that over the last 50 years a little over 3,000 players have entered the league and out of that number King James has become the Fourth all-time scorer.

Karl 'the Mail Man' Malone sits at the number two spot on the list with 36,928 points scored in his career.

At the number three spot sits 'The Black Mamba', Kobe Bryant, who has 33,643 points in an outstanding career with the Lakers. James heads in at number four with Jordan moving down to the fifth spot.

The Federalist president

ometimes, and it is happening with increasing frequency, I find that the average citizen possesses a profound lack of understanding regarding the most basic precepts of American democracy. Part of the blame rests in our education system. For generations we have passed on a revisionist history that, although false, is more widely accepted than the truth.

A standard textbook teaches that in Colonial and Early American times only white men of property could vote. While false students must learn this as fact to past the course and pass the course to earn a degree. Acceptance of lies as acceptable alternative facts is the path to advancement. This perversion has led to our current state of free fall corruption.

I have heard endless debates regarding the intent of one passage or another in the Constitution. In most cases those issues could be easily resolved by reading the Federalist Papers. The Federalist Papers are a series of 85 essays written by Alexander Hamilton, John Jay, and James Madison between October 1787 and May 1788 and published in newspapers under the name "Publius."

The intent was to explain particular provisions of the Constitution in detail with the aim of convincing New Yorkers to ratify the proposed United States Constitution. They have since been compiled in several editions, one of which is available on the Congress.gov website, another in the Gutenberg.org site. They are not hard to find, any Google or Bing

search will turn up a plethora of sites that offer full text versions of the Federalist Papers.

Now if anyone wants to hear the facts about the powers and responsibilities of the Presidency, before they go spouting impassioned opinions here is what Madison had to say in Federalist No. 69 as he compares the American President to the King of England:

"The President of the United States would be an officer elected by the people for four years; the king of Great Britain is a perpetual and hereditary prince. The one would be amenable to personal punishment and disgrace; the person of the other is sacred and inviolable. The one would have a qualified negative upon the acts of the legislative body; the other has an absolute negative. The one would have a right to command the military and naval forces of the nation; the other, in addition to this right, possesses that of declaring war, and of raising and regulating fleets and armies by his own authority. The one would have a concurrent power with a branch of the legislature in the formation of treaties; the other is the sole possessor of the power of making treaties. The one would have a like concurrent authority in appointing to offices; the other is the sole author of all appointments. The one can confer no privileges whatever; the other can make denizens of aliens, noblemen of commoners; can erect corporations with all the rights incident to corporate bodies. The one can prescribe no rules concerning the commerce or currency of the nation; the other is in several respects the arbiter of commerce, and

in this capacity can establish markets and fairs, can regulate weights and measures, can lay embargoes for a limited time, can coin money, can authorize or prohibit the circulation of foreign coin. The one has no particle of spiritual jurisdiction; the other is the supreme head and governor of the national church! What answer shall we give to those who would persuade us that things so unlike resemble each other? The same that ought to be given to those who tell us that a government, the whole power of which would be in the hands of the elective and periodical servants of the people, is an aristocracy, a monarchy, and a despotism."

Now this makes it clear that the President is not above the law. That he does not have the right to unilaterally declare war. That he must work with the Legislature to make treaties and appointments to offices. That he can make no rules concerning commerce or currency and does not have the King's ability to lay embargos, coin money or establish markets. It explicitly states that the President "has no particle of spiritual jurisdiction." This was Madison's summary of the powers of a periodical and elective servant of the people.

If we are to remain true to the spirit of the Constitution, and not just interpret its words to suit our intent, we must take the time to learn the intent behind its construction. It is not hard to find, nor is it an exceptionally long read. Unfortunately most of us are better informed of the governance issues in Westeros than in the foundations of the U.S. Government.

Happy birthday, World Wide Web

The World Wide Web turned 30 last week, marking the anniversary with a conference that took a long look at the good and bad wrought by a technological breakthrough that has transformed virtually every aspect of life today. Yet, despite the advances, the creator of the web says it has morphed well beyond its original intent as a place for bright minds to collaborate on meaningful projects.

In too many cases, the web has become an unregulated incubator for hate speech, a safe haven for corporate giants to abuse personal privacy and a malleable platform for state-sanctioned election mischief and government (foreign and domestic) snooping. There is also the matter of web access. Half of the world is online; half is struggling to get

In the news in just the past few days are stories about how the dark side of The internet may have influenced the hate-filled world of the alleged shooter in the New Zealand mass shooting tragedy. Entire sections of

the web are devoted to hatred, fear-mongering and divisiveness.

No wonder web founder Tim Berners-Lee summed it up like this: "Whoops! The web is not the web we wanted in every respect."

The problem is the web has grown so rapidly and so unwieldy that attempts to rein it in will either compromise basic freedoms or provoke widespread government intrusion. Despite what appears to be a rock and a hard place future, Berners-Lee through his World Wide Web Foundation has developed a "Contract for the web," meant to bring people, countries and governments together and reimagine the web in its original, undistorted image.

"The Contract for the web is about sitting down in working groups with other people who signed up, and to say, 'OK, let's work out what this really means," Berners-Lee said in our story about the 30th anniversary last

The challenge, though, is where to draw the lines and how to balance these altruistic expectations against a world where the genie has been out of the bottle for almost three decades. "Where is the balance between leaving the tech companies to do the right thing and regulating them?" he asked. "Where is the balance between freedom of speech and hate speech?"

The conversation has to start somewhere, though, if the idyllic outcome of a web "better for humanity" is to be realized. That means getting governments, companies and individuals together to reshape the web around basic fundamentals, our story said. For example, governments should make sure everyone has continuous access to the web while respecting the privacy of all citizens.

Companies are challenged to make The internet affordable and also respect the privacy of users with the noble goal of putting the "public good" first. Finally, people who use The internet should be online to "create and cooperate" while respecting civil discourse. There is no doubt the World Wide Web has made many aspects of life better. People are more connected than ever before. People around the world can order goods and services from around the world with ease.

From a First-Timer: How to Survive SXSW

AUSTIN, Texas — Welcome to Austin, the official home of SXSW; bringing you multiple conferences, festivals, and parties all over Downtown. For a first-time attendee, it may be a lot to take in. You won't know what to do, or where to start. You kept hearing rumors that there's free food, or open bars with no badge required. In my three days attending SXSW, I have learned so much that it's worth sharing my experience.

First of all, ask yourself: why do you want to attend SXSW? Is it for the networking opportunity? Maybe you want to catch a few movies that have yet to debut to the public? Or maybe you'd like to discover new and upcoming music artists. There's a lot to do in SXSW, and even if you are there for the whole time, you may not be able to do everything.

SXSW has four types of badges: Interactive, Film, Music, and Platinum. The Platinum badge gives you primary access to everything that SXSW has to offer. These four badges are sold at a high price (they started at \$825 and go way up to at least \$1,300).

When purchasing a badge, which gives you access to assigned areas of the festival, you need to choose a track. Currently there are three main tracks: Interactive, Film, and Music. The three main tracks also have secondary tracks that fall under them. For example, Interactive gives you primary access to all marketing, blockchain, and technology tracks. Film gives you access to journalism, filmmaking, and television tracks, as well as the film festival. Music gives you access to the music festival, and the music business tracks.

Don't worry, there's also wristbands and single-day passes for all tracks, including SXSW Gaming which is usually held on the final days. However, they are only sold in person.

No money for a badge or a wristband? No big deal. You can get a free Guest Pass. However, keep in mind that you might not be invited to some of the parties, or have access to certain areas of the show.

And speaking of parties, Downtown Austin is lit with the swankiest parties around town. Most of the streets had to be shut down due to the increased crowds. If you purchase a badge or a wristband, you may get priority (or even VIP) access to parties; with open bar and free food and swag. You just have to look in vour email.

That's some of the things I've learned so far while I was in Austin. Because it was my first time, I had to go on a super-tight budget.

• Plan your schedule CAREFULLY. Download the SXSW app. There are hundreds of events going on at the same time. You may want to go see that cool movie about a journalist battling cancer but it's on the same time as a panel about how to make a film under \$500, hosted by famous filmmaker Quentin Taratino. You have to make some sacrifices. Have the SXSW GO app handy for notifications on what events are coming up.

In addition, plan for backup. SXSW announced a Red-Yellow-Green system where they tell you in real time if a panel room is getting full. Did that Quentin Tarantino panel reach capacity and won't take any more people? Might as well watch that Journalist movie. Check your schedule for any other backup panels for you to attend.

- **Apply for SXXpress.** Let's face it. You REALLY want to go to that Taratino panel badly. Luckily, there's SXXpress (South By Express) passes. Similar to Disney's Fast Pass at their theme parks, SXXpress passes gives you priority access to the panels or movies you want to see, giving you first dibs on the seats you want 30 minutes prior to the start of the panel or movie. Be sure to have it with you when you enter the panel room.
- Try to memorize your layout of Downtown Austin. This is something I didn't think through. Google Maps is your friend when it comes to navigating through downtown. Be aware that NOT ALL events are held at the convention center. Most are held at other venues such as the JW Marriot, the Hilton, even at theatres such as the Stateside and the Paramount. Thankfully, SXSW provides a free shuttle to all attendees, and there's scooters all over, with most of them charging 15 cents a minute.
- Leave your car at home and skip Uber. Austin's public transportation is amazing and affordable. Save some money on gas and Uber-ing and catch a bus or train. It's \$1.25 for a one-way bus trip, \$3.50

for a train ride, and \$7.00 for a day pass that allows you to freely jump on any route for the whole day.

- Follow @thefreenoms on Twitter. You will thank me later. The person behind @thefreenoms account is a godsend. He will give you upto-date information on where the free food and drinks are, how to RSVP if needed, and he will also tell you how long the lines are. If you are tight on money and want to take advantage of the giveaways, @ thefreenoms will hook you up.
- · Most of all, stay weird. Austin is known for being

weird. Don't worry about dressing to impress (unless your goal is to network with others). Just dress your best, wear some sunscreen, pack a sweater (because you know, Texas weather.) and have a great time.

The biggest thing I've learned about SXSW as a first timer, is that it's all about discovery. I kept thinking that SXSW would be the San Diego Comic Con of Texas, but it was nothing compared to this. You will meet new friends, discover new and amazing things, and have a blast.
