- Quality of life:

 - Continue to help parents navigate a still woefully inadequate special education system so students get the help they are entitled to and need to succeed in school.
- Employment:
 - Championed the rights of people with IDD to be free from discrimination in employment and to receive basic subsistence income payments.
 - Guide teens and adults in finding and keeping jobs, and work with employers to help them see the business advantages of hiring people with disabilities.
- Healthcare:
 - Guaranteed that coverage can't be denied to people with disabilities with passage of the Affordable Care Act, and successfully advocated for extension of long-term

services under Medicaid to support people with IDD to live, work and participate in their communities.

After decades of relentless work, we are closer to realizing our vision than ever before. But as it has been in the past, Medicaid remains vulnerable to budget cuts, and strongly needed increases and allocations specifically in the HCBS arena are far from guaranteed.

As Congress continues to deliberate over current and future funding for Medicaid and the type of significant financial boost the IDD community needs for its HCBS providers, The Arc is ready to meet this opportunity with the full force of our advocacy. Will you be a part of this moment with us? Together, we have succeeded in significantly improving opportunities and quality of life for members of the IDD community and their families. But much more progress and action are needed.

We believe in a future where people with disabilities have the support systems they need to feel valued and included, and to independently participate in their communities in ways that are meaningful to them. The lack of appreciation for the human dignity of people with IDD, and lack of understanding for the day-to-day challenges that they and their family members face, are impeding progress and limiting opportunities for people with IDD. Increasing Congressional funding and allocating resources and support for HCSB represents a significant step in the right direction.

It's time to change the narrative. Will you remain our partners as we continue our advocacy work toward improving the lives of people with IDD and those who provide vital support for them?
