LNG IN BC: UPDATE

We've set a competitive framework to enter the global LNG market and bring new revenues, jobs and economic security to British Columbians - and BC is ready for a strong LNG industry that will deliver for decades to come.

Currently, 19 LNG export proposals are on the table in various stages, and a total of 10 LNG proposals have received export approval by Canada's National Energy Board, with 8 more applications under consideration.
