U.S. 90 WIDENING PROJECT

4 lanes, few solutions

The construction project on U.S. 90 West included the building of a solid median that runs from Southwest Sweetbreeze Drive to Brown Road. According to local merchants, the median has hurt their business. People traveling east toward Interstate 75 and Lake City cannot make a left turn to reach businesses on the westbound side, and people traveling west toward Live Oak can't make a left turn to reach businesses on the eastbound side.

Local merchants: The absence of left-turn lanes is hurting business.

Business owners on U.S. 90 West have complained for years that ongoing construction has hindered commerce and kept customers out of their stores.

Now, other store owners are saying the damage will be permanent because of a concrete median that has cut them off from commuters and customers.

Lifeguard wants rival **EMS firm** disqualified

Company files petition with county in addition to lawsuit in circuit court.

Lifeguard Ambulance Service is taking another shot at securing an Emergency Medical Services contract with the county.

The company filed a petition with the county last week, asking for Jacksonvillebased Century Ambulance, the top choice, to be disqualified.

Lifeguard's formal protest maintains the county doesn't have the authority to begin negotiations with Century because of an ongoing lawsuit it mounted against the county.

Sale prices for homes are still on the rise

Local Realtors: Total dollar volume has also increased.

The Columbia County real estate market continues to improve.

The June 2015 Monthly Market Detail, distributed by the Florida Realtors, showed that despite total closed sales decreasing from 54 to 52, median and average sale prices have both increased.

"The big picture is the total dollar volume is up [11.7 percent] and the median sale price and average sale price [are] up," said Dan Gherna, executive vice president of the Lake City Board of Realtors.

Obama promotes Clinton while Kaine mocks Trump

President, VP nominee join Democrat chorus vouching for former first lady.

PHILADELPHIA — Their political fates now entwined, President Barack Obama is imploring voters to elect Hillary Clinton to the White House, joining a chorus of Democrats vouching Wednesday night for her readiness to be commander-in-chief at time of volatility around the world.

"Even in the middle of crisis, she listens to people and keeps her cool and treats everybody with respect," Obama said in excerpts released ahead of his remarks at the Democratic convention. "And no matter how daunting the odds, no matter how much people try to knock her down, she never, ever quits."

Clinton's running mate, Virginia Sen. Tim Kaine, introduced himself to the nation as

nominee Donald Trump. "Donald Trump has a passion," he said. "It's himself."

"Believe me!" he exclaimed over and over, imitating Trump's tone as he ridiculed a list of the Republican's promises.

"I think [this year] is much better than 2015," Gherna said. "Every year it seems to get a little bit better."

Other positive indicators are a decrease in the median time to contract, which went from 115 days to 82 days; and the median time to sale, which decreased from 156 days to 125 days.

The former is a measure of the median number of days between the listing date and the contract date for closed sales during the month, and the latter is the

In addition, there were only seven distressed properties, including foreclosed homes, and no short sales were made.

of Transportation's widening project on U.S. 90 has been underway for more than three years. Part of that project included construction of medians along the stretch of road between Lake City Avenue and Brown Road.

Southwest Sweetbreeze Drive to Brown Road without any cutouts, blocking direct access to businesses along that stretch.

There are also problems with the construction of the median on Turner Road.

"A convenience store should be convenient, and this is just not convenient," said Aaron Goodman, chief operating officer of Southwest Georgia Oil Co., which owns the S&S food store chain.

In addition to the median making it difficult for customers to enter the S&S store on the corner of U.S. 90 and Turner Road, another median recently constructed on Turner Road prevents departing S&S customers from turning left to get back onto U.S. 90.

Customers trying to leave the S&S must turn right onto Turner Road, then take an immediate left and make a U-turn to get access to U.S. 90. If the traffic is backed up to where the median opens up, customers must drive down Turner Road until they can find an opening to turn back the other way.

According to Goodman, business at the S&S location One median runs from has gone down 35 to 40 percent since the medians have been put in.

> "It really has hurt that store," Goodman said. "It's tough when you're trying to get in and out of there."

When Dr. Peter Giebeig bought the property to open his office in 2004, he says he already knew there would not be a cutout in the proposed median to reach his business, which was the only one there at the time. However, when the Dollar General was built in 2008, the traffic in that area increased significantly.

"We knew we weren't getting a cut in the median, and that was fine because we were the only business over here," Giebeig said. "Dollar General changed that."

According to Giebeig, when he mentioned this issue to the FDOT, they "refused to reconsider" the plans for the median.

"I do not think there's any chance they're going to fix it," Giebeig said. "It's a done deal."

Employees at the Dollar General at 5087 W. U.S. 90, were not permitted to speak to the press on the matter, but business has reportedly been hampered seriously at that location.

store who need to travel east by the median's lack of cutouts is TSC Tractor Supply, located just west of

> Brown Road. According to assistant store manager Mike Rich, the new median in front of the store has "absolutely been an issue."

"We've had customers complain about it," Rich said. "Just getting it opened would be good."

According to FDOT District 2 Public Information Director Tracy Hisler-Pace, the median is placed where it is for safety and is designed to cut down on traffic accidents. Hisler-Pace explained that the lack of cutouts in the median is based on a need to limit U-turns.

"By having it in one place, it cuts down on accidents," Hisler-Pace said. "The bottom line is it's all about safety."

Hisler-Pace says the median will remain without chang-

"Drivers need to be patient and take those few extra seconds or minutes to get where they're going."

According to FDOT public information officer Troy Roberts, the construction project is scheduled to be completed in about a

"We feel comfortable that our argument is factual and objective," said Lifeguard President Brett Jovanovich.

A county EMS committee recommended Century earlier this month, the second time it came in first place.

The first ranking committee chose Century in February, which the county voted to start negotiations with in May. Lifeguard, the runner-up and current EMS provider, protested that decision as well.

On a recommendation from County Attorney Joel Foreman, the county opted to start the bidding process over in June.

The new process didn't address its criticisms of the original, Lifeguard stated, many of which were repeated in the new petition: "It reshuffles points awarded for subjective criteria in favor of Nickerson.

Century's bid."

The lawsuit which prompted the do-over alleged Century was unfairly allowed to modify its bid after it had already been submitted.

According to an email exchange between County Purchasing Director Ray Hill and Century CEO John Glover, Century did not originally include a proposed pricing structure for its ambulance service. That information was later added.

The petition argues the county runs the risk of awarding the contract to Century in August, only to have a circuit court award it to Lifeguard in September.

Foreman declined comment.

Hill wrote a response to the petition, but the Lake City Reporter was unable to acquire a copy before press time. The response is awaiting approval from the county's outside legal counsel, Tallahassee-based law firm Nabors, Giblin &
