Jacksonville Democrat pleads not guilty to multiple federal charges.

JACKSONVILLE — U.S. Rep. Corrine Brown of Florida and her chief of staff pleaded not guilty Friday to multiple fraud charges and other federal offenses

in a grand jury indictment unsealed after an investigation into what prosecutors call a phony charity that turned into a personal slush

'I hope they know we have their back'

Dallas shooting leads to local outpouring of grief and support.

Law enforcement officers and first responders stood in the middle of downtown Lake City on Friday afternoon, the citizens they serve encircling them in a show of love and support.

Dozens of officers, community leaders and residents came together at Olustee Park to mourn the five Dallas officers who lost their lives to a sniper late Thursday.

Sheriff's deputies and citizens wiped away tears as they prayed. Every speaker conveyed the same

Autopsy: Overdose killed local woman

Jessica Buttone's death at RV park was originally considered a homicide.

A woman local police said was murdered at an RV park actually died of a drug overdose, an autopsy report shows.

Jessica Lynn Buttone, 29, was found dead in a pool of blood the morning of June 6 in a camper at the Inn & Out RV Park on 3010 U.S. 90 West. A broken TV and other items surrounded her on the floor.

The Lake City Police Department issued a statement calling the death a murder

The indictment says that Brown, Simmons and Wiley "used the vast majority" of One Door donations for their personal and professional benefit, including tens of thousands of dollars in cash deposits that Simmons made to Brown's personal bank

accounts. According to the indictment, more than \$200,000 in One Door funds were used to pay for events hosted by Brown or held in her honor, including a golf tournament, lavish receptions during an annual Washington conference and the use of luxury boxes for a Beyonce concert and an NFL game between the Washington Redskins and Jacksonville Jaguars.

One Door money was also used for such things are repairs to Brown's car and vacations to locations such as the Bahamas, Miami Beach and Los Angeles. "Our office is committed to ferreting out and prosecuting all forms of corruption and fraud, regardless of who the offender is," said U.S. Attorney A. Lee Bentley. "In our nation, no one is above the law."

Documents previously obtained by The Associated Press from Orlando Mayor Buddy Dyer's office show that he received an invitation bearing the seal of the House of Representatives to a July 13, 2013, golf tournament called the "Corrine Brown Invitational." It was sponsored by the One Door organization and coincided with a freight and rail industry symposium in Jacksonville.

Potential donors attending the tournament received letters from One Door with Brown's signature and official House seal asking them to give from \$125 up to \$20,000 to One Door, according to Wiley's plea agreement.

The invitation said the donations would benefit a scholarship fund for the Jacksonville chapter of the COMTO, and other charities.

Hackers stole customers' card numbers.

The Wendy's restaurant at 4046 State Road 47 is confirmed as one of the locations impacted by the recent data breach that resulted in unauthorized activity on some customers' credit cards.

The breach, which began in February, occurred over the span of the last several months, according to a Wendy's press release on Friday.

In June, the breach was found to have been more extensive than thought, according to the release. It was determined that the cardholder's name, credit or debit number, expiration date, verification value and service

message to the officers they encircled: "Thank you."

"I hope that our law enforcement understands that we are behind them, we support them and we appreciate what they do for us every day," State Rep. Elizabeth Porter, R-Lake

City, said after the ceremony. "I hope they know that we have their back."

Columbia County Fire Rescue worked in conjunction with the sheriff's office to stage the ceremony,

which consisted of lowering the flag to half-staff, a group prayer and speeches from community preachers and political leaders.

The event took place in the wake of the deadliest day for U.S. law enforcement since 9/11.

On Thursday night in Dallas, a peaceful protest over the recent shootings of black men by police officers turned violent as a sniper fired at officers, killing five and injuring seven, along with two civilians.

"What really set it off was the events that took place in Dallas," CCFR Lt. Josh Wehinger said before the

ceremony. "We wanted to get everybody together and on the same page and show support for all law enforce-

ment." Deputy Shane Foote said they wanted the event to show local officers and law enforcement agencies that the community is behind

them. "I think when situations like this happen, law enforcement officers ask themselves why they do

The flags in downtown Lake City were lowered to half-staff to honor the 12 police officers and two civilians who were shot in the attack. There was also a prayer vigil at CCSO headquarters at noon on Friday, with a moment of

silence for the victims. During the event in Olustee Park, Porter, Wehinger and Parkview Baptist Church lead pastor Mike Tatem encouraged the crowd to come together and support these public servants.

"You guys work in a thankless job, so we just want to say thank you," Tatem told the crowd after leading them in prayer.
