# Keeping families close





# Support when you need it the most

A child's medical battle is perhaps the biggest endurance test a family can ever face, both physically and emotionally. When a child is sick, it is intrinsic to their healing process that their family is close by. Our mission is simple: to improve the health and wellbeing of these children by providing free accommodation and support to their families while they are in hospital.

We support families of children up to and including the age of 21, and they are never charged for their stay, regardless of whether is it is for one night, or many months. Having a sick child is stressful and while parents are focused on the medical needs of their children, our facilities alleviate emotional, practical and financial stress for families.

With the stressors of everyday life removed, families can concentrate on what matters most – their child.

No child should have to face their medical journey alone. We know families are stronger when they are together and our facilities keep them that way.

# Together is the best place to be

"We are so grateful, I don't know what we would have done without the House, because being able to stay together was the most important thing."

After 294 nights at our Christchurch House, the Shaw family from Wellington became our longest staying house guests, defying the odds and proving that together is the best place to be – no matter what.

Felicity and Carl Shaw arrived at our Christchurch House in November 2015, shell-shocked with news that their 7-year-old son Vinny had been diagnosed with cancer. Life was already challenging for the Shaw family, as Vinny had been diagnosed with autism at an early age and the couple also had a 6-month-old son, Harley.

After complaining of pain in his head and tummy, it was not long before the family was urgently flown to see specialists at Christchurch Hospital. Vinny was diagnosed with stage four rhabdomyosarcoma, a soft tissue cancer which was in Vinny's head and had spread to his lungs and bone marrow. "We were told he had a 20 to 30 per cent survival rate – we were broken," says Carl.

This set the Shaws on the path of a 54 week treatment regime of intensive chemotherapy and radiation. Despite the complicated road ahead of them, Felicity says being able to stay together at Ronald McDonald House South Island was the key to helping her family overcome the obstacles they faced.

Carl says the 26-room House, located just moments away from Christchurch Hospital, provided support when they needed it the most. Not having the burden of mounting hotel expenses was a huge relief, especially being off work for such a long time, he says.

But it was the other families, volunteers, and staff who created a community of support for the Shaws during some very tough days.

"It's been really nice to have other families around to share their journeys and see many of them go home and get better – they're the only ones who really know what we've been through and what it's like to be away from home," says Felicity.

Carl and Felicity say being able to stay at the House let them focus 100 per cent of their energies on Vinny's treatment and caring for their family. Now back in Wellington, brave battler Vinny is responding well to treatment, and has decided he wants to be a surgeon when he grows up.


### **Rocking with the Stars**

Ronald McDonald House South Island takes seriously its responsibility to operate with accountability and transparency, ensuring that the generosity of our public donors is recognised by the efficient undertaking of our services. We can say with pride that this year we are again standing in good financial stead.

At year end, we had an operating surplus of \$946,603 which ensures we can continue to deliver on our services, regardless of economic situation or events beyond our control. This provides us a safeguard so that no family will ever be without our services, and allows us to look to the future with certainty.

The financial statements for the year ended 31 December 2016 have been prepared under the new Financial Reporting Framework for Charities issued by the External Reporting Board.

Ronald McDonald House South Island has elected to adopt the Tier 2 financial reporting standard which reflects our standing in the charitable sector.

Our fundraising team work tirelessly to establish corporate and community support.

Ongoing room sponsorships of our facilities at both the Christchurch House and the Family Room in Invercargill provides invaluable income that ensures the continued provision of our services for the hundreds of families we serve.

Community support income generated by schools and tertiary providers, community service organisations, sporting associations and individuals has increased by over 35%. To be recognised by our community in this way illustrates how the value of our services is far-reaching and heartfelt

#### **Notes to the Summary of Financial Statements**

#### For the year ended 31 December 2016

- RMH South Island Trust is a charitable trust registered under the Charities Act 2005. The full financial statements
  and accompanying notes summarise the financial results of the activities carried out by the Trust. The Trust operates
  in New Zealand for the benefit of families whose children have a serious illness. The full financial statements were
  approved and authorised for issue by the Trustees on 11 April 2017.
- 2. The full financial statements have been prepared in accordance with New Zealand Generally Accepted Accounting Practice ("NZ GAAP"). They comply with Public Benefit Entity Standards Reduced Disclosure Regime ("PBE Standards RDR") as appropriate for Tier 2 not for profit public benefit entities, for which all reduced disclosure exemptions have been adopted. This also results in the Trust not preparing a Statement of Service Performance for the reporting period.

The Trust is a public benefit entity and qualifies as a Tier 3 reporting entity on the basis that it does not have public accountability and for the two previous reporting periods it has had operating expenditure of less than \$2 million. The Trustees have however elected to 'opt-up' into Tier 2.

- 3. The summary financial statements have been extracted from the full financial statements. The summary financial statements of RMH South Island Trust including Summary of Financial Position and Statement of Comprehensive Revenue and Expenses cannot be expected to provide a complete understanding due to their summary nature. For a full understanding of the financial position of RMH South Island Trust please send a request to the Trust's office, PO Box 1463, Christchurch 8140.
- 4. The full financial statements of RMH South Island Trust have been audited by Nexia Christchurch Limited (formerly Marriotts Audit Partnership) who issued a qualified Independent Auditor's Report in respect of the financial statements dated 11 April 2017. The qualification was "as is common with organisations of a similar nature, control over revenues collected in cash (e.g. donations), prior to being recorded, is limited and there are no practical audit procedures to determine the effect of this limited control".
