# **DAV** announces student of the month, various projects

osie Hayes, a senior at Miami High School, was honored as the Disabled American Veterans' student of the month for December at the organization's monthly meeting on Dec. 2.

Hayes is vice president of her senior class, secretary of the Rotary Interact Club, president of the Miami FFA Chapter and a member of the Key Club and Student Council. In her spare time, Hayes enjoys exhibiting swine.

She's also a member of the First Baptist Church in Miami and a part-time cashier at Chapters.

During her junior and senior years, Hayes has been taking college courses at Northeastern Oklahoma A&M College to get a head start on college, which she'll begin next fall.

"I plan on attending Oklahoma State University," said Hayes. "I'm going to major in Animal Science Pre-Med. I want to be a physician's assistant in pediatrics."

Hayes has already had the chance to experience the OSU campus first-hand. She took a class over this last summer.

"I took an American History course," she said. "It was easier than some of the classes I've been taking at NEO."

Current DAV commander, Phillip Cohen, presented Hayes with her certificate and a gift card. He also explained that she'd have an

opportunity to apply for a \$500 scholarship at the end of the year.

"The DAV will present a \$500 scholarship and the American Legion will present a \$500 scholarship in May," Cohen said. "Each student will have to write an essay to be considered."

The scholarship was one piece of business the DAV discussed during their monthly meeting following the presentation. DAV member and current American Legion commander Bill Tritthart asked for volunteers to join the scholarship committee. This committee will determine what should be included in the essays the students write. They'll also read through these essays and help choose the winners.

In other business, DAV members were asked if they'd signed up for the Christmas dinner being held for them and their spouses. It was also announced that the DAV donation box at Buffalo Ranch was stolen along with any donations it contained. Many members found it upsetting that someone would steal from a veteran's organization.

They also discussed the Dream Flights program. This program provides free flights in a Boeing Stearman biplane, primarily to veterans and senior citizens living in senior housing communities. The DAV is gathering applications for the Dream Flights event that will be held next year.

DAV adjutant Art Chasteen provided an update on the Christmas baskets the group

would be delivering to veterans who reside in area nursing homes.

"We have 58 vets in nursing homes this year," Chasteen said. "That's six more than last year. We're starting to buy stuff for the baskets now. Socks, toiletries, snacks and other stuff like that. I'm also having hats made with our logo. We want to deliver these on the 22nd so we'll be putting these together sometime after the American Legion has their monthly meeting on the 13th. We need volunteers to help put the baskets together and we'll divide up the deliveries among volunteers."

Chasteen also reminded members to visit the Park of Lights at the Twin Bridges Area of Grand Lake State Park. Chasteen, Michael Robertson and Martha Dallago created a

display for the DAV. This is the first time the group has participated in the Park of Lights.

At the end of the meeting, the DAV raffled off a long gun that organization members had been selling raffle tickets for as a fundraiser. The first name drawn was Bill Tritthart, who generously donated it back and another name was drawn.

The fundraiser earned \$1,220 for the group. DAV meetings are held on the first Thursday of each month at 7 p.m.
