GREEN BUD TAXES FUND REDBUD SCHOOL GRANTS

Medical marijuana was legalized in Oklahoma on June 26, 2018, and dispensaries have been popping up all over the state ever since. In a move meant to ensure part of the taxes placed on the medicinal green bud helped schools, the Oklahoma Legislature created the Redbud School Funding Act.

Through Senate Bill 229, part of the medical marijuana tax revenue collected by the state will be distributed to qualifying schools. The bill became effective May

28, 2021, and distributions began in the Fiscal Year 2022.

During this initial year, the state has apportioned \$38.5 million to be used for the first Redbud School Funding grants. Miami and other area schools were allocated part of their funds in January 2022 with the remaining funds due in June 2022.

The Oklahoma State Department of Education (OSDE) allotted half of its \$38.5 million to 330 public schools across the state. These allotments are automatically figured based on whether a school district or eligible charter school falls below the state average in local property taxes and the county-wide millage per student.

“Senate Bill 229 takes a portion of the medical marijuana tax revenue

and makes an annual distribution to eligible public schools and charter schools,” explained Nick Highsmith, superintendent of Miami Public Schools. “Charter schools can’t be fully virtual to be eligible to get some of it.”

Miami Public Schools’ initial allotment was \$166,506.27, which was just under half of the district’s maximum allocation.

“It’s like state aid,” Highsmith said. “We get an initial allocation then they monitor revenues. As additional revenues come in, if they increase or decrease, they adjust. So, our maximum allocation pending all revenue receivables is \$346,106.35.”

Miami was among the schools with higher allotments. The exact allotments for each school can be found on the FY2022 Redbud School Grant Allocation spreadsheet found on the OSDE website at sde.ok.gov/redbud-school-grant-allocation.

Superintendent Highsmith said if you look at the baseline for the state and where the Miami school district is at, there’s a column on this spreadsheet that tells you how far off the district is compared to the state baseline.

“That’s how they calculate the Redbud allocation,” he said. “It’s to bring up those schools that fall below the state average to the state average.”

Local pharmacies distributing free N95 masks

As the highly contagious Omicron variant continues to cause COVID-19 cases to spike across the state, the Oklahoma State Health Department (OSDH) is attempting to arm Oklahomans with a recommended defense – face masks.

The Centers for Disease Control and Prevention (CDC) states that the primary way a person is infected with COVID-19 is by being exposed to respiratory droplets that carry the virus. When worn properly, a face mask can help prevent these droplets from entering your nose and mouth, potentially causing an infection. However, not all face masks are created equally.

According to the CDC’s recently updated guidance, well-fitting respirators, such as N95s, approved by the National Institute for Occupational Safety and Health (NIOSH) offer the highest level of protection against

PLANS TO RENOVATE MIAMI HOUSING TOWERS MOVING ALONG

Progress is being made on plans to renovate the Miami Towers and Nine Tribes Tower housing facilities.

“We are currently in design mode. This project is really particularly complex,” said Tammi Creason of Creason Development, which is teaming with the Miami Housing Authority on the project.

“We have applied for competitive allocation for an affordable housing tax credit. We allocated it last year and in addition to that, applying for historic tax credits.”

Miami Towers, located at 41 North Main, is part of the downtown historic district.

It’s been nominated to be listed on the National Register of Historic Places.

In its earlier life, Miami Towers was called the Hotel Miami. A 120-room building, it was completed in 1919 and repurposed as public housing in the 1970s.

The nine-story Nine Tribes Towers was constructed about the same time on the site of the old Miami High School building.

“We’re looking for investors for different layers of financing for construction loans and other things.

We had a lot of a delay, but it all feels like it’s coming back together again,” Creason said.

“We feel we are relatively through the design process for Nine Tribes, completed

drawings and have submitted them to the city to receive building permits. We have a contractor selected. We really are working toward final construction closing.”

She said everyone involved is optimistic that they might be in a 60-day window on that project.

But plans on Miami Towers are little more complicated, “so we think that is about 60 days behind in that process,” Creason said. “We’ve pretty much got plans in finishing the design, The contractor has it out for bid right now. working on the final construction numbers. We still have a little bit of permitting with the city left on that one.”

Significant issues concerning the integrity of the 107-year-old support columns in Miami Towers — primarily the west/northwest corners — impacting the building’s fire escape route led to an emergency evacuation in August 2021.

Concerns regarding the building, which is owned by the Miami Housing Authority, came to light earlier that year.

“They evacuated the building out off an abundance of caution, wanting to be extremely careful,” Creason said. “During our original design work, we had engineers and people in there, the structural issues were noted.

“Mark (Miami Housing Authority director Mark McDowell) did a wonderful job of getting everyone out of the building.”

The severe winter storm prompted Miami and all other area schools to cancel in-person instruction for the remainder of the week. However, some schools went virtual while others took official snow days.


All Miami Public Schools moved to distance learning

However, in future allocations, Highsmith expects the school district's amount to go down. "Our district evaluation is going up," he said. "We're getting more ad valorem tax dollars back as a district so our allocation should go down regardless of what happens at the state level with Redbud funding. Unless there's an increase in the state baseline." The funds received from

the Redbud grants do come with a stipulation. They can only be used as part of the school's building fund. "Unless the law is changed, the money can only go into the building fund," said Highsmith. "The building fund is a separate fund from the general fund. The building fund can only be used for building improvements, furniture, maintenance of buildings, flooring, paint . . . utilities

are sometimes taken out of a school's building fund, but not at Miami or probably any of our surrounding schools just due to the nature of the size of our building fund." He said building funds can also be used for construction if they could afford to build with the dollar amount that they have in their building fund. However, due to the size of the district's building fund, new construction isn't

usually possible. "We typically only use our building fund for maintenance and upkeep of buildings and grounds," Superintendent Highsmith said. "Our building fund total right now is \$1.8 million, which is what we budget off of. It's a nice little shot in the arm to our building fund." He said Oklahoma was one of only about four or five states that didn't already

have this type of funding for schools already in place. Miami schools weren't the only ones in Ottawa County that benefited from the Redbud School Grant Allocations. Wyandotte Public Schools received an initial allocation of \$58,024.92 with a possible total allocation of \$120,612.83. Quapaw Public Schools received \$26,956.18 with a maximum of \$56,032.16.

Commerce Public Schools' initial allocation was \$68,952.80 and its max is \$143,327.94. Afton Public Schools received \$14,223.84 and its maximum is \$29,566.23. Fairland Public Schools received an initial allocation of \$34,812.96 with a max of \$72,363.56. For more information about the Redbud School Grants visit sde.ok.gov/redbud-school-grants.
